MAY 6-7-8 ALUMNI DAY PROGRAM

At 12:30 p.m. there will be a luncheon for the Class of 1941 in the Catherine Burrow Refectory. At this time another luncheon will be held for the Class of 1916 in the Bell Room. Following these luncheons, there will be a campus tour, which will leave from Burrow Library about 2:00 p.m.

At 1:00 p.m. Southwestern will play a baseball game on the campus. There should be some exciting moments for avid fans.

A party on the Thomas W. Briggs Student Center patio will be held from 5-6 p.m., honoring special 5th year reunion classes (1896, 1901, 1906, 1911, 1916, 1921, 1926, 1931, 1936, 1941, 1946, 1951, 1956, and 1961). All alumni are cordially invited to attend.

Alumni Supper

Next on the agenda is an alumni supper to be held in Mallory Gymnasium at 6:30 p.m. Members of special reunion classes will be seated at reserved tables. The informal gathering will be welcomed by President Alexander, followed by a talk by Mr. James W. (Jasper) Wood '41, district chairman of the Alumni Challenge Campaign in Nashville, Tennessee.

From 8:30 to midnight there will be a dance at the University Club honoring the members of the class of 1941 and companion classes. Admission is \$1.50 per person.

On Sunday, May 8, a church service will be held at 11:00 a.m. in Hardie Auditorium for members of the Class of 1941 and their families, with the Reverend Mr. Jac Ruffin conducting the service. All alumni are welcome.

It is hoped that all alumni will be able to attend this year's Alumni Day weekend, chat with former classmates, visit the campus and see the new Student Center, attend the activities planned, and in general, just have a good time.

The inauguration of Dr. David Alexander '53 as Southwestern's sixteenth president will take place on May 3, 1966.

The dedication of the Thomas Winston Briggs Student Center will take place at 2:00 p.m. on Monday, May 2, after which the building will be open for tours.

FACULTY NEWS DOCTORAL DEGREES

Two professors have recently been added to the list of Southwestern professors who hold Ph.D. degrees. They are Charles G. Oakes, assistant professor of sociology and present acting chairman of the department of sociology and anthropology, and Julius W. Melton, Jr., assistant professor of Bible and religion.

Dr. Oakes received his B.A. and M.A. degrees in sociology from the University of California at Berkeley, and his Ph.D. from Emory University in Atlanta, Georgia. In addition to his position at Southwestern, Dr. Oakes is on the faculty of the University of Tennessee College of Medicine in the department of preventive medicine, where he is a research medical sociologist.

Dr. Melton holds a B.A. degree from Mississippi College, and B.D. and Th.M. degrees from Union Theological Seminary in Richmond, Virginia. He studied at the graduate school of Ecumenical Studies of the University of Geneva, Switzerland, and received his M.A. and Ph.D. degrees from Princeton University. He is an ordained minister and a member of the Central Mississippi Presbytery, Presbyterian Church, U. S.

NEWCOMERS TO FACULTY

Two new professors have joined the faculty of Southwestern for the spring semester. They are Mr. Kevin R. Cadigan, acting assistant professor of history, and Mr. Michael Eisenstadt, visiting instructor in classics.

Mr. Cadigan, born in Philadelphia, Pennsylvania, received his

B.S. degree from Northwestern University, and M.A. from Michigan State University. He has completed three years of work toward his doctoral dissertation, which he is writing for Oxford Uni-

DR. MacOUEEN RETIRES

Dr. Marion L. MacQueen, for many years chairman of the mathematics department, will retire this June. Dr. MacQueen, who holds the E. C. Ellett Chair, received his B.A. degree from Southwestern in 1919, his M.A. from the University of Wisconsin in 1923 where he was an instructor, and his Ph.D. from the University of Chicago in 1933.

Dr. MacQueen is the senior member of the faculty in point of service, having taught at Southwestern Presbyterian University in Clarksville and moved with the college to Memphis in 1925.

Dr. MacQueen is active in many organizations and is a member of various honorary societies. A Phi Beta Kappa, he is also a member of Sigma Xi, Chi Beta Phi and Gamma Alpha, national honorary scientific fraternities. He belongs to the American Mathematical Society, the Mathematical Association of America, the National Council of Teachers of Mathematics, the Tennessee Mathematics Teachers' Association and the Tennessee Academy of Science.

He served in 1959-60 as Director of an In-Service Institute for high school mathematics teachers sponsored by the National Science Foundation. He has taught in summer institutes for high school teachers of mathematics at Memphis State University and the University of Tennessee. He served as secretary of the faculty from 1945 to 1965, and as chairman of the faculty committee on Research and Creative Activity since 1949. For a number of years he has also served as college archivist.

Dr. MacQueen and his wife, the former Grace Gilfillan '27, live at 637 McConnell Street in Memphis. They have two sons, Leigh '55 and Robert '60.

After working hours, Dr. MacQueen busies himself with gardening, carpentry, and design of printed booklets and pamphlets. He has written many papers and articles for scientific journals.

After retiring at Southwestern, he plans to teach a course in mathematics for high school teachers for about eight weeks during the summer at the University of Tennessee, Knoxville. Next fall he will become a visiting professor of mathematics at Hampden-Sydney College in Hampden-Sydney, Virginia.

Additional Student Center Grant

The beautiful collegiate Gothic structure is named as a memorial to Mr. Briggs, founder and former president of Welcome Wagon International. He passed away in March, 1964.


A 34-acre tract of land, given to the college by Mr. Briggs and sold for the appraised value of \$370,000, made the Center possible.

When I was there before there were a score or so of people swimming or sunning by the pool. Now the patio is thronged . . . Little pink and green and blue houses are springing up. Before, I had questioned some Negro natives about how they felt about this sudden influx of foreigners with their money and luxury, and some were not too happy about it, telling me they still lived in slums. This time I talked with a cab driver who owned his own cab, owned his own three-bedroom brick home, he told me proudly. Housing for the natives was part of their discontent, Kemmons Wilson, ("Mr. Holiday Inns") told me they know the problem, are starting out with a model vil-lage of houses which would exceed FHA standards in this country, selling from \$4,000 to the \$10,000 range, and you couldn't buy them for that in this country. There are smart shops, and prices are still reasonable for the most part."

Lizette wrote, "Although he still wears his tribal markings of the long stretched ear lobe, and the characteristic tribal statue of a tall slender and brave warrior, he no longer wears his one-piece coverlet of red cloth, or his long hair coated with cow dung or his body painted with red ochre. Now he returns to his atheistic tribe carrying a Bible instead of a spear, bearing a brilliant smile in place of a hard crusted stare." The Betheas, with their six sons, have been in Tanzania, where Ralph is a medical missionary, for the past year. The preceding year they were on sabbatical leave in Memphis, after four years in Indonesia.


