New Style Alumni Day Scheduled For June 2

Returning alumni will be presented with a completely new type of Alumni Day on Saturday, June 2. The alumni groups which have worked out the plans hope that this day will be one of the most eventful days of its kind in the long history of Southwestern. In the drastic revision of plans even the day has been moved from Monday to Saturday. It is felt that Saturday will meet with the approval of most alumni, and a much larger crowd than the 700 alumni that were on hand for last year's Alumni Day is anticipated. Among the highlights of the day will be a luncheon given by the Southwestern Men of Memphis, honoring the Class of 1926, members of the faculty who have served twenty-five years or more, and men of the Class of 1951; election of Alumni Association officers (Memphis alumni will vote on the campus that day—out of town alumni have been mailed ballots which must be returned not later than May 29 in order to be counted); informal games and athletic events; a barbecue (a fee of \$1.00 per person will be charged for this meal); and finally, a square dance that night.

The general chairman for Alumni Day is Waddy West, Jr., '39. He and his committees have been working for weeks getting things arranged for this big day. Those helping Waddy are Frank Campbell, '39; Bob Porter, '39; Harry Hill, '41; Bill Donelson, '40; Harry Webb, '37; Dub Worthington, '40;

Trust Fund Of \$200,000 Assigned To S'western

Announcement was made in March that Southwestern is to be the beneficiary of a trust fund valued at more than \$200,000. Mrs. Charles R. Glover of Evanston, Illinois, recently assigned this fund to Southwestern, which will establish a professorship as a memorial to her late husband. It is to be named the Charles R. Glover Chair of English Studies. Before his death in 1949, Mr. Glover had established this fund, but had left to Mrs. Glover the responsibility of naming the beneficiary.

Mrs. Glover visited Southwestern for the first time in the spring of 1950 and was favorably impressed by the college. She was pleased with the Gothic buildings and with the students, a number of whom she met. Their friendliness and worthwhileness in particular appealed to her. She also met a number of the members of the administration and faculty, and came to feel that Southwestern was an appropriate institution in which to establish a memorial to her husband. A second visit to Southwestern in the fall of 1950 confirmed this impression.

She chose the field of English studies for the memorial professorship because she felt that it would be most truly representative of Mr. Glover. He was interested in the English-speaking peoples—their history, life, and literature. The works of English men of letters were well represented in his library, which contained many rare volumes collected over a period of many years.

U. S. Officials Encourage Men To Go To College

Southwestern Selected As Testing Center

As things now stand, college enrollments may not be hit as hard by the draft and rearmament programs as was feared a few months ago. Early in April President Truman authorized deferment of college students from the draft either on the basis of aptitude tests or of scholastic rank.

Southwestern has been chosen as one of the centers where tests are to be given. Professor E. L. Queener, Chairman of Southwestern's Department of Psychology, will supervise the tests, which will be given on May 26, and June 16 and 30.

One of the latest bulletins received at Southwestern concerning the draft status of college men is an address by United States Commissioner of Education Earl James McGrath. He makes very clear the strong desire of highest military and executive personnel in Washington that the first duty of young men who are college material is to enter college.

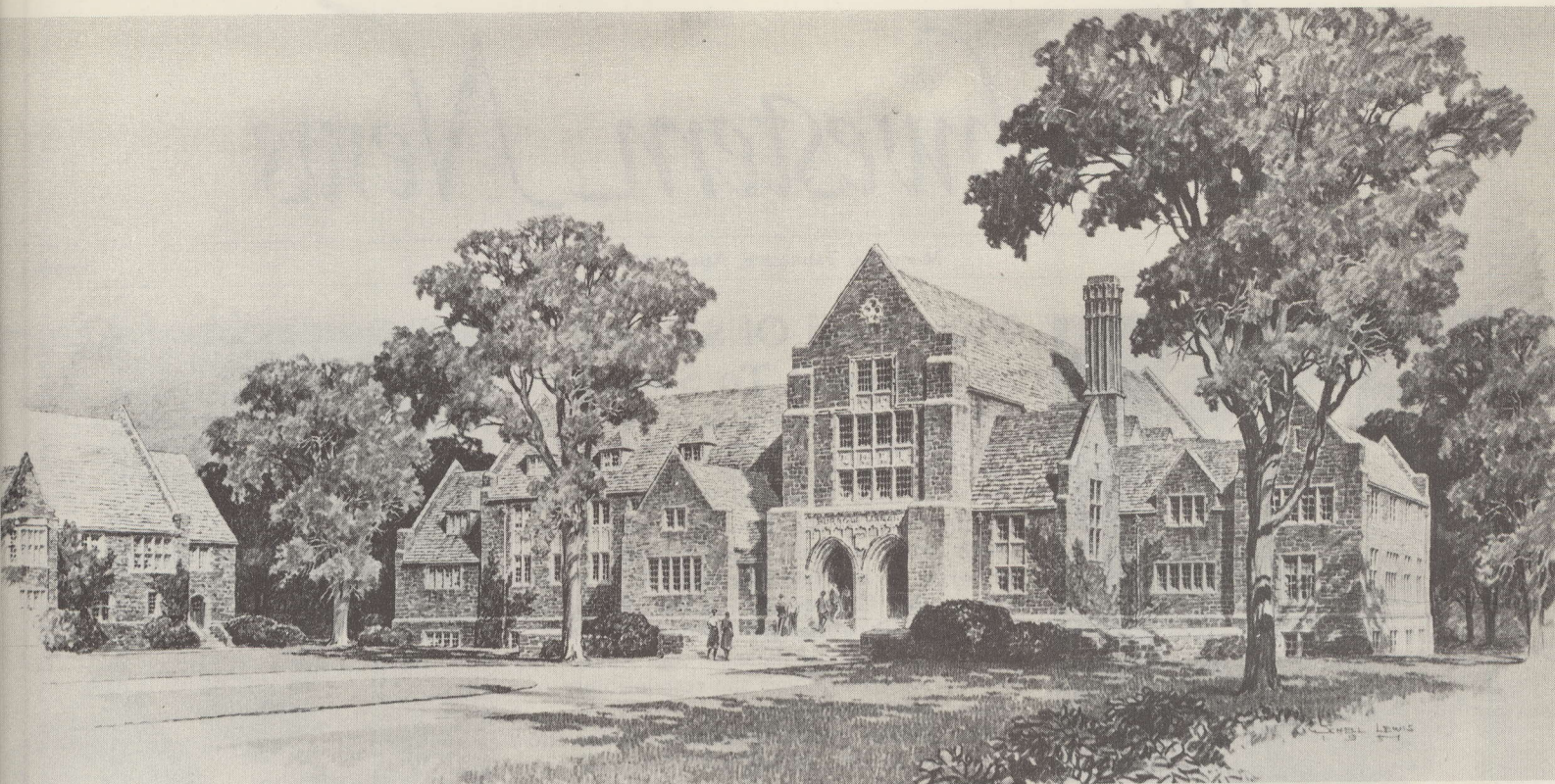
Redhead, Catledge To Speak At Commencement

The Commencement Exercises of 1951 will be memorable if the caliber of the speakers is a just criterion. The Baccalaureate sermon on June 3 at Idlewild Presbyterian Church will be delivered by the Reverend John A. Redhead, Jr., of the Class of 1926, Pastor of the First Presbyterian Church at Greensboro, North Carolina. Mr. Turner Catledge, Executive Managing Editor of the *New York Times*, will be the commencement speaker on June 5 in the Hubert F. Fisher Memorial Garden. No evidence is needed to establish their eminence in their professions.

Following his graduation from Southwestern, Dr. Redhead went to Union Theological Seminary at Richmond, Virginia, which awarded him the Bachelor of Divinity Degree in 1929. The following year he received a Master of Theology Degree from the same institution. Davidson College conferred upon him the honorary Degree of Doctor of Divinity in 1937. Before going to Greensboro, he held pastorates at Farmville, Virginia, Tampa, Florida, and Charlotte, North Carolina. In the summer of 1950 he was pastor of the National Radio Pulpit.

His career at Southwestern marked him for distinction. He was outstanding in campus activities as well as in his studies. He was business manager of the *Sou'wester* and a member of the varsity football and

Accelerated Program Will Begin On June 11

Makes Graduation Possible
In Three Years

Southwestern at Memphis announces an accelerated program of study in which many high school graduates will be interested—in particular, young men of draft age who wish to begin their college studies during the summer and get as much work as possible behind them before they enter the armed forces. The program will also appeal to students already in college who wish to accelerate their courses of study.

The program will get under way on June 11 and will run for twelve full weeks, that is, until September 1. It will be divided into two sessions of six weeks, either or both of which may be taken. An entire semester's work may be completed during the full twelve weeks. Under this program it will be possible to complete four years of college work in three years. Three regular sessions of study, plus two summers' work will yield the necessary total credits.

Southwestern is one of a small number of colleges and universities offering a full twelve-week summer school.

Courses will be offered in Bible, Biology, Chemistry, Economics and Business Administration, English, French, German, History, Mathematics, Music, Philosophy, Physics, Psychology, Spanish, and Speech. Pre-medical and pre-dental students may complete a year's work in the required laboratory science, and pre-professional courses may be begun or continued.

In view of the military situation, it is expected that an unusually large number of students will take advantage of this program and in this way insure for themselves a greater usefulness and perhaps a more desirable place in the armed forces.

Class of '26 Reunion Will Be Major Event

Plans have been completed for the biggest class reunion yet held on the Campus. The gathering of the members from the Class of 1926 is to be made a very special occasion. The reason is that 1951 marks the twenty-fifth anniversary of that Class, which was the first to graduate from Southwestern at Memphis. In President-Emeritus Diehl's words it is the "bridge" class: that is, it spans Clarksville and Memphis. After three years in Clarksville the class moved with the College to Memphis in 1925 and graduated the following spring.

Dr. Diehl, in charge of arrangements, has written to each of the seventy-four members of the Class, including those who did not complete the four years, saying that he is keenly anxious to greet every member of the Class on Saturday, June 2.

The members of the Class are to be guests of the Southwestern Men of Memphis at a luncheon on the same day, 12:45 p.m., at the Parkview Hotel. Faculty members who have served twenty-five years or more and the men of the Class of 1951 will also be guests. Dr. Diehl, Professor and Mrs. C. L. Townsend, and Professors W. R. Cooper, M. L. MacQueen, R. P. Strickler, Robert W. Hartley, M. W. Storn, and A. P. Kelso qualify as guests. The last three professors named above will be completing their twenty-fifth year as members of the faculty since they came in September, 1925. The other faculty members named bridge the removal from Clarksville to Memphis. The College and other alumni are looking forward with pleasure to this unique reunion.

Both men's and women's dormitories will be open throughout the summer. Facilities of the Physical Education Department will be available for intramural sports.

The deferments recommended for college men, he contends, are in the interest of the nation's safety: the real purpose "is to guarantee that our nation in both its military and civilian activities will be provided with an essential number of highly educated persons in professional and technical fields. Our experience in the second World War shows that the contrary policy results in the temporary crippling of many essential civilian activities and the eventual endangering of military operations." If the present unsettlement should continue for twenty years, "the failure of our nation to educate a considerable number of persons for these essential activities would be disastrous."

Mr. McGrath answers sharply the major objections to deferment. The chief objection is, of course, that it is undemocratic. This is obvious nonsense. It is foolish "to speak of temporary deferment as setting up a privileged class when subsequent calls to students may come at an even more difficult and dangerous time."

The primary purpose of the plan is to enable students to acquire a training and education which the military leaders consider useful and necessary for the defense of the whole national community.

In a letter recently sent to friends and patrons of Southwestern President Rhodes wrote:

"It is altogether likely that every high school senior accepted by a college will be able to spend the summer of 1951 and the regular session of 1951-52, at the very least, in the college of his choice. Southwestern has expanded its summer session of 1951 specifically to serve this need, and urges high school graduates of ability to investigate its possibilities for their own benefit."

basketball teams. He won prizes in Bible and Greek courses and for four years served on the Honor Council. He will celebrate the twenty-fifth anniversary of his graduation.

As is well known, Mr. Catledge has had a brilliant career. A Mississippian, he began his work in journalism with a newspaper in Tunica. In 1923 he joined the staff of the *Commercial Appeal* as reporter.

While working with the Memphis paper he made phenomenal progress and in 1927 got his first assignment of national importance. In the spring of that year, Secretary of Commerce Herbert Hoover was directing relief work in the Mississippi Valley, and Mr. Catledge was asked to accompany him as reporter.

Mr. Hoover thought so highly of the work of the young reporter that he recommended him to the editor of the *Baltimore Sun*. A short time later when Mr. Hoover was President he recommended Mr. Catledge to the editor of the *New York Times*.

Mr. Catledge was forthwith employed by the *Times* and assigned to the White House as correspondent. His ability was rewarded with successful promotions by the *Times* until he reached his present position of executive managing editor.

Franklin Kimbrough Resigns

Franklin Kimbrough, '33, President of the Southwestern Alumni Association since June 1949, was forced to resign from his office because of illness. In a letter, dated March 1, 1951, to the College and Executive Council of the Alumni Association, Franklin said: "This is to officially advise you that my doctor says I must, for the present, give up all activities except those which are essential to my business and family. Accordingly, I must resign as President of the Southwestern Alumni Association . . . Needless to say, I regret having to step out now from the alumni activities. I do regret that we cannot try and carry out the plans we had discussed for the remainder of my term. . . In closing, let me thank you for your excellent cooperation. Southwestern will always hold my interest, and have my loyalty. As soon as I recover from this illness, I hope I can be of some service in furthering the work of your Alumni Office."

We are happy to announce that Franklin is on the road to recovery and is again back at his office at Kimbrough Grain and Supply Company.

The College and the Southwestern Alumni Association are grateful for the fine work done by Franklin during the time he served as President of the Association. We greatly value his leadership ability and his interest in Southwestern, and will continue to seek his advice on matters pertaining to the alumni.

Since Franklin's resignation, the office of president is being capably handled by Dr. Robert K. Armstrong, Vice-President of Public Relations of the Southwestern Alumni Association.

Jameson Jones Addresses ODK

Southwestern's Phi Circle of Omicron Delta Kappa, national leadership fraternity, made history on March 30. The annual banquet, usually a modest affair, for the first time became ambitious, impressive, and important.

Sixty guests, including about forty-five alumni members of the Society from the Memphis area, gathered in Neely Hall for the three-fold purpose of honoring the newly initiated members of Phi Circle, hearing Dr. Jameson M. Jones, Dean of Centre College, who was the speaker of the evening, and taking steps to organize an alumni chapter of ODK in the Memphis area.

Dean Jones, a graduate of Southwestern of the Class of 1936, spoke on the subject of integrity and leadership. His talk, which was cast on a high intellectual level, was found stimulating and practical by the assembled members of ODK, who were outspoken in their appreciation.

At the suggestion of President-Emeritus Charles E. Diehl, steps were taken to organize an alumni chapter of the Society, which would have as one of its objects the granting of an annual scholarship to some young man from the Memphis area who gives promise of leadership. A committee has been appointed to form such an organization and initiate its activity.

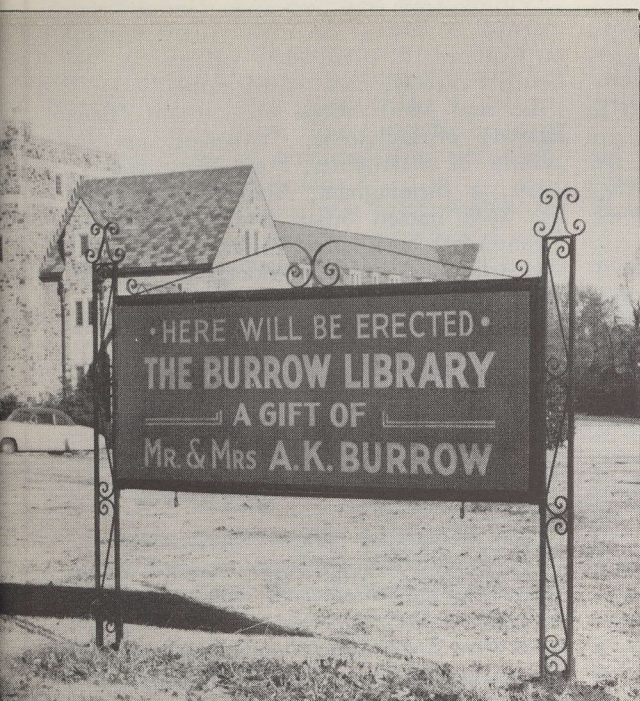
DECEASED
