Jefferson Davis of Atlanta, general solicitor for the Southern Bell Telephone and Telegraph Co., will be the headline speaker at the Alumni Day luncheon.

Under Jeff's picture in the '31 Lynx, you'll find he was an Alpha Tau Omega from Indianola, Miss., Omicron Delta Kappa; Honor Council President; Freshman Class President; Football Captain; and member of the "S" Club and "13" Club.

After graduation from Southwestern, he took his law degree at Cumberland University, Lebanon, Tenn., and has been busily stacking up honors and laurels ever since, beginning with general law practice at Indianola.

He was railway and bank attorney and assistant Attorney General for the State of Mississippi before his service in the navy during World War II and afterwards Counsel and Executive Assistant to the Governor of Mississippi. He joined the telephone company staff in 1947.

But Jeff brings more than his own accomplishments and personality to the June 2 luncheon. He promises interesting demonstrations with audience participation in the communications field and probably on-the-spot long distance conversations with alumni scattered all over the United States.

Jeff is married to the former Jerdone Kimbrough of Memphis, Southwestern alum of the class of '34, and they have three children, Jefferson, Jr., Kimbrough, and Jerdone.

L. PALMER BROWN NAMED TO COLLEGE COMMITTEE

Mr. Brown has a distinguished record of leadership in many civic and welfare organizations and has retained an active interest in Southwestern since his student days.

He serves also as a member of the board of stewards of St. John's Methodist Church and the board of trustees of the Methodist Hospital.

He is a former chairman of the Memphis-Shelby County Chapter of The American Red Cross and was national convention chairman of the Red Cross in 1955.

He is president of L. P. Brown Co.

Fine Spring Squads Round Out Successful Year of Stellar Sports

A pair of successful new track coaches, ex-Lynx stars Freeman Marr and Bill Brazleton, strong baseball and golf teams, and one of the most powerful college tennis squads in the South headline Southwestern's 1956 spring sports program.

And it would take just such an impressive lineup to give the athletic year a fitting conclusion. Following the football powerhouse and talented basketball team, fine spring squads contribute a proper completion to the most successful sports year since before World War II.

After losing the season opener to potent Mississippi College the rejuvenated Lynx runners crushed Delta State 96-35 to take their first track victory since 1947. Meets with Howard and Arkansas State, and the Southwestern sponsored Delta Invitation Relays were also on the spring agenda.

Under the tutelage of Coach Derrick Barton the Southwestern tennis team has advanced in prestige until it currently rates among the tops in Southern circles.

Tommy Buford, the number one singles player, boasts a 17-1 mark, losing only the Vanderbilt match.

The golf and baseball teams have enjoyed good, if less publicized, seasons this spring.

The golfers lost Frank Cothran, the 1955 individual TIAC champion, before the season opened, but nevertheless won over half of their matches. The Lynx were defending TIAC titles this year, but dropped the trophy to a powerful Middle Tennessee State squad.

A lack of pitching depth has slowed the effectiveness of the baseball team in early games, but the diamond crew overall has performed well. Bobby Rose is perhaps the most polished college hurler in the area, and Andy Gandy, John Lawhorn, John Rockett, and Crawford Street have given occasional aid, but the mound corps just hasn't been big enough for a tough schedule. There have been fence-busters to spare, but defensive efforts haven't matched the offense so far.

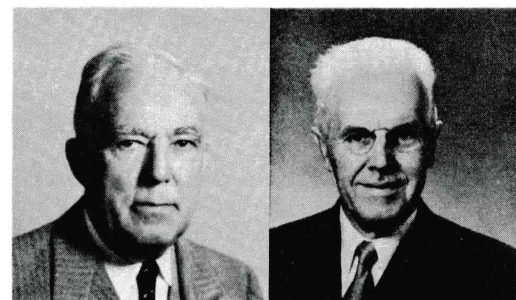
The overall bright spring picture is made almost brilliant by the fact that Southwestern loses only four of the 60-odd athletes participating in the four sports. Both tennis and golf squads are untouched by graduation and the baseball team loses only pitcher John Lawhorn.

The track squad is hardest hit with three prospective departures, and these will be major losses. Jimmy Higgason, the football Little All-American and 100 yard dash star, Jim Turner, this season's track captain, and Bob Jackson will perform for the last time as Lynx this spring.

A volume could be written on the loss of Jackson, for the blond, ex-Treadwell star is being recognized as one of Southwestern's all-time greats. A basketball regular for four years, he this season broke the all-time school scoring mark, while serving as captain. On the track Jackson has been the team's most consistent point producer since he was a freshman. In 1955 he captained the runners and set the school high jump record. This spring he had the greatest day of his career against Delta State by taking first places in the high jump, broad jump, discus, javelin, and shot put, and setting another school record in the javelin.

But records are made to be broken and performances are meant to be improved on, and from the looks of the young group of athletes at Southwestern, 1956 could be just a starting point.

Profs. Cooper and Storn Plan Travel, Writing in Retirement

Two of Southwestern's most distinguished and most popular professors, Waller Raymond Cooper and Martin W. Storn, will retire at the close of the academic year.

Professor Cooper came to Memphis with Southwestern as professor of history, having joined the faculty in Clarksville in 1920, and Dr. Storn became professor of romance languages at the beginning of the college's first year in Memphis, 1925.

Both have taught two generations of numerous Southwestern families.

Now they are looking forward to more leisure in which they can indulge their mutual love of travel and find some time for writing. Professor Cooper already is an author of note and Dr. Storn has plans in that direction.

Professor Cooper was born and bred on an Alabama plantation and traveled widely with his father during his early youth.

He received his A.B. degree at Washington and Lee University, M.A. at Harvard, L.L.B. at University of Alabama and B.A. (Juris) at Oxford University.

Early in World War I he returned to England to join the British Army, which he served in India and the Middle East throughout the conflict, returning to this country in 1920.

By this time, says Professor Cooper, his family was shaking its head and despairing of young Raymond's ever settling down anywhere.

It was then he confounded their predictions by settling down at Southwestern for the next 36 years—with time out for subsequent studies at the University of Chicago, Columbia, and University of Michigan.

More often than any other man, Professor Cooper has been accorded the highest honor that the student body can confer, the title of "Most Popular Professor," and he represents to many alumni a symbol of excellence both in the classroom and in personal relations with students.

Dr. Storn, who was born in Harrisville, Wisconsin, and grew up in Seattle, Washington, was the son of a minister who believed that children should learn Latin at an early age. So Dr. Storn's knowledge and love of languages began in the cradle.

He received his A.B. degree at Wartburg College, M.A. at University of Washington, and Ph.D. at University of Illinois.

He taught at the University of Michigan, Northwestern and Evansville College before coming to Southwestern.

He has also taught classes for a number of years at the University of Tennessee Division of Extension and will continue these and take on a few additional courses there next year.

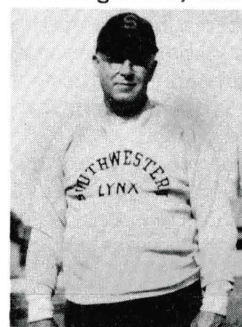
Dr. Storn has traveled widely and studied at the Universities of Strasbourg, Madrid, Paris, and Grenoble. At Strasbourg he met his wife, who knew no English at the time, so he has also done a little teaching of English along the way.

The Storns will spend their sixth summer in Mexico this year and look forward to more European trips later.

COACH JOHNSON LEAVES IN JUNE

Coach Glenn Johnson, director of athletics since 1951, announced in April his resignation, which will be effective at the close of the college year.

President Peyton N. Rhodes, in accepting the resignation, said "the Southwestern athletic program has been considerably strengthened during Coach Johnson's tenure. He is a man of integrity and we lose him with regrets."

Johnson, a native of Indiana, came to Southwestern from Bethany College in West Virginia just in time to assist in the resumption of football, which had been discontinued during World War II, unsuccessfully resumed and then abandoned again for one year.

In his first years here he coached all sports but in recent years has devoted his coaching talents to basketball and baseball in addition to direction of the whole athletic program.

DR. ELLETT'S NAME WILL BE PERPETUATED AT SOUTHWESTERN

The name of the late Dr. Edward C. Ellett, which was known around the world for his contributions to medicine, will be permanently remembered at Southwestern through establishment of the Ellett Chair of Mathematics and the dedication of Ellett Hall, the newest men's residence hall on the campus.

Dr. Ellett, a great eye specialist, teacher, and friend to mankind, left Southwestern a trust fund and insurance policies totaling some \$225,000 to be distributed after the death of his wife, the late Mrs. Nina Polk Martin Ellett, to endow the chair.

The Board of Directors, in view of Dr. Ellett's distinguished work in the field of medicine, his untiring humanitarian efforts, and his widespread influence for good by virtue of his own precept and integrity, decided also to name the residence hall in his honor.

Dr. Peyton N. Rhodes termed him one of the truly great, humble, and God serving men of our time.

Dr. Ellett attended Southwestern at Clarksville and later was graduated from the University of the South at Sewanee and received his M.D. from the University of Pennsylvania. The University of the South also shares in his estate.

Dr. Ellett received during his lifetime

every honor that his professional colleagues could bestow and, in 1935, a unique practical demonstration of their esteem. During a medical convention in Memphis a whole day of free surgery was performed by distinguished eye surgeons on indigent patients from the Mid-South in his honor, a total of 23 operations.

An associate has said that Dr. Ellett exemplified Christian ethics throughout his lifetime in his relationship with patients. He always found time to give them sympathetic understanding and encouragement and their ability to pay never influenced his willingness to serve.

First incumbent of the Ellett Chair will be Dr. Marion Leigh MacQueen, who also becomes the faculty's senior member in point of service after the retirement of Prof. W. Raymond Cooper this summer.

Dr. MacQueen, a native of Alabama, received his A.B. from Southwestern at Clarksville, his M.A. from the University of Wisconsin, and his Ph.D. at the University of Chicago.

He taught at Wisconsin for three years, joined the Southwestern faculty as professor of mathematics in 1923, and moved to Memphis with the college in 1925.

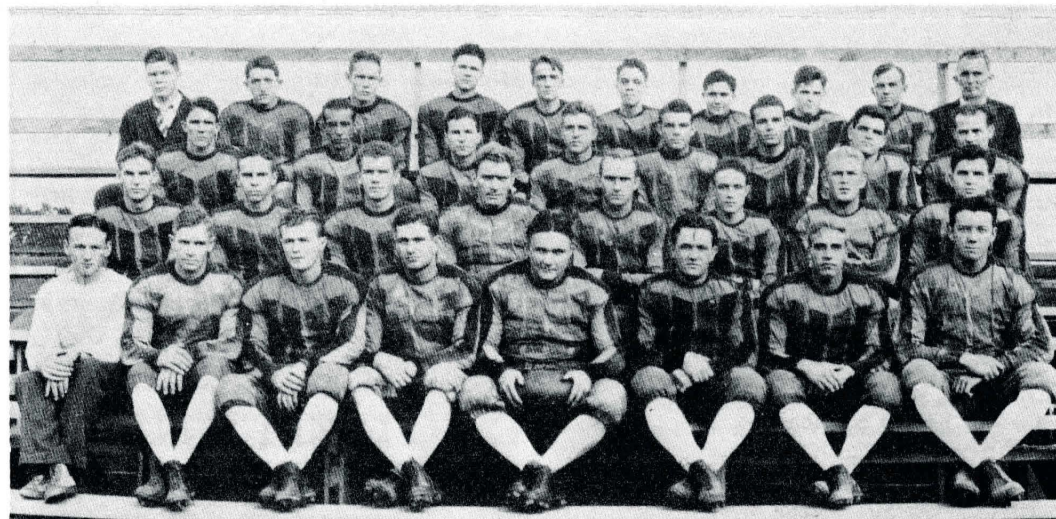

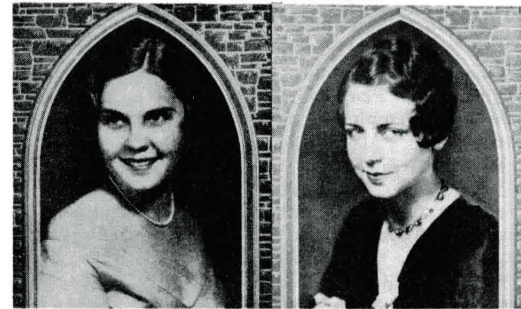
The graduating class will number about 100 candidates for the bachelor of arts, bachelor of science or bachelor of music degrees.

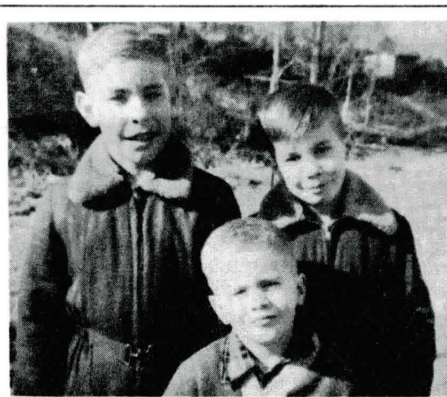

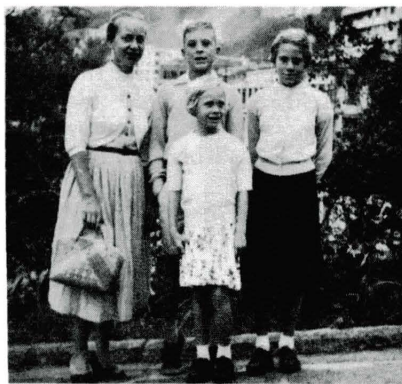

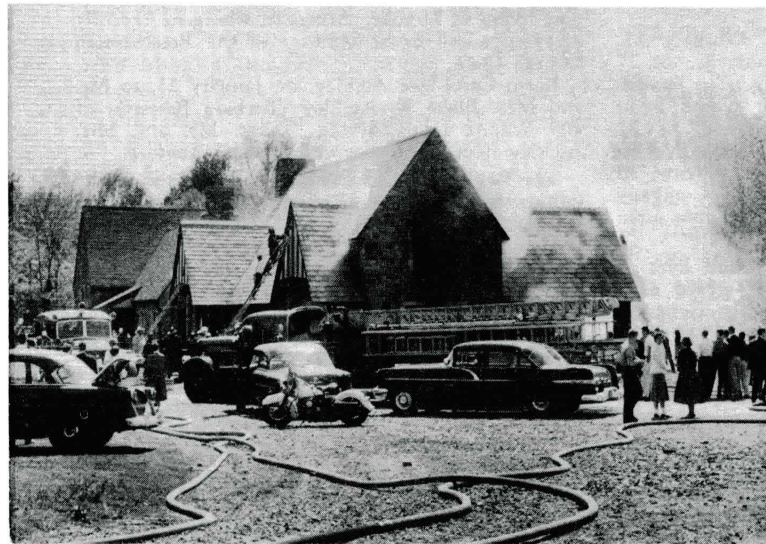
