# Plough Wants 'Homos' Out of Overton Park

Philanthropist Abe Plough has made a call to rid Overton Park of the "homos."

In an appearance before the Memphis Park Commission Wednesday February 15, Plough called sections of the large Midtown park "useless." He said, "There are homos, dope and every other [kind of] people there and I think it's a crime and a shame the underbrush is there."

Local Gay activists immediately reacted to Plough's use of the term "homos." John Stilwell, current facilitator of the Memphis Gay Coalition said, "For a person of Mr. Plough's stature to use the term 'homos' in reference to Gay people is offensive to me. The term falls in the same category as nigger, spic and kike."

Another activist indicated that Plough misses a very important point. "We pay taxes, too. There is no reason why we should be singled out for using the park too much. Certainly no one should fear the fact that Gays use the park any more than you should fear the fact that a lot of Blacks or women use the park "he said

use the park," he said.

Plough, who served on the Park
Commission from 1945 through
1958, said some people refuse to
use portions of the park because
of fear of murder or rape. Commissioner John Elkington said,
"Nobody's been murdered in the
park,"

Plough especially criticized the portion of the park which remains almost virgin forest, the only major forest still in existence within the city. That area was used this past year as a location for the filming of the locally produced movie "The Old Forest."

In responding to the question of safety in the park, Charles F. Newman, attorney for Citizens to Preserve Overton Park, said a possible solution would be to require permits or guides before visitors could enter the forest, a method



used in some national parks. "It would give the [park] rangers some leverage and give access to people interested in seeing that kind of forest," he said.

The controversy about Gay men

using Overton Park for a meeting place has come up a number of times over the years. Previous attemps to crack down have resulted in police harassment of Gays.

# Mondale Crawdaddin'?

A coalition of national Gay groups has both praised and criticized Democratic presidential front runner Walter Mondale for answers given to a survey about his position on Gay rights issues.

The National Gay Task Force (NGTF) recently released Mondales's answers to 27 questions on Gay-related issues and women's issues.

NGTF commended Mondale for promising to issue and executive or der banning discrimination against Gays and Lesbians in the federal government and for pledging support for a "legislative remedy" to the discrimination problem. However, the Task Force is less than pleased with Mondale's responses regarding the areas of military service, security clearances, immigration and health care.

In response to a question about the current Gay rights bill in Congress, Mondale said he supports the concept but not necessarily the currently proposed approach to amending the Civil Rights Act of 1964 to include protections for Gays as well as women, Blacks and other religious and ethnic minorities. Sen. John Glenn was criticized in recent months for making essentially the same response. He, however, took his statements a step further to indicate that he would not "advocate a homosexual lifestyle."

Mondale said, "I favor a legislative remedy to the injustice of discrimination on the basis of sexual orientation. While I have not settled on any one approach, I support an avenue which recognizes that discrimination against Gay men and Lesbians is a denial of fundamental civil rights. In matters of equal rights, there can be no double standard; either our nation is committed, as I am, to equal opportunity for all Americans, or it is not committed at all."

Gaze receives papers from all across the country and one fact consistently jumps out at you. Editorials form all these papers say the same thing: with few exceptions, most organizations and hence their papers are managed by a small core group of Gay men with little or no Lesbian support.

The queston of getting Lesbian support and participation seems as elusive as motivating people in general. But I perceive one problem as paramount in preventing us from becoming a more unified community.

Lesbians have gone to great pains to identify themselves as completely separate and apart from men and Gay men. When referring to the community, it has to be identified as the Gay and Lesbian community, alternating the order of Lesbian and Gay to ensure equal billing

But in their efforts to identify themselves as a separate and distinct group, Lesbian have slipped into reverse discrimination, chauvinism and sexism. All men, Gay and straight, are identified as the

The notion that you can't be a







### Glenn Making Hay on **Anti-Gay Stance**

Philadelphia Gay News- Campaigning in the South, Sen. John Glenn is making political hay from his anti-gay rights stance. Although the Democratic presidential hopeful himself has not boasted about his homophobic position. Sen. Sam Nunn (D-Ga) last week told a Glenn rally that the candidate "has the courage to give up his New York state coordinator rather than give up his strongly held moral belief that homosexuals should not be role models for the children of this nation." Num was referring to the resignation of New York state Sen. Manfred Ohrenstein because Glenn refused to support the federal gay rights bill. According to Glenn's communication director, the Nunn statement represents an attempt to make the best of what had been a bad situation-attacks on the candidate by gays. "We've suffered on the downside of that position," Greg Schneiders said. "We might as well get the positive benefits as well." Glenn himself never brought up the issue of gay rights. When asked about it during his Southern swing, he replied that while he did not discriminate against gays in hiring for his own office, he did not believe that a federal law should prevent school districts or other government agencies from not hiring homosexuals. Political observers see this latest Glenn tactic as a means of wooing conservative Democrats who voted

for President Reagan in 1980 and do not feel comfortable with Walter Mondale, who they feel is too

### Glenn Fears Gays

According to an article in US Magazine, the decision to begin guarding Democratic presidential candidates on January 14, more than two weeks earlier than originally planned, was triggered by a report that John Glenn felt that he might be threatened by irate Gays. Glenn told activists while campaigning in New York that he opposes extending the civil rights law to Gays. In early January Glenn sought Secret Service protection citing the potential therat from the homosexual community. The Secret Service investigated and found that "there was no basis for his claims." Treasury Secretary Donald Regan then conclued that Glenn did not need early coverage: but others in highly placed areas elected to err on the side of caution and protection for Glenn and other contenders soon began (Jesse Jackson got Secret Service body guards shortly after announcing his canditacy Nov. 3)

The Glenn campaign had no comment on the affair.

### **Koch Denies Being Gay**

New York-New York Mayor Edward Koch has charged the state's governor, Mario Cuomo, with spreading rumors that Koch was a homosexual. In his recently

published book, Mayor, Koch said, "There can be no doubt of Cuomo's complicity" in spreading the rumor in 1977 when Koch defeated him in New York's mayrol race. "I also hold Cuomo responsible for the same thing happening in 1982," Koch said, when Cuomo defeated the mayor in the Democratic gubernatorial nomination.

### Blacks, Gays Open Dialogue

CHICAGO (NY NATIVE)-Sereral Black Gay activists have begun "a private dialogue" with officers at Operation PUSH, the black community organization founded by Rev. Jesse Jackson and headquartered in Chicago. The purpose of the dialoge, according to Gay Life, is to educate PUSH about Gay issues and to combat religiousmotivated homophobia. Homosexuality reportedly has been an especially controversial issue within the civil rights organization since Keith Barrow, son of PUSH vice president Rev. Willie C. Barrow, died of AIDS-related infections last October.

The consultation between Blacks Gays and PUSH were initiated by Max Smith, co-founder of United Faith Affinitas Church, a Lesbian and Gay church with a third-world congregation. Smith says he and other activists want to inform PUSH about "what the Bible really says about homosexuality...that loving homosexual relationships are in no way condemned by the Bible."

Black Gay activists see the dialogue with PUSH as an important step in conbatting anti-Gay stereotypes in the Black community because PUSH is a national organization with adual religious/civil rights nature. Some activists believe that although Jackson and other promintent Black clergy and legistators have endorsed Gay civil rights legislation, their support for the issue has been tempered by religious beliefs that "Gay lifestyles" are morally unacceptable. Black Gays say that in order to strengthen the nascent alliance between the Gay movement and the Black civil rights movement, this religiousbased homophobia must be overcome.

Aversion to homosexuality within the Black religious community has become more acute with the advent of the AIDS epidemic, according to Smith. "We want to establish an ongoing dialogue with Black ministers," he said, "because we have heard reports that Black people who have died of AIDS have been condemned to hell at their own funerals" by ministers who believe that the disease is "God's judgment against the homosexual lifestyle."

### Studds Announces Re-election Campaign

Representative Gerry E. Studds (D-MA), who announced on the floor of the House of Representative last year that he is Gay, is planning to seek re-election to his seventh term in Congress.

Gay rights leaders immediately hailed Studd's decision to run for another term and said plans are being made to support his campaign through fundraising efforts throughout the country. His districts includes much of southeastern Massachusetts, including the Cape Cod area.

Studds gained notoriety last year when, in responce to charges that he engaged in sexual relations with a 17 year old House page, he announced in the floor of the House of Representatives that he is Gay. What made the pronouncement most noteworthy was the fact that Studds chose not to hide his sexual identity behind a smokescreen of alcohol, drugs or and "error in judgement."

Surprisingly the reaction by Gays seemed to be duplicated by Studds' constituents. His office received thousands of letters of support, with only a few dozen attacking hom for his sexual orientation. Chances for his re-election appear good.

### **Monkey Virus Linked** to AIDS

The Associated Press reported late last month that scientists at the New England Primate Research Center in South Boro, Massachusetts believe they have discovered a new virus in Rhesus monkeys that causes symptoms in the monkeys remarkable similar to symptoms which appear in human AIDS patients. Researchers say it is doubtful, but possible, the virus also causes AIDS in humans. The virus is believed to be one of a small family of type-D retroviruses related to human T-cell leukemia viruses which some believe cause AIDS in humans. A full report on the new virus is expected to be published in the February 10 issue of Science magazine.

# Lesbian Comic, Not Publicity

LOS ANGELES, CA — Lesbian comic Robin Tyler, through her attorney Gloria Allred, has charged that quadriplegic Elizabeth Bouvia "slapped the hand that reached out to help her."

Bouvia, who says she wants to starve herself to death because she is tired of living in a "useless body," refused an offer by Tyler of housing. Then Bouvia charged Tyler with publicity-grabbing.

"We still hope that Ms. Bouvia is able to achieve her goals and we still feel she has the right to die with dignity," Allred said. "However, she does not have the right to slander people to to label legitimate offers illegitimate and to malign the integrity of a woman such as Ms. Tyler who was only trying to help her."

The incident began after Christmas when Allred contacted the hospital and said she had a client who wished to provide a humanitarian service and allow the cerebral palsey victim to stay in a home where no food, water or medical care would be forced on her. Tyler was not identified as the interested person. After two days of negotiating the conditions, Bouvia rebuffed the offer.

### Washington Grants AIDS Funding

The Reagan Administration budget submitted to Congresson Feb.

1 calls for a \$6.5 million increase over current spending for AIDS related activities in fiscal year 1985 reports the National Gay Task Force.

NGTF Director Virginia M. Apuzzo called the \$53.9 million request "a reflection of howseriously the Public Health Service takes the AIDS crisis."

Despite the higher level of funding, Apuzzo expressed concern that "there is still much more that the government can and should be doing".

She stressed that increases in funding for AIDS activities "should not come at the expense of other vital health programs."

While the Centers for Disease Control will once again revive \$12 million for their AIDS work, Apuzzo said, "the Administration is requesting a cut of \$4 million in work on infectious diseases at CDC and the elimination of funding for the tuberculosis control categorical grants, "which are funded at \$5 million in 1984.

NGTF reiterated its call for the creation of an independent panel of outside experts who can assess the government's research efforts on AIDS and recommend a master plan for future funding.

"Until all the agencies working on AIDS sit down with the top scientists from around the country and review all the research underway and made systematic decisions about how to tackle this problem," Apuzzo said, "it will be hard to assure the American

people that all that can be done is indeed being done to fight AIDS."

### Hustler Sends Insulting Letter to Studds

Huster magazine, which blends shrill sexual and religious lampoons with heterosexual pornography, published an open letter to U.S. Rep. Gerry Studds (D-Mass.) in its Febuary 1984 issue. It seems Hustler publisher Larry Flynt gave complimentary subscriptions to all members of Congress and Studds - who came out as Gay last year in the wake of the investigation of sexual relations between congressmen and pages— complained to postal authorities and insisted his name be removed from Hustler's mailing list.

Hustler's open letter reads in part, "Gee, Gerry, we're sorry. We can only imagine how it must have repulsed you to open that first copy of Hustler magazine and lifelike color photographs of adult female genitalis. If we'd been a bit more considerate, we might have remembered that you'd rather spend your time ramming your aging cock up the assholes of young boys whose parents have entrusted them to your safekeeping....we forgot why the citizens of Massachusetts sent you to D.C.—they must have figured Washington was the best place for an admitted faggot pagemolester such as yourself...No sense having you back home in the Bay State sucking off their kids." Hustler publisher Larry Flynt recently made headlines when he appeared in court dressed in a diaper made from a U.S. flag. A spokesman for Studd's office said they intended to ignore the matter entirely.

### Straight Houstonians Upset With Mayor

Homophobic Houstonians attacked Mayor Kathy Whitmire for thanking the city's Gay community for supporting her mayoral campaign. At a recent City Council metting they accused Whitmire of "setting a bad example" by touring the Houston Gay bars to show her appreciation. "God is after you" one man screamed at the mayor. Another said the mayor was "slipping and slithering over semen soaked floors to become a bar maid." The mayor and the city council members who accompanied her showed no reaction to the remarks. Afterward, she was asked if she would make another bar tour. "I probably will," she responded

# Madison Ave. Pitching Ads to Gays

Have your ever wondered about some of those hunky bodies in the ads for the likes of Calvin Klein, Soloflex, Chaz cologne and others? Just who are they trying to reach? Well, it seems they are reaching out

The Los Angeles Times reported recently that many national advertisers avoid using Gay publications because they fear alienating straight buyers if a product is thought of as being Gay: Gay publishers suspect Madison Ave. has developed new strategy to reach homosexuals without having to advertise in the Gay press. These are ads designed for mainstream publication that feature partially clad, greek-god-like men pushing everything from underwear and cologne to shaving cream and razors. The appeals, of course, reach everyone, but Gay men see a special appeal.

"Scores of American buinesses are wooing homosexuals — and their money. This has become an increasingly important goal. Gays say they detect subtle hooks—a hairstyle, a style of dress, a cryptic sales pitch — in ads for Calvin Klein fashions, Soloflex exercise equipment, Paco Rabbne Cologne and other products. Advertisers say

Gays are exaggerating the perceived trend, 'beefcake,' they say, has simply become an accepted sales method, regardless of the sexual proclivities of the audience."

The Times states the Gay male household is appealing to advertisers because it is more affluent than other groupings. Gay males have larger incomes, have the obvious financial advantage, in most cases, of having no children. Lesbians are less affluent and they are ignored by major marketers.

"Like many ethnic groups which encourage self-suffiency through buying," writer Scott Harris emphasized,"from other members of the same ethnic group, Gay merchants have started to preach a 'Buy Gay' ethic. More and more Gays are shopping in Gay-owned shops, dining in Gay-owned restaurants, vacationing at Gay-owned resorts, placing ads in Gay oriented newspapers, and even saving at Gay owned financial institutions such as Unity Savings and Loan in West Hollywood and Atlas Savings and Loan in San Francisco." Unity Savings opened its doors more than two years ago with assets of under \$3 million. Today assets stand at about \$110,000,000.

## M. Robert Schwab. **Houston Activist Dies**

Houston-A co-founder of the Gay Rights National Lobby and

prominent Gay rights activist and civil rights lawyer, M. Robert Schwab, died December 15, a victim of AIDS. He was 36.

Schwab was active in the successful fight to overturn a Texas law that made homosexual activities illegal. He was also a co-founder of several other Gay organizations, including the Houston Gay Political Caucus, the National Education Foundation for Individual Rights, and the American Bar Association Committee of Gay Rights.

### **NOW Conference Promoted Lesbian** Rights

National Organization for Women President Judy Goldsmith, National Gay Task Force Executive Director Virginia Apuzzo, and Minnesota State Representative Karen Clark were among the featured speakers at the 1984 NOW Lesbian Rights Conference held the weekend of January 20-22 at the Red Carpet Inn in Milwaukee, Wisconsin. The theme of the conference was "Lesbian Rights: Power and Politics in 1984."

"This conference provided an opportunity for pro-Lesbian and Gay activists to plan together for this crucial election year. Feminists and Lesbian and Gay activists must work together to assure that the United States finally protects the rights of all its citizens, regardless of sex or sexual orientation," Goldsmith said.

Clark, the highest ranking openly Lesbian elected official in the United States, has been a member of the Minnesota State Legislature since 1980. She spoke at the opening plenary session Saturday morning on the role of the Gay community in political campaigns. Stay with Me a film about Clark's election, was shown.

Apuzzo addressed the dinner plenary session Saturday evening on the impact of Reagan administration policies on the Gay community.

NOW Vice President for Action Mary Jean Collins, National Association of Business Councils President Sarah Craig, National Coalition of Black Gays Co-Chair Chris Cothran, Gay Rights National Lobby Midwest Director Kathy Patrick, Gay Democratic Clubs Executive Director Tom Chorlton, and representatives of state and Gay and Lesbian rights groups also participated.

### Insemination Open to Lesbians

Philadelphia—Lesbians who want children can be inseminated at the Elizabeth Blackwell Health Center, Philadelphia's Gay News reports. In its 1st year of operation, the center has fertilized about a dozen women, at least one of whom is a Lesbian, said coordinator Miriam Diamond. Center directors voted last year to allow Lesbians to be inseminated. "Lesbians have just as much right to be mothers as straight wo-







men," said Diamond, "We're very anxious for a Lesbian to feel comfortable here. This is a service difficult to get elsewhere." The sperm, which comes from a New York company, is injected in the woman's vagina three spearate times over a two-day period. The whole process costs \$200.

### **AIDS Fund Donates**

The Memphis Gay Coalition's AIDS Fund has donated \$100 to the National Gay Health Education Foundation, Inc. to help publish the first edition of its Sourcebook of Lesbian/Gay Health Care.

A conference to be held in New York City in June is being held in conjunction with the Third National Forum on AIDS. Over 1500 health care professionals from all over the United States and many foreign countries are expected to attend these events.

The sourcebook will include summaries of all workshops and panel discussion presented at the Conference, comprehensive essays on important facets of Lesbian/Gay health care, as well as panelist's biographical data. A directory will provide comprehensive state-bystate listing of Lesbian/Gay health care services, including a special section on AIDS resources.

The AIDS fund was established over a year ago as the result of a benefit performance produced by VincentAstor. The fund is designed to provide information services to the Gay community as well as to assist in funding AIDS related forums and workshops. A series of brochures was developed by AID Atlanta and distributed locally as part of the project. In addition, publicity for a recent AIDS forum for local physicians and the general public was paid for out of the fund.

### **GRNL Still Searching**

Washington, DC- Gay Rights National Lobby Executive Comhas voted to extend mittee the deadline in their search for a new executive director to replace Steve Endean.

The executive committee also voted to increase the salary range from \$25,000-\$30,000 to \$30,000-\$35,000 in order to attract more

candidates. We do this with regret, but it became necessary to extend the search process for a new executive director. It is essential that the entire Board choose GRNL's new executive director and to this point the Search Committee has decided that although several good resumes were received, not enough resumes were submitted for an adequate selection process to occur," stated Board co-chair Kate McQueen.

Yet they connot point to a single case where a Lesbian or Gay man has been blackmailed into giving up secret government documents." The result of not getting a security clearance is usually losing one's job.

### Editorial on Homophobia Censored at Wisconsin H.S.

Madison, WI- An editorial written for a student newspaper entitled "Homophobia: A Social Disease" has been censored by the principal of a public high school here. According to Out!, Madison's Gay newspaper, the student, Jerry Dryer, has vowed to "pursue [the matter] until it's printed.

The principal, Milton McPike, old Out! that he censored the edi torial because it was disruptive. He said that "some of our kids don't understand these kinds of things."

The student editorial board approved the piece for publication but was overruled by a faculty supervisor. McPike agreed with the faculty member, calling the editorial "not well written" and accusatory.

Dryer said there are no services

for Gay and Lesbian students at the high school and, that although he doesn't know of any openly Gay students, he believes "targets of abuse" at the high school could eas-

ily include Gay students. Dryer has been tranferred to another school but has promised to take the censorship issue to the school board and, if necessary, to court.

# Advocate Terminates Bush

Prominent Gay journalist Larry Bush, who has been Washington editor for the popular national Gay news magazine The Advocate has been notified by Advocate editor Robert McQueen that his relationship with the paper has been "discontinued."

Bush, who said he received notification of his termination January 30 in a letter from McQueen to his agent, said his contract with The Advocate had run out on December 1, but that he had been in negotiation with The Advocate on a new contract since August.

According to Bush, who declined to read the entire letter, McQueen's letter to his agent said "I find I have no choice but to discontinue the Advocate's relationship with your client."

"They didn't offer me any explanation of why they chose not to negotiate with me and I don't want to publicly speculate on their motives," said Bush in an interview with The Washington Blade. Bush said he did not call McQueen for an explanation "because it was clear (during contract negotiations) that there was a fundamental gap about

issues" of how The Advocate would cover election year political news. Bush denied there had been any disagreement over salary matters, but added that the only disagreement in negotiations when The Advocate backed out was over "expenses."

McQueen said through a spokesman that he would have "no comment" on his letter to Bush.

Bush and The Advocate gained considerable notoriety within the national Gay movement last year following articles by Bush in The Advocate which harshly criticized the leadership of Gay Rights National Lobby executive director Steve Endean, who eventually resigned. Many supporters of Endean charged that Bush's criticism of Endean was encouraged by Advocate owner David Goostein.

Bush, who said he had "anticipated" the possibility that his yearto-year contract with The Advocate might not be renewed, said he has already begun plans to syndicate his "Capitol Report" news column to other Gay newspapers around the country.



# Navy Seeks to Oust Gay Man with AIDS

Officials with the U.S. Navy are attempting to "punish" a Navy enlisted man who has AIDS by discharging him from the service on grounds of homosexuality rather than on grounds of a medical retirement disability, the senlisted man's attorney has charged.

Harvey Friedman, an attorney representing Navy Petty Officer John E. Baskin, 27, said unidentified officials with the Naval District of Washington, D.C. are acting with the "mentality of the lynch mob" by attempting to override a Naval discharge review board which found insufficient evidence to discharge Baskin on grounds of homosexuality.

Baskin was diagnosed as having AIDS after being admitted to the Jacksonville Naval Hospital in Jacksonville, Fla. last July. Friedman said Baskin's Navy records indicate a physician treating Baskin requested a sexual history and noted on Baskin's medical records that the enlisted man "revealed regular homosexual activity over several years."

The disclosure of the sexual history led to an immediate inquiry by the Naval Investigative Service (NIS), according to Baskin's records. An administrative discharge board met last month to determine whether Baskin should be discharged for homosexuality.

Friedman argued before the three member board that the physician who took the medical history was not present at the hearing, the evidence presented against Baskin was based on hearsay, and Baskin, in any case, has a life-threatening disease and is requesting a discharge on medical grounds.

By a vote of 3 to 0 the board ruled that the government has not

presented adequate evidence to prove beyond a reasonable doubt Petty Officer Baskin has engaged in homosexual activity."

By a second vote of 3 to 0 the board recommended that Baskin be referred to a medical evaluation board

Friedman said he thought Bas kin's discharge through a medical route had been secured until Baskin was notified in writing on February 1 that he was once again being considered for administrative separation. This time the separation would be through a procedure called "in the best interest of the service," a catchall method of discharging members of the military that is specified in a little known military personnel manual.

The reason cited in the notification was Baskin's "statements" to medical personnel in Jacksonville that he had engaged in homosexual activity.

A Navy spokeswoman said actions by discharge boards are only the first of a three-step process. The spokeswoman, Lt. Commander Deborah Burnette, said findings of administrative review boards are considered under Navy rules as recommendations that must be reviewed by the Naval Military Personnel Command. The Command, in turn, makes its own recommendation and forwards both recommendations to the Secretary of the Navy, she said.

Burnette noted that in Baskin's case, the Command's recommendation was apparently in disagreement with the review board, a situation that occurs infrequently. She said Baskin's case is now awaiting action by the Secretary of the Navy

Friedman said he is considering

filing a temporary restraining order to block the administrative discharge. According to Friedman, the administrative discharge would be honorable but would confine Baskin to Veterans Administration hospitals. VA hospitals, he said, are not equipped to treat AIDS patients as effectively as facilities such as the Bethesda Naval Hospital, to which Baskin could only be admitted if he receives a medical retirement disability discharge.

# Gay Youth May remain in Scouts

Dallas Gay News - In a move heralded as a victory for Gay rights activists, the California Supreme Court denied a petition by the Boy Scouts of America contesting a Gay youth right to belong to that organization.

The ruling in Curran vs. Mt. Diablo Council of the Boy Scouts of America sends the case back to Los Angeles Superior Court where the Boy Scouts will have to show cause why a Gay young man cannot remain a member of that group.

"This is a giant step forward in the ongoing effort to end descrimination by organizations which appeal to the public for membership," said George Slaff in commenting on the high court's decision. Slaff, an ACLU Foundation volunteer attorney, is lead counsel in the case.

Timothy Curran a Gay scout who claims that his expulsion from the Scouts violated California's Unruh Civil Rights Act and his common law right to fair procedure, had held numerous leadership positions in his Scout troop and helped form a troop for deaf boys in the Oakland area.

When Curran turned 18 he was no longer eligible to be a Boy Scout, so he applied for Scouter status; young adult members who assist the Scoutmaster of a troop. He was expelled because he revealed that he was homosexual during a newspaper profile. He then filed suit in Los Angeles Superior Court only to have the case dismissed, ruling that Curran had no constitutional right to belong to the Scouts.

Last fall, however, the Calfornia Court of Appeal, in a unanimous decision ruled his expulsion "capricious and offensive to public policy." The Boy Scouts filed a petition with the California Supreme Court, which ruled in favor of Curran.

"This affirmance by the Supreme Court, that the Boy Scouts are subject to the Unruh Act, underscores California's leadership position in rooting out bias and prejudice wherever possible in our society," Slaff noted.

Joseph---he was Jacob's favorite son. Of all the family, Joseph was the special one. So Jacob bought his son a coat, A multi-colored coat to wear. Joseph's coat was elegant, the cut was fine; The tasteful style was the ultimate in good design. Such a dazzling Coat of Many Colors! How he loved his Coat of Many Colors!

Thus begins the stirring tale of Joseph and his Coat of Many Colors, one of the most remarkable stories in the Book of Genesis. So also beings the captivating Broadway musical, Joseph and the Amazing Technicolor Dreamcoat, which was performed last month in Nashville to seemingly unanimous acclaim. The opening night performance of Joseph was part of a magical evening of theatre and fellowship for much of Music City's Gay community.



There are many parallels between AIDS and the process of aging. AIDS is "acquired immune deficiency syndrome." Aging may be the same process. This has led to some conjecture that the plague of the Gay community may just be a speeded-up phenomenon of aging.

As you know, one of the theories about AIDS is that numerous infections to which Gay men, hemophiliacs, and drug abusers expose themselves may be overloading, or "using up" the immune system at an accelerated rate, leaving it depleted. If the immune system is like a punchboard with only so many possible responses, and you use all your chances early in life, you die young; some people may have larger punchboards than others and age more slowly because they have more immune responses to spend. Or so goes this theory.

If fact, why people should age at all is not really understood? answers such as "we wear out" are not good enough.

In a book on genetic approaches to aging, one author speculates that some strategic organ orchestrates the entire phenomenon of senescence. He thinks that organ is the thymus. In his words, aging is "progressive weakening of immunologic surveillance" which allows somatic mutations (or body changes).

The mass of the thymus gland begins to decline shortly after sexual maturity, and by age 50 has only 15% of its original maximum size. The thymus seems essential to making educated T-lymphocytes from the cells of the bone marrow which pass through it on the way to the peripheral lymph nodes.

As we age, the immune system has less and less ability to respond to antigens or foreign substances such as viruses, bacteria, etc. T-cells, in particular, seem to lack this ability; as you know, T-cells are consistently low in AIDS persons.

Researchers have found that with age, T-lymphocytes lose their ability to multiply. (B-lymphocytes do not). T-lymphocytes especially (as opposed to B-lymphocytes) get their education from the thymus, more and more recognized as "where T-lymphocytes go to col-

lege." That's especially interesting in view of reports from pathologists which frequently observe that the thymuses from AIDS persons were wiped out. Did planned senescence occur earlier?

The immune system may have a built-in lifespan controlled by something genetically unique to the individual. Inbred strains of mice have been known to have genetic control of their lifespans found in the same portions of the genome, or chromosome map, that controls immune function.

Despite the common impression that the triumphs of modern medicine have lengthened human lifespan, neither vital statistics nor biological evidence supports the belief. In fact, the disease oriented approach to medicine so common in our country may have had little actual effect on increasing lifespan. The fundamental causes of death are not diseases, but physiologic decriments (weakenings) that make their occurence more likely.

If the two leading causes of death in Western countries (heart disease and stroke) are eliminated, only about 18 years of additional life can be added. Eliminating cancer adds only two more years. Human lifespans have remained virtually unchanged since recorded history; only life expectancy has increased. Medical achievements have simply allowed more people to reach the limit of what seems to be a fixed lifespan which appears to be somewhere in the ninth decade.

One theory of aging relates lifespan to the number of cell divisions possible. These seem peculiar to each species. For example, Galapagos tortoises have a mean lifespan of 175 years, and their fibroblasts are capsulr og so

are capable of about 100 doublings. Human fibroblasts can double only 50 times, and therefore we live about half as long. Chickens can live at the most 30 years, and their fibriblasts can only double 20 times, as might be expected. (New England Journal of Medicine, 12/2/76).

Another striking change that regularly occurs in the aging immune system is an increase in the incidence of auto-antibodies, a kind of attack on self. There is a six- to eight-fold increase in the appearance of anti-human antibodies in 80-year-olds compared to

40-year-olds. There is also a comparative rise in the prevalence of high titers of circulating immune complex.

These factors may cause slowly progressing low-grade tissue damage and some of the degenerative physical changes of aging. Some researchers suggest that this sort of auto-immune tissue damage is of major importance in the aging process.

Interestingly enough, autoimmune phenomena have been seen in AIDS persons, expressed as idiopathic thrombocytopenic purpura, where platelets ( the cells largely responsible for clotting) are eliminated. High titers of circulating immune complexes or antiplatelet antibodies could be responsible

Older people are more susceptible to infectous disease than younger ones. For example, the reactivity to the TB skin test declines in people over 70. Also, amounts of antibodies to AB blood group antigens are lower in the older. Along with impaired reactivity to old antigens, there is impairment of the ability to develop new hypersensitivity skin responses. Individuals are usually sensi-

tized to the chemical dinitocholobenzene on first contact. 95% of subjects younger than 70 show reactivity on subsequent exposure. Only about 70% of people older than 70 react after reimmunication.

I, personally, failed the Heptavax vaccine; after the first two doses, there was no antibody formation, not uncommon response for those over 40. A higher dose of antigen is required in older animals to bring about the response found in younger ones.

In cancer control, natural "Killer" cells sound great, and they are especially important in destroying tumor cells. Older people have lower number of these, and higher incidence of cancers. AIDS persons, too, have lower numbers of natural "killer" cells, and this may be why they often show a rare form of cancer, Kaposi's Sarcoma.

No final conclusions can be drawn. However, it is interesting titers of auto-antibodies, low T-cell helper and suppressor lymphocyte activity and severe impairment of cutaneous hypersensitivity are associated with increased mortality and aging — and they also correlate with AIDS.

Out of this crowd, 10 people will presently be infected. Consider not only gonorrhea but also syphillis, non-specific urethritis, scabies, hepatitis and intestinal parasites. Although there are recognizable signs and symptoms, keep in mind that you may tripping the light fantastic with a silent carrier. Not every infectious person has a sore, a rash or a discharge that may signal a problem. Depending on sexual practices, there are parts of the body that harbor the infections unknowingly.

In a era when everyone is con-

cerned with physical fitness, nutrition and healthy maintenance, sexually transmitted diseases are a serious threat to your well being if you are a sexually active person. By learning early that there is a problem, your responsible actions in seeking treatment will prevent you from developing serious consequences of these diseases.

For early detection, consult a physician or clinic who is know-ledgeable in screening and management of sexually transmitted diseases. Routine check-ups can prevent you from having unpleasant memories of an otherwise fantastic experience. No one wants to be one of the 10 in a crowd.

# Gay Vote '84 — It's Not Over

Not one vote has yet been cast in the elections of 1984, yet the experts are telling us the results are already self-evident. Pollsters, pundits, and political "experts" tell us that President Reagan and former Vice President Mondale are running away with their respective nominations, and that Reagan leads his Democratic challengers by a wide margin. Some polls show broad general support of the President, while others identify key electoral blocs (Blacks, women, and environmentalists) who oppose him strongly. Recent interviews with Gay leaders suggest that the Gay vote is far from crystalized at this point, and that it has the potential for affecting this year's political process in a number of ways.

The more unified and effective we are this year, the greater will be the impact of the elections on the priorities of the Gay/Lesbian Rights Movement. In particular, our poltical work can affect the Democratic presidential and vice-presidential nominees, the Gay and human rights platforms of both parties, and the election or reelection of supporters of the Gay Rights Amendment in Congress.

Perhaps the issue of greatest immediate impact is the possibility that the Republicans might lose control of the Senate next January. Democrats need a net gain of six seats (five, if they win the Vice Presidency) to gain leadership, and while few Democratic incumbents are considered vulnerable, many Republicans are. Among the unstable Republican seats are two in Texas and Tennessee where incumbents are resigning and Dem-

ocratic challengers with better Gay rights records are considered possible winners.

In other races, antiGay, "new right" incumbents face progressive Democrats in West Virginia, Iowa, Maine, and North Carolina (where a coalition of groups has united to combat untraconservative Senator Jesse Helms). Women campaigning with the endorsement of NOW and other civil rights groups, are considered strong Democratic Senate contenders in Minnesota, Colorado, New Mexico, and Oregon. Each can be expected to be more supportive of Gay Rights issues than the men they would replace in office.

If control of the Senate would return to the Democrats, many key committee chairs would switch from civil rights opponents to friends of the Gay, feminist, and Black communities. Most notably, control of the Judiciary Committee (which has jurisdiction over the Gay Rights Amendment) would pass from Strom Thurmond to Ted Kennedy, Likewise, the leadership of committees dealing with AIDS and health funding, legal aid, and other issues of importance to our communities would be in the hands of politicos who could be expected to show more response to our demands.

In 1980, the Gay "Convention Project" was organized to create the strongest possible Gay presence at the Democratic Convention. Over 75 openly Gay delegates were elected, and Gays played key roles in the rules, credentials, and platform committees. The result was a strong committment by the Democrats to Gay rights legislation, and the formation of a

formal Gay caucus of the party. This year, we have the opportunity to begin to build such a relationship with the national Republicans and to reaffirm our growing influence among the Democrats.

Such as process depends on the activities of Gay people in the caucuses and primaries which are just beginning. We have to support good candidates organizationally, at the polls, and then, hopefully, at the conventions. We have to contribute to the efforts of our Gay delegates with money and muscle. It's now time to turn to your localor state political organizations for specific suggestions about how you can participate. At the very least, determine what candidates support Gay issues and others that are important to you, and offer to work in some way for them.


Despite the general belief that President Reagan won a "landslide" victory in 1980, his margin was relatively thin. Had Carter won a couple of hundred thousand votes in a few states, he would have been reelected. A good part of the difference was the result of eligible voters who were not registered, and registered voters who did not go to the polls on Election Day. In city elections last year in Chicago, Philadelphia, Boston, and elsewhere, minority candidates

demonstrated they could win office through a combination of effective registration campaigns and coalitions with other minority groups. In many areas, the strategy resulted in the election of openly Gay candidates; in many others, to victories for supporters for Gay rights.


In 1984, national Gay leaders are convinced that strong voter registration is critical to the success of our candidates and cause. A coalition fo six national Gay rights groups has been formed to encourage and coordinate local registration campaigns. The groups include The Gay Rights National Lobby, National Association of Lesbian and Gay Democratic Clubs, and the National Gay Task Force. 

**∀** Celebrity Bottoms Out

NBC's recent mini-series, Celebrity has reached into the past to present us with a characterization of a homosexual that I had hoped society had outgrown. The only bigger disappointment is the attitude of Joseph Bottoms, who plays the Gay character, Mack Crawford.

According to US magazine, the homosexual issue is pivotal to the plot but Bottoms told US, "I don't think of Mack as 'The Gay.' To me, that's not the key to Mack Crawford." He went on to say, "I know that in doing this role I'm going to face a lot of questions that come right to the point, so I've given it some thought."

For those of you who missed it, Celebrity deals with the "three princes," the most popular, the most promising three old friends who, on graduation night, rape a young girl (Acutally T.J. did the raping while Mack and Kleber watched from another room.) The girl apparently died from the experience: the three dispose of the

body and vow silence forever.

Each goes on to fulfill his

Mack, the star athlete, is injured in a football accident and after his release from the hospital is hidden away by his religious fanatic mother who believes athletics is sinful. He is finally discovered and rescued by his old pal, Kleber.

A physical therapist, played by Tess Harper, gets Mack on his feet again. They marry, he starts doing commercials, they have sexual problems (infrequency), a son is born; they divorce and Mack goes on to fame and fortune making movies.

The relationship between Mack and his ex-wife is strained, at best, and at first she refuses to let Mack even see his son, Jeffie. Eventually she relents and during a visit Jeffie catches daddy in the act and refuses to ever see him again.

Mack's character as a homosexual is vague and never really developed. There always appears to be some male companions in evidence, but we never see Mack showing any kind of affection toward any of his male partners.

It is his sense of loss over his son and the emptiness of his life that drives him to return to Texas to the fateful reunion of the three princes that will result in Mack's death.

In his interview with US, Bottoms said, "I don't hate Gays, but I think they're awfully unfulfilled human beings. I really think that homosexuality is a dead end street. It's self-adulation. It's masturbation. Where does it go?

"...to me, it's sad. I know many homosexuals. I feel sorry for them because they're unnatural."

And unfortunately, that's exactly how Bottoms played Mack... unhappy, ashamed and unfulfilled. Bottoms said, "Maybe it would have been better if I hadn't played this role because of my feelings." Ain't that the truth.

The conclusion (as far as Mack is concerned) comes about when he discovers that his son has joined the cult of The Chosen (T.J. got religion in prison and became a Bible-thumping, money-collecting faith healer calling himself The Chosen.)

While growing up, Jeffie, now Brother Paul, had various problems with the law. It is implied as as a result of discovering his father with another man and during the confrontation, T.J. takes credit for saving him. T.J. then shoots Mack because he is evil, perverse, "queer," and demon-possessed. At the trial, T.J. will testify that God Himself pulled the trigger and it was not Mack who died but the demon which possessed him.

So once again, the sad, lonely, unfulfilled queer finds violent death as the end to his meaning-


less life. The only thing that keeps me from completely condemning Celebrity is that it also shows how a completely amoral, evil, con man can appear to be a man of God, convincing even himself, in his fanatacism, that everything he does (including murder) is the will of God and, therefore, right.


Again, Joseph Bottoms in US: "I have a relative who is a homosexual and has been for many year. I'm happy that he has found one lover who has been with him 35 years.

"But for the most part, it seems to me that homosexuality is probably the way I felt when I was single and was just sort of roaming through people's lives. You know you hurt people by being with them and limiting your relationship to just sex and leaving."

On one hand, speaking against homosexuality, Bottoms says the fulfillment of sex should be with the opposite sex, because that's life. "That's what this is all about." Then, he says he and his wife don't plan to have children but are considering adopting. Bottoms wants them walking and talking and wiping themselves. Then we can have fun."

Whereas Cher's portrayal of Lesbian Dolly Pelliker brought us one
step forward, Joseph Bottoms portrayal of Mack Crawford in Celebrity drops us two steps back. The
battle for a positive Gay image in
the media goes on. Joseph Bottoms
should go back to playing pretty
straight men, stick to subjects he
knows about (love, marriage, adoption) and avoid the subjects he
knows nothing about (homosexuality and homosexual relationships)
and just maybe he won't lose all
of his Gay audience.



# The Other Half

I have a friend who is Black whose lover, spouse, significant other, is white. In fact, I know quite a few biracial couples. What constantly amazes me is the amount of flack they receive form other friends and acquaintances. There is a constant pressure on them, as though they, by virtue of their relationship, have somewhere somehow, betrayed someone or something.

The white partner is accused or suspected of some form of strange, "abnormal" behavior; it is just not acceptible to be in love with a member of another race. But the pressures on the Black partner are just as strong, perhaps even worse. Their Black friends accuse them of being "traitors," of somehow "selling out" to Uncle Tom-

I find it hard to believe that any of us, knowing as we must some form of prejudice, rejection and public judgement, can lay that same kind of guilt and fear on our brothers and sisters.

The racial tension seems to get worse still when we move from talking about two people in a relationship to one person of mixed parentage. Not so long ago, I counselled with a young man who was the child of a Black and white parents. He was extremely confused and angry. He found no acceptance from either whites or Blacks. He was a man without a place, and therefore ended up hating himself. He hated his white background, he hated his Black background, he hated society in general.

There was little I could say to dissuade him. After all, in excluding him from their groups,""society had left him little room in which to look for any kind of love.

In truth, we are all "half-breeds." There is just no "pure" anyone around these days. A woman in Louisiana was recently much surprised to find her race listed as "Black" on her birth certificate, because one great-great-grandparent had been Black, making 1/32 mixed parentage, We are made up of all kinds of national backgrounds, and colors and races and creeds, Most of us could not name our 32 great-great-grandparents, much less tell with any surety what their heritage was.

Most Gay people have heterosexual tendencies, and non-Gays find secret longings for their own sex. So what? Whocares? Why is it so important to base our identities on sexual preference, race, nationality, religion, or whatever? We have put so much energy into stressing our differences that we begin to lose sight of our common concerns, the things we share as human beings, residents of Earth, children of God.

why can't the reality -- that our relationships and we ourselves are combinations of many factors, many races, many traditions - be a source of joy and a reason to share? who wants to put a lot of energy into criticizing anyone sheerly because his or her partner is of another race? Who cares (or even can say with absolute certainty) that you are 100% white or Black or any other color? Why do so many people expend so much effort in fighting to establish their credentials as members of this sub-group or that?

I guess I will never understand this choice of conflict over concert, this identity of division rather than diversity. Ultimately, it does not mean a thing, for both you and I along with all the "isms" we care to defend and support will eventually join the great parade of those who have gone before us and now have no color, who have become dust and ashes. Why not enjoy this God-given life and its diversity, instead of breaking it down into smaller and smaller pieces?

I think that many of us believe a lie. The lie is that our true identity

is found in the color of our skin, our sexual preference, our gender, or in some other minor criterion. Believing the truth means believing that our real selves are not defined by such petty things, but by larger, ternal truths about ultimate purpose, meaning, destiny, and our relationship to God and the world.

What we are made of is not nearly so important as what we are

# USOC Wins - 'Gay Games' It Is!

A federal judge has ruled that the U.S. Olympic Comnittee has exclusive claim to the word "olympic" for the third time. On February 2, U.S. District Judge John P. Vukasin issued a permanent injunction against Gay Games from using "olympic" in their athletic promotions.

Mary Dunlap, attorney for the Gay Games, said that she would appeal the ruling. She argued that "somehow, the plain applicability of First Amendment protections of free speech and association to our essentially noncommerical political and symbolic use of an ancient word, and the obvious discrimination against us, are motivated by homophobia and perhaps megalomania on the part of the USOC."

Judge Vukasin disagreed.



In August of 1982, three weeks before the opening of the 1st Gay Olympics, the USOC won its first victory when Judge Samuel Conti issued a temporary restraining order in anticipation of a permanent restraining order.

The ruling came as a complete surprise to organizers. Dr. Tom Waddell, president of the non-profit

group, said at the time he had "no idea it was coming." He complained that knowing some of the people on the USOC he understood why they would wait until the last possible moment "when it could hurt the most."

Vaughn Taylor, a San Francisco attorney who obtained the first injunction, maintained there was no homophobia involved in the suit. He said in 1982 it was merely a legal action to protect the trademark status of words the federal government had granted to his clients.



In 1978, the U.S. Congress passes the Amateur Sports Act which granted the USOC sole authorization to use the words "Olympic" and "Olympiad." Since then, the only other uses of the words specifically authorized by Congress are the Special Olympics which were organized for physically and mentally impaired people.

Waddell feels the Gays' use of the word was challenged when others' use was not. He complained that there were numerous examples of other sporting and entertainment events which use the term Olympics. These were conducted without the USOC's interference.

According to San Francisco's Bay Area Reporter, official displeasure with the term Gay Olympics first surfaced in a letter in late December 1981 from F. Don Miller, executive director of the USOC. In the letter, Miller asked Waddell to stop using the word Olympic and warned him that his commit-

tee was entitled "to recover any and all funds which were solicited and acquired by virtue of the usage of Olympic terminology." Miller insisted on a response within ten days.

Waddell wrote back that he was only aware of the olympic as a "generic" term referring to an event which pre-dated Christ," but requested the permission be granted the Armchair Olympics, Special Olympics and Police Olympics as examples of precedents.

Miller answered in January 1982 with the original request to cease and desist, adding that the committee's position had nothing to do with the issue of homosexuality. Waddell later wrote Miller that the First Amendment guarantees of free speech and association are of higher priority than trespassing on privileged words.



"We also have been advised by legal counsel that there appears to be a violation of the guarantee of equal protection under the law," wrote Waddell. "There is a discriminatory action on the part of the USOC which has sanctioned the Junion Olympics and Special Olympics, but has looked the other way on the Armenian Olympics, Xerox Olympics, Crab Cooking Olympics, Diaper Olympics, Rat Olympics, and Dog Olympics, while at the same time takes exception to the term Gay Olympic Games."



Waddell also wrote that his group was willing to take the issue to court if its couldn't be settled amicably between the two groups. He requested an answer from Miller by February 1. No other word was heard until Monday, August 9, 1982. With that court action, the battle was on, and has been ever since.

At this point, the USOC has won every round.



# WSJ Says Gay Political Force to be '84's Main One

In USA folk myth it is said that being mentioned in Time Magazine is making it in America. That's only the beginning. Making it in the Wall Street Journal means not only that one is not only here—but here to stay. Once again Gays have found major space in the latter.

The article was part of the WSJ's "Politics \*84" coverage and was entitled in typical WSJ low-key language, "Gays See Election as Chance for Gains, May Be Main Political Force This Year."

The dateline was Washington, DC, and the story was written by WSJ staff reporter Ellen Hume. Her theme is that Gays may be the most important new force in American politics this year."

Hume details the furor that resulted when candidate Senator John Glenn disavowed Gay rights. She notes that both Mondale and Cranston have solicited Gay support (and out of the closet support, at that).

Hume reports that national Gay activists this year are trying to get the nation's 20 million Gays to vote as a bloc. The Democratic Party has thus far been the most receptive. Last year their National Committee elevated Gays to the

same "special status as Blacks, Women, Hispanics and Asian- Americans."

Human Rights Campaign Fund, the Gay PAC that in money raised was the 55th largest out of 3,371 PAC's nationwide.

The political success of Gays in local politics from San Francisco to Houston is another sign of the growing Gay clout. The article reports there are some 100 openly Gay elected officials around the country, 110 Gay Democratic Clubs. Hume says that even some Republicans are seeking Gay support.

"The Gay agenda is much broader and more controversial than a decade ago," writes Hume, "when homosexuals said they wanted to be left alone. The platform is now Gays seek legitimacy as a full-fledged minority group with an innate sexual orientation."

The Gay agenda nationally is a three part one: a bill extending Title 7 of the Civil Rights act to include Gays; more federal health money to combat AIDS, and elimination of bans against Gays in immigration and the US military.

Others carry the agenda even further, some seeking to win pension and spousal rights for Gay couples. Others that homosexuality be a part of sex education in the schools

There are those who say not all the news is good news, though. The Gay agenda could be a bombshell say some political whiz kids.

"The fact that Gays are behaving like an ethinic group doesn't mean that the rest of the public will accept them as one. The public doesn't want to discriminate against homosexuals, but it doesn't want to deal with them on a personal basis either," say William Schneider of the American Enterprise Institute.

Some conservative groups already are capitalizing on the backlash against Gay rights gains. "I believe Gay rights will become the Democrat's Achilles' heel," says Gary Jarmin, chairman of the Christian Voice Moral Government Fund, a PAC dedicated to opposing politicians who support Gay rights.

Still Gays are much more visibly active in American politics than ever before. "What we have here is a classic example of how the American system works," says Ann Lewis, political director of the Democratic Party. "They're working to achieve goals through the political process. They are supportin victorious candidates and, in response, they are receiving support for their goals."

Hume makes one observation that has startled Gay progressives.

Gays aren't necessarily Democratic or liberal, as the stereotype might suggest. As many don't have children, they can be very conservative on such economic issues as aid to education."

Hume concludes with Gays and their relations with Ronald Reagan and organized labor. She writes, "In the past, even President Reagan has shown some sympathy for Gay rights. Gays note that in 1978 Mr. Reagan spoke out strongly against an initiative would have barred homosexuals from teaching in schools. 'We're even in the upper echelons of the Reagan administration,' says Vic Basile, president of the Gay National Human Rights Campaign lobbying group. 'What we don't have is openly Gay people in those areas.'

"Perhaps the most marked symbol of the nation's changed attitude about Gays is the AFL-CIO, which for years has been a hotbed of anti-Gay sentiment. At its national convention in Miami last October, the labor federation approved by voice vote a resolution backing the national Gay civil rights bill."

Florence Lacey has received critical acclaim for her role as Eva Peron both on Broadway and with two national companies of Evita for the past two and a







Baskin, meanwhile, has been transferred to the Washington area and has been admitted to the Bethesda Hospital.

"They are bent on punishment out of some sort of misguided judgment and not really trying to ensure his departure from the service," Friedman said.

Friedman said he was particularly disturbed by what appeared to be a violation of confidentiality on the part of Baskin's physician in Jacksonville. However, Admiral (ret.) Melvin Museles, executive director of the Association of Military Surgeons of the United States, said the physician-patient confidentiality code does not apply in the military when a physician learns that a military regulation has been violated.

In the case of alleged homosexuality, Museles said, a physician is required to report such allegations to a commanding officer, since homosexual conduct is forbidden under military rules.

He also said, "I have yet to reach a decision concerning the extension of [a] ban [to] uniformed personnel....[or] to the security agencies," such as the Central Intelligence Agency, National Security Agency or FBI.

Mondale stopped short of saying he would remove restrictions on granting security clearances for Gays. "Traditionally, the security field has sought to minimize the vulnerability of its members to blackmail," he stated. "On occasion, it's attempts to do so come into conflict with the civil rights of Lesbians and Gay men who apply for positions in this field. He promised to establish a commission to investigate the merits of the current policy and to work toward minimizing any civil rights conflicts with it.

Mondale indicated he would work through "appropriate legislation" to eliminate "invidious" immigration law provision that are used to exclude Gays from entering the U.S., but he would not go so far as promising to direct the Justice Dept. not to contest court challenges to such provisions.

NGTF Executive Director Vir-

NGTF Executive Director Virginia Apuzzo said in a news release that Mondale's statements appear to be a "backtracking from earlier commitments to deal with military exclusion at the executive level." She also faulted his reference to blackmail and his comments about security clearances. "This response indicates a serious insensitivity to Gay men and Lesbians who have loyally served and continue to serve their country. The blackmail charge is a red herring that most thinking people have long since dismissed," Apuzzo said.

NGTF was also dismayed that, in light of the AIDS crisis, Mondale said he had no specific proposals



in mind to ensure that the nation's health care system is more responsive in the future to health emergencies. Mondale did say, however, that the AIDS situation "was a national health tragedy, and nothing like it should ever be permitted to occur again."

Among the other groups involved in preparing the questionaire for the candidates are the National Association of Gay and Lesbian Democratic Clubs, the National Coalition of Black Gays, the Human Rights Campaign Fund, and the Gay Rights National Lobby. The coalition is still awaiting replies from President Reagan, Sen. John Glenn, Jesse Jackson, and Reuben Askew.


