The state Highway Department has begun to survey possible new east-west expressway routes which would

go around Overton Park.

Leon T. Cantrell, project engineer, said today from Nashville that one new possibility lies north and another south of Overton.

The department also is studying the feasibility of moving the proposed East Parkway interchange with the expressway entirely out of Overton Park, instead of part in the picnic ground as planned.
