AIDS Blood Test Due In Early '85

WASHINGTON, DC -- A fast and reliable blood test for the presence of AIDS antibodies will probably be licensed in January or February, according to the federal Health and Human Services Department."Things vices Department."Things are moving very swiftly and we are not anticipating any delays," said Dr. Lowell Harmison, science advisor for H&HS. Harmison added that they would need "at least 20 million AIDS tests per year, including 6 million for blood banks" which he indicated was a top pri-

Development of the tests began last June when five drug companies were given the task of developing the test. Progress has been swift and several are expected. ted to gain FDA licences

A positive reaction indicates that a person has been exposed to the AIDS virus and may have developed antibodies to it. It does not indicate that the person will suffer a life-threatening infection. ing infection.

Gay Will Defended in PA

ERIE, PA -- The executor of a college professor's will who left his estate "to furthering the civil rights of American homosexuals" has decided to go to court to defend the contested will

The will of John DeWitt McBride who died on May 20, 1983, named Dr. Raymond Lemieux as trustee of

mond Lemieux as trustee of an estate valued at approximately \$160,000. The will stated that the money was to be used to further Gay civil rights. Last month Dr. Lemieux was given the choice by the court to either defend the will or lose his position as courtappointed trustee.

In April 1984, McBride's nieces contested the will stating that they, as blood relatives, should inherit the money. Attorney James E. Marsh has been retained to defend the will by the Lambda Legal Defense and Education Fund (LLDEF) and the National Gay Task Force's Fund for Human the National Force's Fund Human for

Dignity.

The will is unusual in that no specific organization was named to benefit. In August 1984, Marsh appeared on behalf of National Gay Rights Advocates and The Advocate, which was

named in the will as a source for the executor to consult in the disposition

of the estate.

Also in August Gay and Lesbian Advocates and Defenders (GLAD) requested standing with the Court as a party to the case and McBride's three nieces be-

McBride's three nieces began procedures to contest the will since none were named beneficiaries.

Finally on August 29 Judge James B. Dwyer ruled that "Lemieux must defend the will. Otherwise there is no contest." contest."

According to Lance Ringel of NGTF, "It's important of NGTF, "It's important for us that the money gets into the Gay community somehow. Our intervention provided a holding action that lasted long enough for Lemieux to become involved.

If the will is upheld, then
the Gay community can decide how to approach the
money. We've never had the
luxury of worrying about

that much money before."

reports that the probate
file reveals that Stephen Tetuan, attorney for the estate and author of the will, wrote to Lemieux encouraging him to serve as trustee." Tetuan reportedly Lemieux assured

Should You Take The Test?

On the surface, it sounds like a "good thing" ... but

On the surface, it sounds like a "good thing"... but is it? A growing sense of concern among health professionals in the Gay community point to potential social and legal repercussions of a positive AIDS test. Blood banks will almost certainly subject all blood donated to the test in order to guarantee the safety of the U.S. blood supply, but serious concerns in the Gay male community may overshadow the public safety reasoning.

What will an antibody-positive AIDS test reveal?

The test will reveal exposure to the AIDS virus. It will not be able to determine whether or not a person will develop the disease. Clinically the test is uninterpretable and will tell your doctor nothing. Many people test positively for tuberculosis and hepatitis without ever having had the disease and without ever developing the symptoms or being able to infect others.

What confidentiality protections are there?

According to New York's Gay Men's Health Crisis, current confidentiality safeguards are totally inadequate. It is not paranoid to assume that a postive test will be mistakenly equated with the disease itself. Such information might be made available to insurance companies and others who routinely require the release of your medical records. The worst case scenario would include a compilation of all Gay and bisexual men whose blood is "tainted". The effect of such a list on employability and insurability could, no doubt, be devastating.

What should I do?

The test should be used only for diagnostic purposes

What should I do?

The test should be used only for diagnostic purposes and for the purposes of research. If you do take the test, be sure that you are guaranteed confidentiality in writing. If your doctor feels that you have symptoms which warrant further investigation, take the test. If you participate in a bona fide research project, take the test but insure your confidentiality. Be sure that you understand what a positive test does and does not mean. If you are at risk for AIDS, do not donate blood other than for research purposes. What should I do?

Lemieux's legal fees would be absorbed by the estate and that arrangements could be made that would be "very accomodating to [Lemieux's] work schedule.

On September 11, Lemieux responded to Judge Dwyer accepting the position as "trustee". Apparently the will originally identified him as "beneficiary" with the proviso that he administer the distribution of the estate to the Gay community. "I did not consider my-self a beneficiary," he said.

Judge Dwyer retained briefs submitted by GLAD and The Advocate but denied their petition to intervene in the case.

gether; on sharing dreams are letting fear and cowarfor the future... it's just dice separate us from that
a very emotional time. It's
also a time when many peopless and especially Gay the ple, and especially Gay people, go into deep "blue funks" because some of those elements seem to missing from their lives.

If you choose to remain in the closet for whatever reason, that decision ultimately affects only you. If you choose to remain in the closet and you have a "lifemate", that decision and your actions can hurt the one you care the most about and, as strange as it may seem, few people seem to give that a lot of thought.

In Gay relationships we are trying to establish the same sort of relationship a husband and wife have with-

out many of the hang-ups and role playing that they have attached to them.

But think about that,

When a man marries, he leaves home and establishes a new family unit. His wife leaves home and becomes part of that family unit with him, as do any with him, as do any children they may have. The point is, that they behave as a family. At Christmas, the wife doesn't take off and go home to her parents nor does the husband take off a week and go home to his parents. They both go to one parent or the other, together, as a unit. Usually, they trade off or spend equal amounts of time with each group of parents.

We Gays have reached a point where we are defining

point where we are defining better. relationships Yet. at a time when we should be sharing our time with the one person that means the most to us, we

I would personally suggest that when you receive that invitation or when you start making those travel plans, make it clear that you want to include your "friend", "roommate" or whatever you choose to call them. Few parents would come out and just say "no." If they do, just say you'll be unable to make it home this year. At the very least, that will indicate to both your parents and your lifemate just how important that person is to important that person is to

Here are a few points to consider. I know some of you will deny them vehemently but trust me they are true!

1. In spite of everything, most people have already figured out that you are Gay, especially if you and your lifemate have been together for any length of together for any length of

2. Of those who have figured it out, 99.99% don't care. The rest aren't worth worrying about.

your parents really a. If your parents really care about you and are truly concerned about your well-being, all they want is your happiness. They want you to find someone to love who loves you in return. If they want more, if they insist on forcing their old world prejudices. prejudices, misconceptions and role models on you, then it is time to break with them anyhow.

4. Finally, you can do all this without coming out and

saying, "Mom, Dad, I'm Gay." Just letting them know by your actions that this other person (your lifemate) is someone special to you, you tell them everything without telling them anything. That also puts the ball in their court. If they want to just accept the situation, that's fine. If they want to talk it out, that option is left open to them but they have the responsibility to say to you, "I bility to say to you, "I want to know more about this." If they choose to be rude or unkind to your lifemate or you, it may be time to break with them.

We have often said in

these pages that the decision of "coming out" has to be made by each person in their own time but that no-body has the right to "make you crazy" and that includes your family by birth.

Ultimately, our goal is to attain acceptance and respect for ourselves and the relationships we form. We make the same commitments, emotionally and financially, that heterosexu-als make when they embark on marriage. But until we give our lifemates the same love and respect and consideration that heterosexuals give their spouses, how can we expect non-Gays to re-spect our relationships? In this case, the ball is in our court. We have to like ourselves. We have to like the one we love. We have to respect the commitment we have made to our lifemate. We have to start acting like our lifemate is what we claim our lifemate is...the most important our lives. single, in person

BWMT Speaker Rouses Milwaukee

MILWAUKEE, WI--(OUT!)
Black and white Gays must
work together in politics,
according to Irwin Rothenberg, a co-founder of the
Memphis, TN chapter of
Black and White Men Together

Rothenberg spoke at the Great Lakes Regional Network meeting of BWMT, held in Milwaukee October

held in Milwaukee October 19-21. About 100 BWMT members from across the country attended the meeting, sponsored by the Milwaukee chapter to celebrate its fourth anniversary.

The regional meeting also featured workshops, business sessions, parties and songs. The fast-growing international organization changed its rules this summer to include both sexes and all racial and ethnic groups, although only men were present at the local sessions.

Rothenberg said polarization along racial lines affects Gays as well as straights.

affects Gays as well as straights.

Despite a population of 400,000 Blacks in Memphis, Rothenberg said, there was no Black-owned Gay bar there. "Blacks are welcome or not welcome at the bars, but they are most often welcome after midnight."

Blacks have often perceived the Gay movement as white middle-class and male---"the same people who have

-"the same people who have oppressing been them,"

been oppressing them,"
Rothenberg said.

He said he helped found
the BWMT chapter in Memphis three years ago. "I
learned that Southerners do
not enjoy differences in
people. I'm not only Gay
and enjoy interracial relationships, I am Jewish,
Yankee, left-handed, educat-

ed and liberal.

"Just having a Black and white together without an employer-employee relationship is a political statement," he said he learned.

But he said economics is teaching Southern white business people, anxious to join in "Sunbelt" development, that they "cannot move forward while trying to hold someone else down."

Rothenberg contrasted Memphis where the white Democratic power structure excludes Blacks and Gays, with Birmingham, AL, which recently elected its first Gay mayor. That city has had an economic upturn because business investors see a Black mayor as evidence of a "stable political situation," he said.

Rothenberg pointed out that the Birmingham mayor has a Gay liason who awarded Lesbian-feminist singer Meg Christian a key to the city during a recent visit.

He said BWMT must also be more than political. "We have learned to love each other, we have learned to watch out for each other.

other, we have learned to watch out for each other. and we have learned to take care of each other."

care of each other."

He said two ways his chapter has done that are providing rap groups to "exchange real experiences" across race lines and developing a "data bank" of emergency information on members so they can help each other in case of accident, arrest, illness or death.



Tis the season not only for new calendars (and do they abound) but also for a new edition of whatever Gay guide you prefer. Here are some gift possibilities for that traveler on your list.

For the international set, Spartacus Guide for Gay men might be high on your list. It is a comprehensive guide for international Gays. The book is written in English, French, Spanish and German and provides not only the places to go in over 150 lands, but tells you a little of the customs and the laws in those countries. It sells for about \$20. Interesting reading, even if you don't do a lot of foreign travel.

For the domestic scene, there's Bob Damron's Ad-


For the domestic scene, there's Bob Damron's Address Book for about \$10. It has about 6,000 listings from the U.S. and Canada. Its 3" x 7" format is convenient for pocket or purse

Similar in size and concept are two books, Places for Men and Places of Interest to Women. These two guides are pleasing in format and use those cute little symbols to designate particular features of the places mentioned (a \$ is for "hustlers", a ship for "cruisey", etc.). These two are products of Ferarri Publications which also prints Places of Interest a larger book complete with maps. All of these guides include not only the U.S. and Canada but also the Caribbean. Cost is about \$7 or \$8.

Less classy, but probably conditions thing from bars and bookstores to doctors, lawyers and dentists. Gayellow Pages offers a number of regional editions which concentrate on specific areas of the country. The southern edition covers 17 states from Virginia to Kansas and from Arizona and Texas to Florida.

For those on your list who travel in more exclusive circles is Odysseus '85. This listle bars; it restricts itself to accomodations. It includes listings of over 450 hotels, motels, guest houses, bed-and-breakfasts, resort apartments, ranches, camping sites and private



detailed more Gayellow Pages. They're not really yellow, but for the money, they have a lot of information. Selling for about \$2.95, they list everything from bars and bookstores to doctors, lawyers and dentists. Gayellow Pages offers a number of

houses "catering exclusively to, or welcoming Gay men in the USA, American territories and Canada. There's even a listing of 125 USA and international travel agents serving the Gay community. Suggested retail price is \$12.95

Last, but certainly not least is Mike Smith's Colorful People and Places. While not the easiest to read, the book contains valuable material for people interested in inter-racial people and places. Our copy is dated 1983 and we're not sure if it has been updated. It can be ordered from Quar-

SF Baths Reopen -**Court Orders Monitors**

SAN FRANCISCO, CA --After having been closed for a total of 44 days, the Gay baths in San Francisco are again open to the public. On November 28, Judge Roy L. Wonder overturned the city's efforts to shut the businesses down by reversing a temporary restraining order which was issued in October by another Superior Court

Judge.
Attorneys for the club
owners were understandably
pleased. The Bay Area Reporter quotes one attorney, Thomas Steel, as saying "This reverses (Health Di-rector Mervyn) Silverman's closure order and that's the main thing. We've been saying it is illegal and this confirms it."

strictions for the sex businesses which, in addition to
the bathhouses, include sex
clubs. Among them were:

* No renting of private
rooms without a hotel li-

*Employees must monitor the behavior of patrons, and "expel from the premises any and all patrons observed engaging in high risk sexual activity." The definition of "high risk" sex is to be provided by the San Francisco AIDS Foundation

*Removal of doors to video cubicles, booths or rooms.

In addition, the judge

ordered that club owners "participate in the education of its patrons toward the prevention of high risk sexual activity" -- some-thing that many of the owners have been doing for a year or more.

According to attorney
Steel, even these restrictions are objectionable
"especially in the removal of doors and assignment of monitors. Having monitors to spy on the behavior of patrons is obnoxious and unconstitutional," he said.

The definition of "high risk" say will arouse a bit

risk" sex will arouse a bit of controversy. The AIDS Foundation, which is charged with issuing the formal definitions under the order, recognizes three levels of risk in sexual behavior: Safe, possibly safe, and unsafe.

Thanks to our SOS 84 program, we now have active committees in over 25 cities and good contacts in many others. Our potential for broadbased growth throughout the country is exciting."

GRNL Head Debates Homophobe

Gay Rights National Lobby Executive Director Nancy Roth locked horns recently

Executive Director Nancy Roth locked horns recently with Paul Cameron, the self-styled chairperson of the Institute for the Scientific Investigation of Sexuality, on the Balitmore Public Broadcasting Service show "People Are Talking."

Cameron gained notority in the Gay community when he issued vituperative literature against the Lincoln, Nebraska proposed amendment to add "sexual orientation" to the city's human rights section of the municipal code in May 1982. The amendment, which would have made Gays one of ten groups protected from disgroups protected from discrimination in housing, employment, and public accommodations failed, 3 to

Cameron again came to the community's attention in early October when he was stripped of his American Psychological Association membership for misrepresenting data and not

exercising scientific cau-

tion in reporting findings.

Roth answered Cameron's diatribes with calm disdain, asking repeatedly, "What methods did you use to obtain those statistics, Dr. Cameron?" Roth presented cogent arguments in favor of Gay rights legislation. of Gay rights legislation,

The Cost of Persecution

WASHINGTON -- According to the General Accounting Office (GAO), the cost of investigating Gays in the military last year was a whopping \$373,000. While that figure seems high, it doesn't compare to the \$23 million spent on training and paying these soldiers who are discharged before completing their duty. The completing their duty. The Navy accounted for more than half of the discharges in the past 10 years with more than 8,150. Of the 14,311 discharged, 191 were officers, according to the report.

The military continues to try to keep "queers" out of the services. The American Civil Liberties Union and the Lesbian Rights Project have filed suit on behalf of a female officer in the California Air National Guard who was discharged because of her homosexual-

According to the Gay Community News, 1st Lt. Julie M. Johnson wrote a letter to her commanding officer proclaiming her Gayness in order to "prevent any problems from arising in the future." Under the Air National Guard's regulations, declaring homosexuality or tional Guard's regulations, declaring homosexuality or bisexuality is "unfit or unacceptable conduct" and cause for administrative discharge action. Johnsonwas given the option of resigning or being subject to a termination proceeding. She refused to resign and in August, Johnson was given an honorable discharge.

In addition to various state and federal constitutional claims, the suit charges that as a state of California employee, Johnson's dismissal on the basis of sexual orientation vio-

of sexual orientation vio-lates state labor laws and Executive Order B-54-79. Executive Order B-54-79.
That executive order prohibits discrimination in state employment based on sexual preferences, and was signed by former Governor Jerry Brown in 1979.

Johnson is seeking reinstatement, back pay and attorneys fees.

Lesbian "Dad" Given **Visitation Rights**

OAKLAND, CA -- In what OAKLAND, CA -- In what may be a precedent-setting ruling, a Superior Court judge has granted visitation rights to the former lover of a woman who conceived a child by artificial insemination while they were together. together.

Linda Loftin married
Mary Flournoy in a 1977
church service unrecognized
by the state. Flournoy was
artificially inseminated by
sperm donated by Loftin's
brother. The couple reared
the child for two years
until they separated in
1980. Since then, Loftin has
been unsuccessfully trying
to visit the girl, who is
now six. Flournoy blocked
the effort, fearing a disruption of the child's life.
The two women settled out

The two women settled out of court last month and Loftin's visits were to begin November 29. The ruling is precedent-setting because until now, visitation rights had only been granted to biological parents, grand-parents and stepparents.

Dr. Stephen Morin, speaking at a forum sponsored by the American Psychological Association, said that AIDS is causing a lot of Gay men to drastically alter their lifestyles and is providing an excuse for violent Gay bashers to operate.

Morin, who is from San Francisco, likens the city to a "war zone." With a Gay male population of about 70,000, there is one AIDS death and two new cases reported daily. Morin has been studying about 800 men. He states that at least 40 have remained celibate out of fear of catching the disease. He claims the average number of sexual partners each month has dropped from six to just under four in the past year.

Health Crisis Faces Shortfall

The largest private social service agency dealing with AIDS is in trouble. Faced with a potential shortfall of \$100,000, the group is distributing an informational packet in hopes of raising money.

Despite the doubling of

diagnosed AIDS cases every six months, contributions to GMHC have declined severely in the past 6 months. Organization officials attribute the fall in contributions to the lack of media coverage of the disease. In August, 1983 GMHC caseload was about 200 people; today the case load stands at almost half of the cases in New York City... about 1000. New York is the hardest hit of the metropolitan areas. 





Putting the Spiritual and Sexual Self Together Again

Fragmentation is the reality of many people's lives.
We are emotionally, psychologically and mentally compartmentalized. One sphere of our life or lifestyle is segregated from other parts of ourselves. This is almost universally true of our sexuality. A private matter is what the folk wisdom and custom of culture call it. Sexuality is only for the bedroom and not for public discussion or visibility. That is just why Gay people are told not to demonstrate any sexuality or people are told not to demonstrate any sexuality or sexual preference in public. Somehow the exhibition of heterosexuality is glossed over as innocent affection or something other than sex. "Innocent affection" expressed by Gay people immediately raises fears that overt sexuality may immediately raises fears that overt sexuality may follow. The issue is a fear

follow. The issue is a fear of sexuality.

Gay people themselves participate in maintaining this status quo and work to keep their lives private. While this may appear at first glance to be the way to go, and may seem to be a route to freedom, it is a dead-end street. I am not saying that sexuality must all of a sudden be open and public, that we all begin copulating on the street corners, but I am going to say that sexuality is a dynamic energetic force which is close to our spiritual selves and must be harnessed to our spiritualharnessed to our spiritual-ity if we are to be ful-

ity if we are to be ful-filled.

We have been taught and society has modeled a life-style in which spiritual and society things are polar opposexual things are polar opposites. This has been the achievement of Western achievement of Western Christianty in particular. Example: how would the church you grew up in respond if you offered a verbal prayer during worship which said, "Thank you, Lord, for my sexuality and the joy of sexual expres-Lord, for my sexuality and the joy of sexual expression"? They would probably fall our of their pews, then escort you out of yours. In reality, that is just what has happened to Gay men and women. We have been escorted out of the religious communities we were once a part of precisely because our very presence threatened to undo the traditional structures which had conveniently held sexuality and spirituality apart from one another. To allow Gay people to stay in the religious structures inevitably brings about the dialogue of sexu-

ality and spirituality.

What is needed now is a frontal assault upon the old structures to result in the merger of sexual and spiritual reality not only within the churches but within each of us as individuals. This of us as individuals. This merger is often frightening.

merger is often frightening.
We, ourselves, often oppose
this merger and seek to
shore up old walls which provide separation and a false
sense of security.

Nevertheless, the agenda
to unite both worlds proceeds. Why does it proceed?
Because the truth at the
heart of the struggle is
that there are not two
worlds, one sexual and one
spiritual. The truth of the
matter is that to know the
fullness of spiritual truth, matter is that to know the fullness of spiritual truth, one must engage the substance of sexual energy and reality. The truth is also that to know the fullness of sexual energy and its meaning, spiritual reality must be brought into the sexual exchange between two persons. Herrein lies the essence of the mystery which religious form and sacrament has sought to communicate for centuries. This essence is the achievement of communion, the blending of two lives in ways that profoundly influence and change both. The depth and height of human love evidences the occasion of boly communion in which love evidences the occasion love evidences the occasion of holy communion in which two persons merge their realities by way of physical sexual sharing. In doing so, they discover the presence of God in the most vital and real ways humanly attainable. What happens in this union is revelation of the nature of each person's being as well as the interdependence of each person with the Divine. with the Divine.

The fact that this is true presents us with this dilemma: the merger of the sexual and spiritual "stuff" is volatile and life changing, therefore, we fear it and seek to contain and avoid it. This containment motive has been the source of the world's attempt to devise sexual ethics in such a way as to prohibit sexual expression save under the most restricted of circumstances. The resultant "sexual ethic" is not a sexual ethic at all, but a procreation ethic. It does not serve or express the reality of Gay people either sexually or spiritually.

If, in essence, we as Gay people are not so different from the rest of humanity, then this ethic does not The fact that this is true

serve the rest of humanity either. The procreation ethic to contain sexuality in order to appease human fear, has produced and reinforced the social institution of marriage. Religious symbols and meaning have been co-opted by culture to aid in this process of containment. The tragedy is that the deeper purpose of the religious symbol, i.e. to express human love and relationship, to mediate the union of sexual and spiritual, has been lost in the process of serving political, economic and other cultural needs. The old models must not be replaced for the sake of enabling health and wholeness of live for both Gay and non-Gay people. So let us work out our own ethic which begins with the agenda of discovering our spiritual selves and proceeds to the action of allowing our spirit to interact with our sexual selves. The result will be vital and healthy human beings able to love and empowered to create community. The result will also be the source of reformation and restoration

of a decayed and corrupt Western religious tradition which awaits the voices of new prophets.

The place to begin is in our own minds, our own hearts and our own beds. The best sex you will ever have will be a spiritual experience produced out of communion, dignity, self-respect, love and honesty; and this can't happen with anonymous strangers. All of the "hot" and passionate sexual desires we have ever had are fulfilled beyond the event of sexual and spiritual union and through this union. Every other pursuit is a vain hope.

This is a road to freedom.





Are The Gay Communities Political Leaders In Danger Of Becoming Uncle Toms?

First of two parts by Joseph Di Sabato

A large measure of the Gay movement's failure to win the struggle for our civil rights is due to poor packaging, poor public relations, and poor communications. The recent conduct of Walter Mondale and Geraldine Ferraro with respect to Lesbian and Gay rights during the political campaign just ended points out quite clearly that we are not accepted as a community whose struggle for equality should be openly advocated in the name of "justice" and "fairness" -- two concepts upon which Mondale centered upon which Mondale centered his try for the presidency.

Many of our community's political leaders deny this, pointing to the extremely positive positions taken on Gay and Lesbian issues in the Democratic platform. Gay and Lesbian issues in the Democratic platform, and the fact that Mondale had several openly Gay people on his campaign staff including the first liason to the Gay community ever appointed by a major party's presidential candidate. Such a claim is strong evidence that many of our community's leaders have personally become so enmeshed in ly become so enmeshed in the political games of the establishment elements of the Democratic Party that they can no longer see the forest because they are far forest because they are far too close to the trees. As a result, our movement is marketing its struggle as ineptly as Walter Mondale marketed his candidacy.

I want to make clear that my thoughts here are not to be interpreted as attacks on any specific individuals but

my thoughts here are not to be interpreted as attacks on any specific individuals but rather as an attempt to open up a crucial dialog within our community concerning both the tactics used in this election and the changes we must make in those tactics over the next four years. 

The Gay press, which is the only media reguarly covering our issues, is read by less than 5% of the country's Gay population. Moreover, due to this lack of mass media this lack of mass media coverage, even most of those who have come out to some degree have not been sufficiently educated to the fact that our civil rights are more imperative than perceived short-term economic advantage. The Gay vote which does exist is only the minority of those of us who are self-identified as Gay, only a small fraction of the total homosexual population.

Many Gay people truly

total homosexual population.

Many Gay people truly feel that their sexual orientation and issues arising from that orientation are not good grounds for making political decisions. Many Gay people feel that we have made friends and won significant battles over the past decade (and we have), that things are good for the Gay community these days (and they have certainly improved), and that we have come too far for anything to turn that around now (which is the ultimate in self-deception). Putting perceived economic self-interest before civil rights interest before civil rights was the same mistake made by the Jews during the rise of Nazis in Germany -- not an extremist comparison for anyone who knows history. Social complacency will be our community's downfall if we don't take soriously the

our community's downfall if we don't take seriously the tenuousness of our progress.

How can this complacency continue in the face of the hateful rhetoric of the Moral Majority, in the face of an incredibly significant anti-Gay federal court ruling handed down during the height of the campaign, in the face of the refusal of the Reagan administration the Reagan administration to request badly needed additional funding for AIDS

research (against the recommendations of its own Assistant Secretary of Health)? The complacency continues because of the poor visibility of our issues and the unwillingness of our leaders to force the Democratic Party to articulate them.

The Platform Strategy

We must ask whether our

We must ask whether our leaders are as afraid as the candidates are as airaid as the candidates are of provoking the New Right into publicly appealing to anti-Gay bigotry and thus forcing our friends to address the issue. The opportunity to open a nationally televised political dialog on our issues ovisted for the first political dialog on our issues existed for the first time in this election, when the Democratic Party adopted strategy of direct confrontation with the social agenda of the New Right. the Instead, the Democratic Party was given the signal by many Gay leaders that — if the platform were sufficiently strong and specific in taking favorable posttions on our issues — we would accept the practical political realities which have traditionally held true and not embarass our friends by making them take a pub-Democratic by making them take a pub-lic posture on Gay rights.

Therefore they gave us the most favorable and specific Gay rights plank in history (even writing the terms "Gay" and "Lesbian" into the platform); we couldn't have asked for more in this regard. They even officially recognized the Gay democratic alubs as a Democratic tic clubs as a Democratic Party caucus, entitling Party caucus, entitling Gays and Lesbians to a seat on every significant party committee. Thus, behind the scenes, the Democratic Party was as pro-Gay rights as we could have desired. A cynic might claim that they went this far in order to any confrontation might place their which which might place their position on these issues in the full light of mass media coverage. Most people, however, are not familiar with party platforms. Only when platform stands are repeatedly made part of the public debate are people made aware of what they say.

We are buying into our own oppression by accepting invisibility. Only in New York, where there existed a close personal relationship between one of the Gay community's political leaders and the head of the State Democratic Committee. Democratic Democratic Committee, were there any Mondale ads bought and paid for in Gay media by the state Democratic Committee. Nowhere were ads bought by the Mondale campaign itself. In other areas where specific Mondale ads appeared (as opposed to ads from Gay political organizations listing an entire slate of Committee,


candidate endorsements including Mondale), such ads were paid for by Gay committees supporting Mondale and not by Mondale's cam-paign or by the state Democratic Committes. More-over, there I am aware of specific Mondale ads only in or Houston -- all areas with supposedly large and influ-ential Gay voting blocs.

Moreover, the appointment of Sandra Gillis as "liason" to our community was obviously just a bone thrown to us. Ms. Gillis was unknown in Gay political circles, had little knowledge of the Gay political structure. of the Gay political structure and virtually no personal contacts with the majority of Gay political leaders throughout the country before her appointment. She spent much of her two months as liason meeting months as liason meeting Gay political leaders, learning as much as she could about their organizations and their role in the community, and being assured that the Gay political structure was solidly behind

Mondale. Such an inexperienced liason would never be found suitable for any other significant constituency; yet we were -- once again -- grateful for anything. I'm sure that all of these assurances by our poltical leawere comforting ders Washington, Chicago, Miami Mondale's campaign -- especand Philadelphia; surpris- ially since no vocal public ingly none ran in San Fran- support for our struggle was cisco, Los Angeles, Boston demanded in return. If Sandemanded in return. If Sandra Gillis naively assumed that such support on the part of Gay "politicians" translated into support on the part of the average voter in the Gay community (as opposed to support from (as opposed to support from that small percentage of Gays and L sbians who are politically aware), she was sadly mistaken.

In Orwellian terms, the much balleyhooed year of 1984 was "Double Plus Good" for Nashville's Gay community! The year just passed offered advancement and "Victory" on many fronts for Lesbian and Gay men in Music City USA

1984 was called the "year of George Orwell", and in JANUARY, The Cabaret ushered in the year with a suitable, high-tech nod to the future. As reported in the February 1984 issue of Gaze, The Cabaret became the first "video show bar" on Saturday night, December 31, 1983, when it unveiled two ten-foot television screens, one on either side screens, one on either side of the stage. The very latest music videos are projected onto the screens, while the video's stereo soundtracks resound throughout the Hayes Street club.

Video cameras and a computerized, design-generating device called a Chromoscope are also used in The Cabaret's nightly, imaginative video projections on the pair of giant screens.



The program was sponsored by the Council On Human Sexuality. Finally, Thursday FEBRUARY 23, 1984, was a red-letter day for the Gay community, as that was the day that The Chute opened its doors and began drawing impressive crowds almost impressive crowds almost immediately. Located in the Franklin Road building which housed Mother's Construction Company during 1983, The Chute replaced Mother's futuristic decorand regrettably meager and regrettably meager crowds with an inviting country-and-Western atmosmeager inviting phere and a hefty stable of faithful and ever increasing customers (as reported in the April Gaze). Fascinat-ing Old West memorabilia is everywhere at The Chute, and a warm stone hearth, 18-Gaze-January, 1985

friendly staff, and appetizing short order menu are the popular "extras" which may have prompted the 1984-1985 edition of Bob Damron's Ad-dress Book to add the deserved message, "Looks Promising", to The Chute's listing therein. Since FEBRU-ARY, The Chute has been putting its unique brand on Nashville's Cover Communications. Nashville's Gay Communi-ty. As a result, the bar has lassoed a diverse, thriving clientele.

MARCH was the month that David Silver and his Fantasy Male Revue took to the stage of The Cabaret, and Rita Ross headlined at Warehouse 28. As announced in the April issue of Gaze, MARCH also brought an exciting new feature---live piano music---to Nashville's downtown landmark, Juanita's 224.

The seventh annual Miss The seventh annual Miss Gay Cabaret pageant was held in APRIL 1984, and contestant Tamiki Ross took the crown. A festive party commemorated the first anniversary of The Jungle's move to its new locale, and Music City's everpopular Warehouse 28 celebrated its

sixth anniversary with a "Tropical Madness" party, a sweepstakes, another performance by Rita Ross, and a special concert by "progressive bluegrass/fusion" artist, Robin Flower. Also in APRIL Reverend Paul Tuck-APRIL, Reverend Paul Tucker and the Metropolitan Community Church participated in a Tennessee State University seminar on the crucial subject of being Gay and

Christian.

The MAY 1984 issue of
Gaze carried the hopeful
headline, "AIDS CAUSE DISCOVERED", as well as news

of the merry third anniversary celebration at The Crazy Cowboy. A major portion of the proceeds from The Crazy Cowboy's festivities was donated to the Multiple Sclerosis Society. The Warehouse welcomed the Sleazebuckets for one MAY Sleazebuckets for one MAY performance, and The Cabaret presented the official Mister Gay All Tennessee pageant (the preliminary to Mister Gay All American). Mark Middleton was named Mister Gay All Tennessee and went on to represent the Volunteer State in Oklahoma. Finally, on Monday Volunteer State in Oklahoma. Finally, on Monday night, MAY 21,1984, Nash-ville's Gay community, as well as delegations from Chattanooga and Chicago, convened at the Polk Theatre of the Tennessee Performing Arts Center downtown to witness the first annual Miss Continental Tennessee pageant for female impersonators. At the stroke of midnight, the wonderfully elegant ceremony crowned the contestant who subsequently represented Tennessee in the Miss Continental USA pa-Miss Continental USA pa-geant in Chicago in September. At the Tennessee preliminaries, pageant coordinator Ginger LaMar and then reigning Miss Continental Chena Black welcomed seven outstanding and stunningly attired contestants from Nashville and Chattanooga. Ultimately, Diana Hutton was crowned Miss Continen-tal Tennessee, and Stephanie Wells and Terry Livingston were the first and second runners-up. In addition to the two-page pageant article and five photographs published in the June Gaze, the Polk Theatre gala was covered by The Nashville Banner.



You get the prank calls, the kids playing on the telephone, the people who think that insulting you for being Gay is doing some good and the ones who try to convert you. Nobody said it was going to be easy.

Working the Gay Switchboard on a weekly basis is really an eye-opener. It is at once tedious, fulfilling, boring and exciting. Rarely a dull evening.

evening.

I got involved with the Switchboard initially a couple of years ago. I wondered how I, who had so many of my own doubts, many of my own doubts, could even consider giving advice to someone else.

you're lucky, you'll have most of the answers or at least know where to find them. Many of the questions involve special events, where the bars are, where the bookstores are, if there is a bathouse in the area or where Gays gather. Those are the easy ones.

But every once in a while a hard one will come up.
"How do I tell my parents I'm Gay." "I'm really attracted to this guy (or gal) I met. How do I find out if they're interested.",
"Should I tell my "Should I tell my ____ (boss, mother, wife, sister, friend... fill in the blank) that I'm Gay?"

"I'm Gay and I'm really having a problem with it."

"What kind of a problem?"

"Well, I know I'm Gay.

That's not the problem. The problem is that I love God and God says it's wrong.
