Health Depts., Blood Banks Share AIDS Concern

The consensus of opinion of public health officials and blood bank workers in and blood bank workers in Tennessee seems to be that the HTLV-3 antibody test for AIDS is premature. The reality, however, is that the test will be licensed soon and blood banks and health departments are preparing to meet what may be an onslaught of Gay men who want to take the test.

A group of 200 public health and blood bank officials met in Nashville on February 26 to discuss the implications of the HTLV-3 antibody test.

antibody test.

"Don't have the test done unless you are prepared to know and accept the results," said Dr. Tom Peterman, one of the representatives of the Centers for Disease Control conducting

Disease Control conducting the meeting.

One of the main concerns of the group is that many Gay men who feel themselves at risk, will want to have the test done and may try to get the test free by going through a blood bank. Blood banks will be required to run the HTLV-3 tests on all blood. They are generally not equipped to deal with

the emotional trauma that a positive test might incur.

Gay organizations thoughout the country have been urging their constituencies not to take the test because of the problems with interpretaproblems with interpretation of positive results. The test screens for HTLV-3 antibodies only. It cannot determine if a person has AIDS, if he or she will develop it, is immune to it or can infect others. Its primary usage will be in screening donated blood.

Another concern shared both by health professionals and Gay leaders is the one of confidentiality. Currently

most blood banks which de-fer donors for medical rea-sons categorize those sons categorize those reasons. For example, if a person is deferred for having had hepatitis, that information about him is easily available. Because of the sensitive nature of AIDS, it is felt that routine precautions for confidentiality may not be adequate.

Meeting participants also noted that while there are noted that while there are multiple confirmatory tests for such things as hepatitis, syphilis, etc., there is only one such test for AIDS antibodies. A positive HTLV-3 antibody test can only be confirmed by reperforming the same test. If the test result is positive, health departments at present are either unable or unwilling to do the necessary additional blood workups to determine if the person really has AIDS.

Eugene Forrester, Executive Director of Life Blood, said without a confirmatory test available, "this test can cause more problems than it can cure."

According to CDC, 20 cases of AIDS have been reported in Tennessee with the majority of those in the Memphis and Nashville ar-

Lawrenceburg Man To Fight Dismissal

It's 15 minutes before quitting time on a Friday afternoon. You are summoned to the personnel manager's office who has heard rumors you are Gay and are asked to resign or be fired. Impossible? Ask Gerald Cole, a 29 year employee of Murray Ohio Manufacturing in Lawrenceburg, Tennessee. It happened to him.

Cole, a quality assurance supervisor, with the bicycle manufacturing company since 1955, was summoned to the office of personnel manager Larry Heard February 8 and given the ultimatum. According to Cole's account, ger's office who has heard

given the ultimatum. According to Cole's account, Heard heard through the grapevine that Cole was "going to marry a man" and that he "preferred men to women." He was told that it was "affecting the efficiency of you as a supervisor." and was given the choice of voluntary resignation or termination. Cole chose to be fired so that he could fight the case.

Cole says that no direct accusations of misconduct had been filed and no one was named as having filed a complaint. He claims that he was not given a chance to respond and was given 45

minutes to remove all his belongings from company property. He has yet to re-ceive an official reason for

ceive an official reason for his firing.

Cole is at a loss to explain the company action against him. He says that unions have tried to organize the plant in Lawrence-burg on a number of occasions and that he may have been identified as an organizer but that is not the case. He theorizes that he may have been passed over case. He theorizes that he may have been passed over for promotions over the years because of that allegation but that his personnel record was clean and his yearly evaluations were close to perfect. "This came out of the clear blue sky," he said. "I had no idea why they were even calling me (to the office.)" Cole says he never really liked the idea of a union and thought he had a good rapport with his co-workers.

Cole contends that some

Cole contends that some of his co-workers may have thought him Gay but that he had always been discreet. He has been living with his lover Ricky for some years.

Roy Moore, Cole's immediate supervisor, apologized to him before he left adding

that there was nothing he could do and asked if he could help in any way.

The Equal Employment Opportunity Commission does not recognize sexual orientation (only sex) as a basis for a claim against the com-

pany.

Cole plans an action against the company for his firing and has contacted the ACLU of Tennessee and Gay Rights Advocates to determine his standing in the

At present Cole is out of a job and cannot receive his retirement benefits until age 62. He says, "I've never been a Gay rights activist but I'll work til my dying day for it now."

In recent weeks, we have seen a 5 part series on AIDS on Channel 13, a major documentary on AIDS on PBS stations, and a major story on a victim of AIDS in Mid South Magazine. A number of us have been touched by the fact, that although invisible to us, we either know a victim or his loved one. We've heard stories of men in our midst who have AIDS and need our help. We finally realize that we are not an island of immunity in a sea of epidemic --AIDS is in Tennessee.

A number of us said long ago that it was going to take a friend coming down with AIDS before we real-ized the severity of the problem. That has happened and the community is mobil-

izing.

The last meeting of ATEAC resulted in a setting of priorities and was perhaps the most creative meeting I've had the pleasure of attending.

We all realize that fundraising is going to be a ma-jor endeavor. Without that we cannot hope to accomplish our goals of education, assistance to AIDS victims and grants to research teams. And yet, we are all concious of the fact that people do not want to be beaten over the head con-

stantly for money. Regard-less of the motivation or worth of the cause, that gets old. So how to get without money begging? That's creativity where comes in.

The fundraising ideas hit right where Gay people live and give them something for their money. Here are some of the ideas:

** A booth at the Flea Market (we seem to populate it on Sunday afternoons anyway.)

** Raffles of various sorts ** A summer block party with booths staffed by mem-** bers of various organizations

** Special shows- Cheese-Beefcake Contests, dinners, celebrity roasts (Can you celebrity roasts (Can you imagine a roast of George Wilson or Sharon Wray??)

Members have been invited to participate in the decision making process at Health departments not only here in Memphis but in Nashville as well. 
MGC to ATEAC

The Memphis Gay Coalition has made a donation in the amount of \$500 to the Aid to End AIDS Commit-

The Coalition's "AIDS Fund" was established two years ago with the proceeds of "Old Hash," a benefit performance staged at Circuit Playhouse. Approximately \$2000 was donated by the Gay community at that time. The coalition has maintained the funds from the benefit (as well as others earmarked for AIDS) others earmarked for AIDS) is a separate account. "We initially spent some of the money for AIDS brochures," said Bob Dumais, president of the MGC. "After that initial effort, we felt that we should simply hold on to it until something worthwhile came along, rather than buying more brochures." than buying more brochures." The thinking has been that the money should be held in reserve in case an AIDS victim needed financial assistance. Vincent Astor, who spearheaded and produced "Old Hash," proposed that \$500 be donated to ATEAC since that group will be dealing directly with AIDS patients in the area. 
unanimous.

HRCF Undertakes Major Survey

The Human Rights Campaign Fund (HCRF) is about to undertake a major nation-wide survey of its constituency to assess its political philosophies and priorities.
The survey, to be compiled through the mail, was included in a February 15 letter to HRCF contribu-

Vic Basile, Executive NCBG Installs
Director of the Fund, which is the sole national political action committee dedicated to supporting candidates favorable to Gay civil rights issues, said the survey was being taken to assist the PAC in planning its political agenda for the next election cycle. "We need to understand the mindset of the Gay community if we are to be a truly representative organization," Basile said. cal action committee dedi-

Basile said. The survey respondents on their political philosophies, their partisan identification, their votes for President, U.S. Senate, and U.S. Representative in the last election, and the primary motivating factors in their selection of a candidate. In addition, the questionnaire seeks to discover how cohesive a

"voting bloc" the Gay community might be.

"One important piece of
information we'd like to

information we'd like to learn is what percentage of the Gay electorate will vote for a candidate primarily based on his or her stand on Gay civil rights." said Basile. "It's important both for us as an organization and for candidates of both parties to know the kind of impact their stand on this issue will have on Gay voters."

The survey asks repondents to rank eleven separate items on the Gay political agenda in order of priority.
The eleven items include: abolishing restrictions on Gays, abolishing sodomy laws, increasing funding for AIDS research and treatment, and other concerns ranging from discrimination in the military, employ-

ment, housing and adoption to legal recognition of he rights of Gay couples.

The Human Rights Campaign Fund is a Washington-based political action committee, and is one of the largest PACs in the United States.

WASHINGTON, DC -- The National Coalition of Black Gays (NCBG) has concluded their three-month search and announced the election of seven women and two men as members of the the board of directors until their gener-al elections are held in November 1985.

The new members include: Audre Lorde, poet and writer; Marlena Goldie Mason, political activist; Michelle Parkerson, filmmaker and writer; Luvenia Pinson, poli-tical activist; Clifton Roberson, president of the DC Coalition of Black Gay Men and Women, Gwendolyn Rogers, anti-war, lesbian-feminist and anti-racist or-ganizer; Rev. Minure Saunders, co-chair of the Illi-nois Lesbian and Gay Task Force; Barbara Smith, feminist writer and a founding member of Kitchen Table: Women of Color Press; and Dan Weddo, a professor of International Studies and contributor to Habari Daftari. There are now 13 board members.

Apuzzo Resigns **NGTF** Post

Apuzzo, executive director of the National Gay Task Force (NGTF), has revealed she will leave that organization March 17 to become deputy director of the New York State Consumer Protection Board. The Washington Blade reports that she will join the staff of New York Gov. Mario Cuomo after a four week vacation.

Apuzzo's resignation bound to have a significant impact on NGTF as well as the Gay movement in general. NGTF has been struggling in recent years to obtain its niche in the Gay political movement. litical movement. Apuzzo's predecessor, Lucia Valeska, quit amid a controversy regarding her effectiveness as a leader of the organization. It is interesting to note that the same type of accusations led to the resig-

nation of Steve Endean, former executive director of the Gay Rights National Lobby. NGTF and GRNL have suffered from strained relations for years.

It is expected that Jeff Levi, head of the NGTF Washington office, will re-place Apuzzo until a successor is named.

Erie Will Ruled Valid

ERIE, PA -- The will of an Erie, Pennsylvania profes-sor who bequeathed \$150,000 to the "furthering of the civil rights of American civil rights of American homosexuals" has been declared valid by Judge James
Dwyer. The 1981 will of the
late John D. McBride had contested by nieces.

McBride resided in Erie County from 1969-1979 and taught French at Edinboro State College. He retired to Mexico in 1981.

According to Gay Community News, his two nieces appealed the probate on the grounds that McBride's residency in Mexico at the time of his death required probate under Mexican law. Their attorney argued that the entire will should be held invalid since the will was drafted in Pennsylvania. The court was then asked to distribute McBride's estate among the blood relatives

and legal heirs, the nieces.
Since the will did not name specific beneficiaries (only that The Advocate should be used as a guide for choosing such), a number of Gay legal organizations have sought to gain legal standing in the case. Among them are Llambda Legal Defense and Education Fund, National Gay Task Force and Gay and Lesbian Advocates and Defenders.

In deciding the validity of the will, Judge Dwyer noted the "obvious intentions in distributing the estate" by referring to a previous will dated January 1977 which included an identical proviso. In that will, no money was bequeathed to

the contestants.

San Francisco Asks For Bathhouse List

SAN FRANCISCO -- The city attorney of San Francis-co has asked for attendance records of Gay bathhouses and clubs. The Bay Area Reporter says the order was part of a broad suppoena asking for "any and all documents, including but not limited to, records of attendance... during the period of June 1, 1984 through August 31, 1984."

Club attorneys reportedly were outraged at the demand and planned not to honor the suppoena. Apparently the request was made in an effort to determine the number of people attending each club so that the city might bet-ter gauge the number of "monitors" it needs. The monitors are needed to police a court injunction which calls for bathhouses

to remain closed until a monitoring system can be worked out.

Houston Ordinance Defeated

HOUSTON, TX -- There was good news and bad news in Houston in January. The bad news was that voters overwhelmingly defeated an ordinance protecting Gays in city employment 82% to 18%. The good news is that Houston Mayor Kathy Whitmore has said, as long as she is mayor, the pro-visions of the defeated ordinances would be followed by her administration.

The Houston City Council passed two ordinances in June which added "sexual orientation" to the list of protected classes and which changed the city's affirmative action plan to protect tive action plan to protect Gays. Opposition to the ordinances erupted immediately primarily from fundamen-talists and a petition drive was launched to place the questioned items on a referendum. That vote took place January 19.

NCBG Receives Grants

The National Coalition of Black Gays has received totalling grants about \$3,000, according to The Washington Blade. The funds will be used to support their local chapter and their publication.

The group also announced that Audre Lorde, poet and writer, and Barbara Smith, founder of Women of Color Press had joined the board of directors.

High Court Refuses To Hear **Bisexual Case**

The Supreme Court refused to set a precedent in determining whether any public employee could be fired legally "based solely on his or her expressed sexual preference." According to the Commercial Appeal, the ruling in the case of Ohio high school guidance counselor, Marjorie Rowland, which stated that public employees are only protected from retaliation when they speak up on matters of public concern, not on private matters, was upheld by the Supreme Court. fused to set a precedent in preme Court.

Ms. Rowland sued the school board after they refused to renew her contract upon learning that she had discussed her bisexuality with colleagues. Having worked as a counselor since 1974, she charged that her constitutional rights of free speech and equal treat-

ment had been violated.

Justice William Brennan
and Justice Thurgood Marshall cast the two dissenting votes feeling that the Supreme Court should have used the case to establish whether or not a public em-ployee could legally be fired based on sexual preference. Earlier, a federal jury ruled in favor of Ms. Rowland but the decision was reversed by an appeals court and ultimately that decision was upheld by the Supreme Court. The ruling against the Ohio counselor by the appeals court said that she "failed to prove that she was performing her ich properly."

The married man is the worst. He is convinced that the man who gave him the blow-job also gave AIDS. It may have been the only time in his life he was with another man sexually, and all he did was ejaculate in the man's mouth. It is the old "boy, was I drunk that night" syn-

Partly out of homosexual panic and guilt, he is positive he has AIDS, is giv-ing it to his wife, and in time all his kids are going to die as well. He cannot be

reassured enough.

Of course, we are all con-cerned about AIDS. More than once, I have thought I was only days away from the full-blown AIDS syndrome and that my bruise would turn into Kaposi's or the cough would become pneumo-

But some people keep this up for months. They do not have AIDS. They are the worried well. They worry them-selves sick. They lose weight, they cannot sleep, and they keep feeling their neck and checking their skin for lumps and bumps.

Gay men are remarkably well informed about AIDS.
They probably know more than some straight physicians. Like the medical student who is convinced he has every disease in the pathology book, sometimes we overreact. These are some of the common pitfalls:

Tongues You will probably see the color of this morning's mouth wash or last night's peppermint candy. There will be yeast, molds, fungus, taste buds, and maybe even an image of the Virgin with the moisture your body produced to lower its temperature. Moreover, the moisture your body produced to lower its temperature. Mary.

Tongues change their coat and color depending upon the diet you eat, the air or smoke you breathe, or the medicine you take.

tic infection. It is normally there. Do not have your tongue cultured or scraped for yeast. The white patches of Monilia or thrush that you should worry about as every idence of decreased cellular immunity and opportunistic evaporative cooler and sweating. Synthetic sheets will not release this extra warmth as well as cotton. All these conditions can raise your body's temperature, and sweating is just a normal way to bring it down. immunity and opportunistic down.

infection will be on the buccal mucosa inside the cheeks or lips. So do not bring your coated tongue in for a \$25 checkup; brush it, rub it, kiss it, or just ignore it.

Lymph Nodes

I do not count lymph nodes felt at the angle of the jaw in a lymphadenopathy check. These are normally felt and sometimes will be sensitive because of an adjacent carotid artery, recent sore throat, or smoking.

Also, do not worry about original lymph nodes, unless you are positive they have become much larger. Males normally have palpable groin nodes. Probably they stay enlarged because our legs are subject to a variety of nicks, scratches, and superficial infections. Also, if you ever had a rectal sore or absence you know that inor abscess, you know that inguinal nodes drain the buttock area.

When checking for lymph nodes, remember that they are beneath the skin. Not uncommonly, a patient will in-terpret a sebaceous cyst which is intradermal for a lymph node. And when checking for lymph nodes, do not start pinching and grabbing with the fingers, because you will create a variety of imaginary lumps and bumps.

Just as women are advised on cancer checkups on breasts, it is better to use a rolling action with the finger pads flat against the body in lymph node examinations.

It is important to recall that a low-grade temperature elevation does not always signify the presence of illness. The body temperature may rise above 98.6 during exercise or excitement, particularly in a warm environment. Marathon runners have elevated temperatures at the end of the race. On a hot day here in Sacramento, healthy patients' tempera-tures are recorded up to 100 degrees and regarded as normal. A few individuals who are otherwise in perfect health will persistently have temperatures of a degree or so above normal, a condition know as habitual hyperthermia. But rather than live with the anxiety of night sweats, merely record your temperature for a few nights. If it is persistently over 100 degrees, check with your physician. Fever is the usual body's response to infection. Yet my patients oftentimes cannot tell me if they had fever. That piece of information is invaluable and sometimes worth hundreds of dollars in exotic procedures and blood

Tiredness

There must be a hundred reasons for tiredness. Syphilis, mono, hepatitis, CMV, or anemia are just a few.

A couple of disgruntled patients left our practice once when their syphilis blood test came back a few days later from the County Health Department as positive and accounted for their lymphadnopathy instead of an AIDS-related condition that was our initial concern. Any other physician probably would have missed the diagnosis of syphilis entirely. Doctors do not always have the advantage of test re-sults during the first evaluation.

Syphilis is a great masquerader. The great grandfather of modern medicine, Dr. William Osler, once said that "if you know syphilis, you know medicine," With the benefit of some Constant reassurance experience, I have made that they do not have AIDS seems diagnosis in situations to help. Slowly, they gain where it had been missed by insight into their preoccuinfectious disease specialists. Because the disease can be subtle, if you are sexually active, and especially if you have lymphadenopathy, you must have syph-

ilis ruled out.

Wound Healing I do not know how long it takes a cut to heal; they never told me in medical school. It must depend upon how deep it is, where it is, and how close the skin edges

Yet patients are sure they have AIDS because their cuts do not heal fast

enough.

I have had a year's fellowship in hematology (blood diseases), and as far as I can tell and have read, skin healing is not a good assessment of the immune function. While it is true that bacterial infections can slow down healing, AIDS patients do no usually get bacterial infections. They are more likely to be viral, fungal, and protozoal. Skin

Remember Nyuk Tsin, the old Chinese woman with the big feet in Michener's book, Hawaii, who inspected her body for signs of leprosy every night before she went to bed? Well, I have patients like that

tients like that.

Unfortunately, the normal person has two or three dozen moles. It is true malignant melanoma is one of the worst cancers and must be caught early. However, there is not that same advantage for the early diagnosis of Kaposi's sarcoma. Most AIDS physicians are putting off the treatment of Kaposi's sarcoma for fear of further immune suppression.

Anyway, most of the time Kaposi's sarcoma will blossom all of a sudden in several locations and is not easily missed. Kaposi's sarcoma is pretty distinctive with its red, purple, and violatious changes, and of-tentimes the patient knows the diagnosis before going for a biopsy.

Conclusion

Do not trouble trouble unless trouble troubles you. For some of the worried well, the best advice about AIDS is: Do not read about it, do not talk about it, and do not think about it. Let your physician worry about it; that is partly what he is paid for.

On my part, I have found that seeing the neurotic, worried, well patient frequently and at regular intervals seems to help. Even if it is the thousandth time, I try to be open-minded about each one of their complaints rather than dismiss the problem as "all in your head."

New AIDS Treatments Tried

While the controversy rages surrounding the AIDSexposure test, researchers have been working on new drug therapies to help those already diagnosed with the

French and British researchers have discovered that the AIDS virus attaches itself to special white blood cells reproducing it-self and destroying the cells. With this destruction comes the total collapse of the body's immune system. Now they are experimenting with antibodies which will attach themselves to these preventing cells anything else from connecting to them, thereby preventing the HTLV-3 virus from gaining a foothold.

The drug Suramin, reported last October as being an effective treatment for African sleeping sickness, a disease similar in many ways to AIDS, is being pre-pared for "large-scale trials at medical centers," according to Dr. Samuel Broder of the National Cancer Institute.

A second drug, ribavarin, has been successful in test tube studies in blocking the growth of the HTLV-3 virus. Developed by Dr. Robert For-thal of the Centers for Disease Control, ribavirin has already been tested in pa-tients with other diseases and may be available to be used on AIDS patients rela-

Other drugs, researchers say, have been used to slow down the AIDS virus but do not eliminate it. It is hoped that these two newer drugs will.

AIDS Insurance

SANTA MONICA, CA --Fifty people in California have purchased "AIDS insurance" only two days after the state insurance commis-

sion approved it. According Hepatitis-B Spreads Marrow Biopsies The Weekly News (Miami), most of the Coastal Insurance Company's the AIDS insurance policies were purchased by people in the Los Angeles, San Francisco and San Diego areas, the state's three most populous cities. Yearly premiums are \$194, and the policy will pay a person who develops AIDS up to \$73,000 in the first year, including \$100 a day for the first 60 days of hospitalization, \$150 a day for the next 60 days and \$200 a day from the 121st day on. It also includes provisions for \$5,000 a year for therapy and treatment either in or out of the hospital. The policy is not available to anyone already diagnosed with the disease.

Most states have authorized policies covering astrophic illnesses" heart disease or cancer which may cover AIDS.

Fired Because of AIDS?

WASHINGTON, DC -- The Office of Human Rights is investigating whether private firms and government agencies can legally dismiss employees who are tested positive to an AIDS

exposure test.

National Institutes of Health (NIH) officials say, "There is no evidence to indicate that a person who tests positive for the HTLV-3 agent will develop AIDS." However, Gay leaders are encouraging men not to participate in research projects or take the test voluntarily until the questions of confidentiality have been resolved. Health officials have maintained that their confidentiality is absolute. Health and Human Services Secretary Margaret Heckler, gave enthus-iastic support to regula-tions designed to guarantee privacy and confidentiality. It was her first time meeting with Gay leaders.

Despite Vaccine

Despite the availability of a vaccine to immunize against hepatitis-B, an infectious viral disease that can result in liver damage and early death, reported cases continue to rise, especially among the high-risk Gay male group.

According to Dr. James O. Mason, director of the federal Centers for Disease Control, the low levels of immunization center on concerns about safety, cost and an ignorance of the potential dangers of hepatitis.

The vaccine was developed using Gay-donated blood and manufacturers are quick to point out that there is no possibility that a live AIDS virus could survive the manufacturing process and there-fore there is no possibility of contracting AIDS by taking the vaccine.

Merke, Sharp and Dohme, Inc., which developed the vaccine, says the \$100+ price tag for the three in-noculations reflects the high cost of development and production of the vaccine.

Many insurance companies
will not pay for the vac-

Last year 200,000 cases of hepatitis-B were reported.

May Diagnose AIDS

USA Today reports that bone marrow biopsies may be an inexpensive test to diag-nose AIDS. A study reported in the February edition of Archives of Pathology and Laboratory Medicine says that researchers compared biopsies from 30 AIDS pa-tients which showed similar characteristics in 86% of the specimens.

Delta Backs Down

According to the Associated Press, Delta Airlines was considering barring AIDS victims from its AIDS victims from its flights fearing both possible infection as well as adcustomer reaction. The airline backed off, how-ever, when medical evidence showed it was unwarranted.

Airline spokesperson William Berry said the concern about AIDS started when a passenger, who identified himself as an AIDS patient, called the airline and asked for extra space to rest because of his illness.



Dr. Swinger To Speak At AIDS **Committee Meeting**

The only person who personally knows all of the AIDS patients in Tennessee will answer questions from the Gay community about AIDS March 10.

Dr. Gary Swinger, state epidemiologist assigned to the Communicable Disease Control unit of the state health department will provide the latest statistics and information about AIDS.

Dr. Swinger "just happened to be in town" when ATEAC was formed. He says it was a coincidence that he happened to be in town on that day. "I only heard about the

meeting the day before," he

If it was a coincidence, it was a fortunate one says Tommy Stewart, president of ATEAC. "Dr. Swinger has been instrumental in our formation. His encouragement and help has encouraged us to make important contacts within the health department both on the local and state levels. He's opened doors for us that probably we wouldn't have opened on our own."

According to Swinger, it was a classic case of being

Gay Lovers On Trial In Wall Street Journal Case

by Morgan Pinney The importance of Gay relationships is figuring prominently in one of the most closely watched trials now taking place in America. R. Foster Winans, a former columnist for the Wall Street Journal, and his lover David Carpenter are being prosecuted by the U.S. government along with another man, Kenneth Feliz, for trading stocks on the basis of pre-publication in-formation "leaked" by Win-ans. The court is being told that Carpenter's participation was due solely to his "spousal relationship" with

Winans. The trial is receiving intense media attention be-cause it represents the first time the government has tried to prosecute a journalist for "insider trad-

ing."
Winans is not being prosecuted for stealing informa-tion from the Wall Street Journal. Rather, he is being prosecuted for using that information to trade in stocks. Such "fraudulent" trading in a company's stock is illegal for those who are privy to information about that company before it is made public. Winans asserts that he was not an "insider" but rather an outsider who gathered public information and then wrote about it in his column. He did, how-ever, "leak" the topics of some of those columns to a few people in advance of publication day, enabling them to profit from the often dramatic changes in a stock's prices once it was mentioned in print.

He is charged with de-frauding the Wall Street Journal in violation of the Securities and Exchange Act of 1934. While he has contessed to all the basic facts in the case long ago, he strenuously denies that he broke any securities laws. Furthermore, Winan's

The lawyers for David Carpenter are basing his de-fense squarely on his posi-tion as Winan's lover. They say that he was not a coconspirator, as the govern-ment contends, but rather a "spouse" who did not plan the leaks or the stock trading, even though he acted as a courier between the parties and received payments made out in his name.

It's a novel legal approach according to Leonard Graff of National Gay Rights Advocates in San Francisco. Tim Sweeny, Executive Director of Lambda Legal Defense in New York says, "We find this defense very innovative, creative --and unprecedented. We are following the case with great interest." Gay rights lawyers have long sought to expand court recognition of Gay relationships -- with mixed results. For example, they have never gotten the courts to grant spousal immunity to Gay people. Under this concept, married heterosexual couples, even common law spouses, cannot be compelled to testify

against each other.
At first blush, it might appear Carpenter is trying to distance himself from Winans. But Carpenter's attorney, Jed Rakoff, points out there is no conflict between the testimony of Winans and Carpenter. The truth is that Winans made all the arrangements to feed pre-publication tips stockbroker Peter while they strolled alone on a Long Island golf course one day in the fall of 1983. Carpenter entered the picture later only because he was Winan's lover.

Winans sought Carpenter's assistance and compassion as any man might ask these things of a spouse. The two men wear wedding rings and sit closely together in the court room. Their relationship is referred to frequent ship is referred to frequentlaws. Several recent articles throughout the Gay press have voiced a concern for moral and ethical issues concerning Gay people and our sexual practices. Some have been a recasting of old legalism and others a criticism of our lack of concern for responsible sexual behavior. Therefore, I am writing to open a new dialogue

on this crucial issue.

It must be said, loud and clear, that the traditional values which we have used to define sexual behavior have sought to restrict and contain sexuality rather than allow individuals to experience the diverse and changing nature of their sexual experience. We have been raised in a SEX NEGATIVE environment which has produced values and moral codes that cannot serve the needs of our homosexual experi-

forces old fears regarding sexuality in general. Modern Gay couples cannot adopt the laws of their parents regarding sexual behavior. The problem with the entire question is that we do not have a sexual ethic. As much as we think we might have one, it is clear that we do not. What we have is a procreation ethic which pretends to be a sexual ethic. Our views of sex have been formed by a social and religious system which has attempted to value sex which leads to procreation and devalues all other forms of sex. Such a system is bankrupt and cannot speak to the Gay and Lesbian experience. Indeed, it does not speak adequately to heterosexual experience. Therefore, it cannot provide guid-ance to Gay singles or couples regarding their sexual relationships. To seek to offer traditional models of relationship to Gay people I cannot help but feel is to attempt to wear that the current discussion clothes which are not design-

Gay people cannot simply reproduce the models their parents' relati relationships. To attempt such a thing only leads to frustration and confusion. Symbols of relationship which are designed to affirm heterosex-ual values serve to denigrate homosexual reality. When Gay people try to fit into this system, we end up denying our own reality.

The moral discussion always seems to center around sexual behavior. Let me offer the following guide-lines which are an attempt to define the boundaries of sexual relationship, not the content of our behavior. A sexual ethic must:

1. Permit sexual diversi-

2. Allow for varied sexual identities and behavior. 3. Preserve mutuality and

consent between persons. 4. Enable growth toward maturity and freedom to

change one's behavior.
5. Recognize the stages of rebellion and experimentation in sexual behavior as normative.

6. Give positive value to

sex. 7. Give positive value to people.

8. Acknowledge the sex-negative components of traditional social and religious

values.
It is the role of Gay clergy to lead the way and seek to forge a sexual ethic where none now exists. It is our hope for the future that we as Gay and Lesbian people can provide the much needed critique of society's present ethics. Standing outside the institution of marriage, with its goals to contain and restrict sexual behavior, we are given a pro-phetic role which can ultimately restore non-Gay relationships as well as our own. Gay clergy cannot simply create a Gay version of the mainline churches. To do so is to oppress ourselves and to neglect the call to give our gifts to continued on page 14

God Has Not Abandoned Us

No matter what you have been told, there is no condemnation in Scripture for us as Gays and Lesbians. We as Gay and Lesbian Christians are often alienated because of our faith by those of the Gay community who, cause of our faith by those of the Gay community who, for whatever reason, have rejected Christianity, and by other "Chrisitians" because of our Gayness. To this we, as Gay and Lesbian Christians, wish to help our brothers and sisters who are Gay to realize that just because some "TV evangelist" hurls isolated Scripture verses at you as if they were hurling stones, does not mean you must give up God and what He wants for your life. To our "straight" Chrisitian brothers and sisters, there is little we can say that Jesus has not already said. First, discover the meaning of a passage to the original reader. Second, out of this, seek to draw a universal principle which is not limited to the particular time and place of any one reader. Third, based on that, find the present specific application of the universal principle. universal principle.

Carpenter and Winans very quickly went to the Securities and Exchange Commission investigators and told all the details which are now being used against them in court. Brant admits that he tried to get them to deny everything, even having Car-penter prepare phony in-voices for "decorating serthe vices" to disguise payments Brant made him. Brant was shocked to find that the payments had been deposited to a joint bank account which Winans Carpenter maintained and like a married couple. 

Gays And The Jewish **Tradition**

[The following article presents highlights of a sermon given in September 1984 by Rabbi Janet Marder, spiritual leader of Beth Chayim Chadashim, Los Angeles, reprinted from DIGEST, the newsletter of the World Congress of Gay & Lesbian Jewish Organizations.]

Is homosexuality against our religion? Is it against God? Does the Bible speak against it?

There are people who believe that the Bible does have some good things to say about homosexual relation-ships. I am not one of them. My study of the Bible leads me to only one conclusion: whenever the Bible explicitly takes up the subject of homosexual acts, it denounces them clearly and unequivocally The Bible does approve of loving friendship, which is the way I view the relation-ships between Ruth and David Naomi and

Jonathan.
But of course there is no way of knowing for sure anything about the sex lives of Biblical characters. And in fact it doesn't matter. What does matter is that Jewish law -- Biblical, Talmudic, medieval and modern -- has always been absolutely clear in its denunciation of homosexuality. And this conclusion -- that Jewish law rejects homosexuality -- is held by every reputable Jewish scholar today regardless of their per-sonal views of homosexual-

What then, are we doing here? How can this congregation exist? Is it some kind of joke? Or, worse, is it, as some think, an organization of sinners who band together explicitly to violate God's law.

Yes, the Bible speaks against homosexuality -- and so do the Talmud and later Jewish texts.

But no, homosexuality is not against our religion.

And most imporant: No,
God is not against homosexuality. In other words, I accept the fact that Jewish law and Jewish tradition con-demn homosexuality. But I disagree. I think the Bible generations of rabbis who have viewed homosexual-

ity as sinful are wrong.

I want to convince you tonight that my acceptance of
homosexuality as a Reform

come from a flippant disregard of Torah. I don't reject the prohibition of homosexuality because it's uncomfortable or inconven-

I take Jewish texts seriously. And I do believe that God gave Torah -- which means "teaching" -to Israel. What makes me a Reform Jew is this: I don't believe God gave "The Torah" to Israel. That is, I don't believe that God dictated the Five Books, word for word, to Moses. I believe that human beings, reaching towards God, created the Torah. Some of those human beings were spiritual geniuses who spiritual geniuses who apprehended divinity. And so divinity is reflected in the Torah. But the Torah also reflects human fears, human flaws, human limitations.

Now the big question facing any liberal Jew is this: who is to decide which parts of the Torah reflect divinity and deserve our love and reverent obedience, and which parts do not a series of the torate deserve our love and reverent obedience. and which parts do not? And the answer is: I decide. And you decide. It's a decision each one of us has to make for ourself. What gives us the right to do that? Well, here is the second thing that makes me a Reform Jew. I believe that Torah — Codly teaching — continues Godly teaching -- continues to be given in every gener-ation. It goes on today, when we observe the world, when we observe the world, think about it, study, ask questions, talk with one another. A person with a questing mind, a questing spirit, can receive Torah today. In other words, as a Reform Jew, I respect the operation of human intelligence. I respect the human freedom to make moral freedom to make moral choices. And so, for a Reform Jew, the final authority must always be the individual human conscience. As a Reform Jew, I respect the right of all Jews to interpret the Torah according to the dictates of their own conscience, and to act in accordance with their beliefs. Some people are lazy or Jewishly ignorant, and I may not think much of their choices. I may not think they have a true idea of Torah. They may think the same about my idea of Torah. As far as I'm conthe "best Jew is the one which makes Reform thoughtful choices based on

study and reflection.

been Hermann Cohen, the great 19th century philosopher of Judaism. Cohen be-lieved that the essence of Judiasm was its ethical teachings. And he asserted teachings. And he asserted that whenever a Jewish law conflicts with Jewish ethics, it must be rejected. He gives an example: the Talmudic teaching that one may violate the Sabbath in order to save the life of a Jew -- but not that of a Jew -- but not that of a Gentile. Cohen says that this law contradicts Jewish ethical teaching about the unity of humankind, and is therefore unacceptable.

This is how I view the Jewish legal prohibition against homosexuality. It is not merely an "uncomfor-table" or "inconvenient" law. It is an unethical law, not consistent with the ethical values that are re-

(located in the rear of Jackie's)

iterated over and over again in our texts. Ideas like: All men and women are made in the divine image, which entitles all to be treated with dignity. God loves all created beings. Jews are commanded to love and protect the stranger, the one who is vulnerable, the one who is different. To sin is to make a free choice to desecrate the image of God in ourselves or in others. I believe that these ideas reflect divinity. They are, as it were, God's word and God's law. But a law that says the homosexual is an abomination and deserves to abomination and deserves to does not reflect divinity. In fact, as far as I'm concerned, calling such a law the word of God is a kind of blasphemy -- a smear on God's name.

Our religion, our essential and eternal religious values, are not against homosexuality. Judaism stands for loving respectful and responsible human relationships -- wherever and between whomever they occur.
