### Oral Alpha Interferon Effective in Kenya; U.S. Trials Underway

According to an article in the Bay Area Reporter, reports have come from Kenya indicating that small quantities of Alpha Interferon administered orally have been successful in putting AIDS symptoms into remission. Scientists remain skeptical but are keeping an open mind.

Dr. Davy K. Koech, director of the Kenyan Medical Research Institute in Nairobi has been treating PWAs with wafers of Alpha Interferon about 100-200 units in strength. The patients dissolve the wafers in their mouth. According to Dr. Koech signs of remission can be seen

within days. At the end of eight weeks, AIDS symptoms have completely disappeared and the white blood cell count has increased dramatically.

To U.S. researchers who have been treating PWAs with millions of units of Alpha Interferon administered intravenously, with little or no success, the results are baffling. Some theories have been put forth but no solid reasons have yet been found for the difference in results between the two methods of administration. Testing of the theory will be conducted in experiments at Mount Sinai

Medical Center in New York City. Some results should be available in two months.

In the meantime, doctors are reluctant to discourage patients from trying to take the alpha interferon orally. The drug is non-toxic in the amounts used and it can't hurt them. Maybe it can help.

In the U.S., Alpha Interferon administered intravenously is approved for treatment of Kaposi's sarcoma, genital warts, and one form of leukemia. Research has shown potential benefits for treating patients with chronic active hepatitis B.

## PWA Issues Highlighted in Telecast from San Francisco AIDS Conference

The Chicago-based Physicians Association for AIDS Care (PAAC) released the programming schedule for their landmark 25-hour telecast from the 6th International AIDS Conference on June 21, 22, and 23. In addition to approximately 2-1/2 hours each day of conference news, interviews, and speeches, PAAC is launching its National AIDS Education Initiative. This initiative includes 12 hours of programming on current treatment options for the major AIDS-related diseases, as well as social, financial, and ethical issues raised by the epidemic.

According to Gordon Nary, PAAC's executive director, "This telecast is the most important AIDS educational event since the epidemic began. It will provide physicians, nurses, and other caregivers and persons with HIV (AIDS) virus with the most current information on the management of HIV infection and its opportunistic diseases."

Nary also pointed out that "The telecast integrates critical issues of importance to the PWA (Person With AIDS) commu-

nity such as reimbursement, quality of life, and patient education. PAAC's unique interdisciplinary approach to this epidemic is reflected in such diverse topics as a roundtable discussion of the impact of HIV infection on professional liability insurance; ethical issues in accessing clinical trials by women, children, and people of color; and pastoral care."

The telecast will be provided as a public service to any institution with satellite reception capabilities, cable stations, and persons with home satellite dishes. While hospitals and educational institutions will not be charged a fee, PAAC is requesting that cable companies and individuals registering for the program make a donation to defray PAAC's costs.

Brochures detailing the program schedule, featured speakers and registration information are now available from PAAC. All institutions registering for the telecast must agree to provide a demographic report on viewers. Because of staff limitations, Nary requested that

# Wildmon Sued for Copyright Infringement

According to USA Today, Artist David Wojnarowicz is suing Mississippi-based Rev. Donald Wildmon and his American Family Association for including photos of his artworks in a mass mailing aimed at raising funds against pomography. The \$1 million suit accuses Wildmon and the association of copyright infringement and libel. The mass mailing allegedly contained details of sexual images from Wojnarowicz's paintings under the headline, "Your Tax Dollars Helped Pay for These 'Works of Art." Wojnarowicz alleges the mailing portrayed the works out of context.

Maybe — just maybe -more people will get involved

in the events. And maybe more people will be aware of the fact that we are celebrating Gay Pride.

As I look back on the last ten years, I can see the changes the Memphis Gay Coalition has gone through. I regret some of those changes weren't for the better. I remembermy first years with the Coalition. Although I wasn't there at the very beginning, when I did get involved, the Coalition was very active and very political. There were marches down Cooper Street followed by political rallies at the Overton Park Shell. When I came away from those events, I felt Gay and Proud. It was inspirational. But even then, people hid behind various banners to conceal the fact that they were Gay.

In those early days, everything had to be "politically correct." We had to use the "correct" phrases, the "correct" terms, and the "correct" names for everything. With all the nitpicking and posturing, it was only natural that problems would develop. That was coupled with personal agendas that became more important then the overall good of the organization.

I guess the first rift came with the Blacks. Perceiving the Coalition as not serving their needs or addressing their problems, they split off to form a Black organization. That organization became even more tightly focused on interracial couples. The radical feminists broke off later focusing their efforts on N.O.W.'s Lesbian Task Force.

Now don't get me wrong. The organizations I speak of do good work and I wouldn't begin to criticize them. The point I'm making is that these people complained about the Coalition being too narrowly focused. They left to form or join an organization that was just as narrowly focused, only in a different direction. The mistake here is that each of the three segments has less impact and less effectiveness then the three segments working together would have had.

Along with all this breaking-

away, the number of people participating in the marches became smaller and smaller until the marches became more of an embarrassment than a statement of strength and pride. The thing that stills irks me the most about this are the people who travel to San Francisco or even to Nashville to participate in their celebrations. They come back and rave about how great it was. And isn't it too bad we can't do that here?

Well we could if they would stay home and participate in our march. But here somebody might recognize them. Is it really Gay Pride when you lose yourself in a crowd of thousands in a city where even if your face is featured prominently on the evening news, no one will know you?

So over the years, the Coalition became less and less political. Part of it was through the loss of people associated with political and/or civil rights organizations such as the ACLU. Part of it was through a concentrated effort to appear less "radical" to potential new members. But certain things remain non-negotiable. The Coalition retains its ability to be a political organization. It continues to meet monthly at the public library as a "political statement." It continues to sponsor and support Gay Pride events. It continues to try to work for all Gay men and Lesbians. And it is still open to all Gay men and Lesbians.

So what is Gay Pride these

days? And is political activism I have to admit that things are no still alive?

Well as far as political activism goes, a few years ago some people tried to form a political action committee. While it was still in the formative stages, voices from the Coalition's own "politically correct" past introduced requirements of racially and sexually balancing the group, requiring co-chairs, and other things to make it "politically correct." The end result was, the organization floundered and vanished into oblivion. (I think it still resides in a cardboard box at Vincent Astor's house.)

This points out the two opposing views on the subject of organizations. First, there is the view that it is better not to even have an organization then to have one that is not racially and sexually balanced. The other view, my personal view, is that you can't force that balance. It has to happen because people care and want to be involved in the organization. If you elect or appoint people just to make a quota, unless those people really care about being involved, they simply become dead weight.

So to answer the question, Gay activism is still alive. It is just sitting back waiting for people to get over their petty bickering and start pulling together for the good of all.

As for Gay Pride — well that's a more difficult question. At one point, everything was very plain to me. In all honesty,

longer black and white but only "Shades of Grey." Do we jump on every song lyric, every comedian that cracks a Gay joke, and every person that makes a disparaging remark? Or do we conserve our energy and choose our battles? Do we proudly put Memphis Gay and Lesbian Community Center in big bold letters on the front window and risk someone breaking in and trashing the place? Or do we put only the letters on the front window and quietly conduct our business hoping to go unnoticed? In the names we choose for ourselves, do we proudly proclaim that we are Gay and Lesbian? Or do we hide behind symbols that we know mean "Gay" but which hide that fact from non-Gays? Do we speak to the media and other people about our feelings, our rights, and our needs? Or do we sit back and wait for someone else to come forward? Do we wait for someone else to do something?

Well, maybe things are clearerthan I thought. Gay Pride is on the closet shelf because we prefer to take the easy way the safe way. I guess we can take it down and wear it again when we get ready to take some chances. We can wear it again when we decide to take charge of our lives and make things happen for ourselves. We can wear it when we decide to stop being afraid. Won't that be a great day?!


I had called earlier in the day and was able to access a list of local bars from the answering machine. In my experience this was unique and definitely a

## NGLTF Pressure Forces Change Hate Crimes Hotline **Disconnects Gays**

Washington, DC—A national hate crimes "hotline," set

Although the up to collect information on crimes of bias but which originally refused to take "Gay bashings" and religious-related reports, is now tracking such crimes following pressure from the National Gay and Lesbian Task Force (NGLTF).

The Toll-free hotline, 1-800-347-HATE, was announced by Pres. Bush in Apr. 23 at the White House signing of the Federal Hate Crimes Statistics Act. The hotline is operated by the U.S. Dept of Justice (DOJ) Community Relations Service and was established to help the DOJ mediate and conciliate incidents of hate violence (see story on page 16.)

During the ceremony, Bush explained that the Hate Crimes Statistics Act orders the attorney general to collect information on "crimes motivated by religion, race, ethnicity, or sex-

Although the hotline was not mandated by the Hate Crimes bill, at the signing ceremony Bush said, "I am also pleased to announce that today the Department of Justice has established a new toll-free phone number for reporting complaints of these hate crimes."

Gay and Lesbian activists were stunned to discover, upon calling the hotline, that operators would not take information on anti-Gay and Lesbian hate crimes. Robert Bray, NGLTF public information director, called the number to test it and was told to call—at phone toll rates—the DOJ civil rights office. That office instructed Bray to call the DOJ criminal section. which told him to "write a letter" describing his case.

NGLTF then contacted Gay and Lesbian activists to "swamp" the hotline, and notified Rep. Barney Frank and

Gerry Studds and Sen. Paul Simon of the problem. The lawmakers contacted DOJ officials to pressure them to include anti-Gay and Lesbian hate

DOJ officials claimed that because sexual orientation is not included in the Civil Rights Act of 1964, the department was not "mandated" to collect such information.

However, following intense pressure from NGLTF and other members of the hate crimes coalition, including the Anti-Defamation League and People For the American Way, the DOJ agreed to add sexual orientation to the hate crimes hotline and track such incidents on DOJ hotline reports.

Furthermore, DOJ officials met with Kevin Berrill, NGLTF anti-violence project director, and Peri Jude Radecic, NGLTF legislative director, to discuss coverage of Gays and Lesbians in DOJ operations.

"We were outraged that the national hate crimes hotline was hanging up on survivors of anti-Gay attacks," said Radecic. "Victims of bashings were being further victimized by bureaucratic runaround. However, we are pleased the Justice Dept. moved quickly to fix the problem and open a dialogue with Gay and Lesbian activists."

### **HRCF Backs Harvey Gantt** In Helms Race

Washington, DC-The Human Rights Campaign Fund, the largest national Lesbian and Gay political organization, has contributed \$5,000 to Harvey Gantt, the former mayor of Charlotte, N.C., who is seeking the Democratic nomination to replace Jesse Helms (R-NC) in the U.S. Senate. The amount is the maximum contribution allowed by federal law in a primary.

"Harvey Gantt is a compassionate man who understands the importance of civil rights for all Americans," said Tim McFeeley, executive director of the HRCF "He has demonstrated his ability to serve and will make an effective and capable senator."

"Jesse Helms is a disgrace. The more the voters of North Carolina learn about him, the more questions they have about whether he represents their interests," McFeeley noted. "Helms spends his time fighting needed AIDS resources, censoring art and opposing choice," McFeeley stated. "His bigotry against Lesbian and Gay Americans has no place in the U.S. Senate," he continued.

Helms was successful in keeping the recently passed Hate Crimes Statistics Act off the Senate Floor for three years.

When the bill eventually was considered by the senate, he offered an anti-Lesbian and Gay amendment which was rejected 77-19, following extensive lobbying by HRCF and other national organizations.

Helms is the author of the notorious "not promote or encourage" amendment which was designed to weaken AIDS prevention materials aimed at Gay and bi-sexual men. The Senate has refused to accept his amendment in the last few years.

In recent weeks, Gantt has stepped up his attacks against Helms on issues of concern to the Lesbian and Gay community. He accused Helms of appealing to people's emotions, rather than addressing the nations real problems.

Helms "is going to decide what art is good and what art is bad [and] is going to decide about people whose sexual orientation is 'normal.' He is going to get back on the issue of what is good and what is evil in American society"


Gantt, an African American, "represents the best of what North Carolina can offer the nation, independence and vision, not the ignorance, bigotry and hate that Jesse Helms embodies," McFeeley stated.

#### High Tech Gays to Boycott Int'l AIDS Conference

San Jose, CA—High Tech Gays (HTG), the nations largest organization of Gay and Lesbian professionals in the high tech industries, has voted to support the boycott of the 6th International AIDS Conference being held in San Francisco in June.

The boycoit will be effective unless the U.S. government alters its immigration policies to allow Gay men and Lesbians and persons with AIDS or HIV infection to freely enter the U.S. and attend the Conference. Current U.S. law prohibits such persons' entry. HTG has asked its more than 700 members to write to their Congressional representatives to have the discriminatory policies changed.

"The majority of High Tech Gays' members are scientists, engineers, and other technical professionals who must have access to full and freely exchanged information. This conference is violating this tenet of free information flow by denying entry to Gay men and Lesbians and people with AIDS and HIV and is, besides, morally reprehensible" said Rick Rudy, president of High Tech Gays and a Board Member of the National Gay and Lesbian Task Force. "A Conference that excludes those who can bring the necessary information cannot accomplish its tasks and HTG members find that unacceptable."

HTG joins more than 85 national and international organizations who are boycotting the AIDS Conference, including the National Gay and Lesbian Task Force.

## Lesbian Denied Employment by Dallas Police

New York, NY-Lambda Legal Defense and Education Fund announced the filing of a suit against the State of Texas, the City of Dallas, and the Chief of the Dallas Police Department for denying a Lesbian employment as a Dallas police officer, solely because of her sexual orientation. The DPD refuses to hire Lesbians and Gay men, and cites as a basis for its policy of discrimination Section 21.06 of the Texas Penal Code, which criminalizes certain "homosexual conduct." Lambda's lawsuit challenges the constitutionality of that law, which by its terms specifically discriminates against Gay people.

In March 1989, the plaintiff, Mica England, interviewed in her home town of Tulsa, Oklahoma for a position on the Dallas Police Force. At the time, a recruiter told her that her being a Lesbian would not be a bar to employment, and encouraged her to come to Dallas. Based on that assurance, Ms. England traveled to Dallas to complete interviews. There, Ms. England was subjected to intrusive questioning about her personal life and private sexual activity, and was not permitted to complete the application process because of her statement that she is a Lesbian. Police Chief Mack Vines told Ms. England that the DPD "doesn't hire Gays."

"The use of the Texas sodomy statute to justify discrimination in hiring by the government is a classic example of how these highly intrusive and stigmatizing laws hann Lesbians and Gay men, even when they themselves are not arrested or prosecuted for violating them," said Evan Wolfson, the Lambda staff attorney who represents Ms. England.

"The mere existence of these laws is used to justify all kinds of discrimination—from refusing to allow Gay people to adopt or keep custody of our kids, to

refusing to allow us to serve our country in the armed forces," said Wolfson.

Section 21.06, more commonly known as the Texas "sodomy" law, makes it a Class C Misdemeanor for adults to engage in consensual oral or anal intercourse with others of the same gender, even in the privacy of their own homes.

"Dallas is one of the few large cities in Texas where openly Gay people cannot work as police officers," noted William Waybourn, president of the Dallas Gay Alliance, a local advocacy group supporting England's case. "The Texas State Dept of Public Safety and the police departments of San Antonio and El Paso, to name just a few, all recognize that anti-Gay discrimination is unconstitutional, unfair, and counter-productive to the interests of the taxpayers who need the best officers they can get."

Aids Coalition and ATEAC.


The chapter is seeking volunteers to help in the making of quilt panels, at fund raisers, etc. Anyone interested in volunteering may call the chapter office at 725-0371.


"My number one goal is to work in as many benefits as possible for ATEAC and other charities," she says. "I want people to look at me and say that I represented Memphis in a

decent and professional manner. I plan a career in female impersonation and the Miss Gay Memphis title is the most important thing so far to encourage me."





"In addition to making the cards available to the stores that faithfully serve Lesbians' needs, we are offering Juicie Fruit to bookstores and card shops that may have never carried anything so unabashedly Lesbian before.

'The time will come when serving heterosexuals only will be as outmoded as a 'whitesonly' establishment." says Baker, "As Lesbians and Gay men, we can't afford to allow ourselves to be systematically excluded from any institution. As comical as it is, there are still some people who view our inclusion on a card rack as a threat."

Baker honed her irreverent brand of humor as a designer and greeting card writer at the Midwest's bastion of conservatism, Hallmark Cards. Seeing that Juicie Fruit wasn't likely to be a hot property at Hallmark, Baker quit and published the cards with the help of her "roommate" Colette Panchot, and two of their Lesbian friends. As a result, Pajama Party Press was bom. Like Hallmark Cards, Pajama Party Press is also based in Kansas City, MO.

The cards are light-hearted. They poke fun at everything from Lesbians' love of health food to our preference for comfortably sensible clothes. They are perfect for birthdays and thank-yous, friendship and love, and all those nebulous areas in between. They are printed in hot pink and black on glossy

## R F D—Sweet Sixteen

Personally, I have always felt that one of the most durable contributions the Gay movement has made is our literature. Where many newsletters and magazines have come and gone (and sometimes returned); I have here a story about a most unusual Gay journal which has lasted 16 years.

Rural Free Delivery? Radical Faerie Digest? Right Fine Dialogue? True to its own image and direction, the three letters R F D never mean the same thing twice. The three letters taken together mean "A Country Journal for Gay Men Everywhere." This magazine has appeared regularly for 61 issues (through several cross-country moves) and con-

It describes itself thus: "RFD is the only nationally distributed magazine that

tained the con-

tributions of

many people.

focuses on rural Gay men and related areas of human growth and consciousness. RFD explores the identity of Gay men, their history and contributions. Being a reader-written journal, it is an open forum for new ideas, radical views, and controversial issues."

"The philosophy of the journal is one which expounds a low-energy-consuming lifestyle and voluntary simplicity. Our readership maintains a high interest in alternative products, publications, services and real estate." The key word is alternative.

One must first understand the type of people who would publish, write for, and read such a magazine. This might conjure up thoughts of the 1960's movements of alternative lifestyle, of which the Gay rights movement is also a part. Since there have been Gay people, mostly Gay men in this case, there have been

Radical Faeries. They describe themselves as a network of very diverse "rural and urban dwellers who see Gays and Lesbians as a distinct and seperate People with our own culture, way of Becoming and spirituality." "We believe that as a People we have unique and necessary contributions to make. We join together with each other in mutual aid and love for play,

own imthree ver

work, self-discovery and nurturing."

Faeries find one another at gatherings and in sanctuaries. One sanctuary is located in Middle Tennessee, named Short Mountain. A Gathering is defined as a large coming together of people of like mind. The first national Faerie Gathering took place in 1979 and was called for by activist Harry Hay. Several regular gatherings take place each year, in several areas across the country (Short Mountain holds two). There are Gay and Lesbian gatherings and also mixed gatherings where the Gay attendees are welcome.

Alternative is redefined among Faeries. Some leave cities for the country. Some leave independent living for communal living. Some leave mainstream religion for older traditions—Wiccan, Native American, Buddhist—or a more nature oriented spirituality. A

common vision shared by Faeries is the sacredness of and respect for the earth and nature, hence the emphasis on rural life. These communities are a living outpost of the "caring for our own" attitude which was once such a necessary part of the closeted Gay life. A lot of mutual concern is found at gatherings and in these communities perhaps, a sense of family which Gay people in small groups used to have and may be slipping away. People here do actually care about and for one another. It's not easy, it takes work and willingness. It can, and does happen.

Therefore, it was natural that a journal to interconnect these individuals, couples and groups would arise. In 1974, the first issue was printed by a group of

men in Iowa City, Iowa. A local Gay/Lesbian outreach group helped

with resources
and funding and
RFD was born.
The first issue
was seen as a
lifeline for
many isolated
rural Gays and
a forum which
would be used
by those who
perhaps took
the concept of
alternative lifestyle beyond most

people's ken.
An article in one of
the earliest issues of
RFD interviewed a 70
year old Gay farmer who
lived in the country. He
had his own set of diffi-

culties but maintained his Gayness all of his life. The homespun quality has remained consistent for 16 years (quarterly, following the seasons) as the articles, topics and graphics, sometimes even the size and shape, change with each issue. As does the meaning of "R F D".

The journal was published for several years by Faeries in Wolf Creek, OR. Its home has moved several times, staying for about 10 years at Running Water, a commune near Bakersfield, NC. Some issues were put together at various locations then distributed out of New Orleans or Bakersfield. In the winter of 1989-90 the first issue was mailed from its present home at Short Mountain Sanctuary, near Liberty, Tennessee.

Though rural in flavor, RFD finds its way into hundreds of city mailboxes and bookstores. 2700 copies of each issue are printed, going to at least 1300

subscribers, some out of the country.

The table of contents rarely changes; there are always letters and a lunar calendar; there are useful and informative de-

partments such as Kitchen Queen (recipes) and Gardening; purely



literary departments (Essays, Poetry, Book Reviews); feature articles and humor. Important subjects such as AIDS, of course, and why there are so few Faeries of color are explored; there is a prison outreach, and articles from faraway places like China and nearaway places like Canada. Even the commercial ads are unusual.

These creative and unusual writings demonstrate a richness and variety in Gay thought. News stories and commentary prove that the Faerie movement is not insular, in fact, it is well aware and sometimes very involved. There is always a Faerie contingent and workshop at the

Southeastern Conference of Lesbians and Gay Men.

Without losing any of its original purpose or intent, RFD has also become a chronicle of Gay history, in times when these

chronicles exist with purpose. Its large variety of contributors keep it up-to-date and fresh. Readership

continues to grow and with it the notion that there is potential for a unique Gay/Lesbian culture that has little or nothing to do with discos, stereotypes or coastal trends. Something unique—just like the everchanging "R F D".

As this Faerie might say, "Really Faabulous, Dahling."





## Steps to a New Life After Losing Someone You Love

How can two people react so differently to breaking up? Tom and Steven had been dating for 5 years when they split up. Surprisingly, Tom adjusted to his new single status pretty quickly - within 2 months he began dating again. Steven, on the other hand, lost interest in everything around him - he couldn't eat, slept fitfully, and felt emotionally raw. Once, he called Tom's new apartment and hung up when his answeringmachine picked up. He cried, knowing he was out somewhere without him.

You might think that Tom is heartless or that Steve is over emotional; after all, neither one's behavior seems to fall within the boundaries of what society dictates as "acceptable" greiving. Researchers used to think there was a right and wrong way to react to loss, but new studies indicate that there is a much wider range of so-called "normal" reactions following a loss. There is a universal grieving process, but every individual experiences that process in his own way, in his own time.

The grieving process can be broken down into three (3)

Alternative AIDS Counseling and Testing Site Established

In an effort to reach more people who are considered to be at high risk for AIDS, or HIV infection, an alternative site to receive AIDS Counseling and Testing has been established as of May 3, 1990. In addition to the testing site at the Memphis and Shelby County Health Department, 814 Jefferson Ave., Counseling and Testing is now available at the Gay and Lesbian Community Center, 1291 Madison Ave. on Wednesday nights from 5:00 PM to 7:00 PM

Counseling and testing is provided by staff of the Memphis and Shelby County Health Department. According to Skip Coder, AIDS Counselor, of the Memphis and Shelby County Health Department, "One of our goals is to provide counseling and testing in an unbiased environment through extended hours to people who are unable to come during regular working hours." Coder says he hopes that this new location will provide education and service to more members of the target population.

Anonymous and/or confidential testing is available. There is no charge for the test. Please call 576-7866 between the hours of 8 AM-4:30 PM for an appointment.

## ATEAC Begins Food Pantry

The Aid to End AIDS Committee has been sanctioned as a food pantry outlet of the Memphis Food Bank. The effort was made in order to better serve some of ATEAC's clients who need emergency food assistance.

"In the past we've been using other food pantries, but it just meant that we had to send the client to another place," said Angie Dagastino, ATEAC Executive Director. "Now we can simply give them something immediately, and don't have to be dependent on the hours of other agencies," she said.

Currently, the ATEAC food pantry stocks basic items such as cereals, canned fruits and vegetables, beverages, and the like. A limited supply of household cleaning materials and personal items are also available. However, they would like to expand. A freezer would allow them to acquire frozen foods and other more perishable items

phases. And while everyone passes through these phases, we each experience them differently.

Phase 1: Impact

We've been conditioned to believe that we should feel tremendously sad, even depressed, right after a crisis, but that is not true for everyone. In fact, experts used to think that if you weren't extremely distressed after a major loss, it didn't look well for your future psychological well-being. A new study done by the University of Michigan found that between 1/4 and 2/3 of people who have lost a partner are not greatly distressed, yet are emotionally healthy. Likewise, the parameters of what is "normal" following a breakup have changed. It's not surprising if you get depressed after a breakup - but not everyone has to.

Phase 2: Observation

During this phase you begin to focus less on the break up itself and more on how you are reacting to it. Often during the Impact stage there is no detaching, no stepping back. In Observation, you begin to recognize what you've lost - not just the person, but your dreams for the future, and the direction in which you thought you were headed. A lot of people don't realize that this may be even more painful than the loss of the person. Surprisingly, many people need to spend a lot of time alone, reminiscing. Some people think your supposed to forget about the past - it's too painful. But rehashing everything about your relationship - the good and the bad - allows you to put it into perspective. This phase comes to an end when you are able to incorporate the past into the present and move into the fu-

Phase 3: Reconstruction

During this final stage, you begin to build a life and an identity that doesn't include your ex-lover. It's important to figure out how you can incorporate the values you held as a couple into your life as a single. For instance, if you and your lover used to swim together and enjoyed being fit, you could retain that value by taking up another

sport that you liked that also makes you feel good physically. Doing this will help you restructure your life. It's important to remember, though, that everyone moves through each phase at his or her own rate. Time may be the great healer, but there is no clock or calendar by which to measure your recovery. People who are greiving often find themselves under a subtle pressure to show more distress initially than they may feel and then to cheer up and get on with life long before they're ready. There is no universal prescription for coping with a loss - and we are just beginning to realize the full range of normal grief

If you are trying to take steps to a new life after losing someone you love, remember that your grieving reaction may be different from your partner's, but that makes it no less acceptable or genuine. Everyone moves through the above three phases, but we all do it in a different way and take different amounts of time. Give yourself a break, and allow yourself to beal

The Memphis Gay and Lesbian Community Center has just signed an agreement with the Memphis and Shelby County Health Department to provide HIV testing and counseling at the center. Signing the agreement along with the president of the center, were Mayor Bill Morris and other officials. This testing is part of the plan of the Health Department to reach out into the community. The agreement will last until July 1, at which time the effectiveness will be reviewed. Appointments can only be made by calling the Health Department at 576-7866.

The annual elections of the community center will be held at the monthly business meeting on June 16, 1990, at 11:30 AM. We are asking for all people interested in the center to come to the meeting, nominate, speak, and vote. Up for election are all officers and seven board members. Now that the center is running, a board seat involves only a few hours a month at the monthly meetings and a few hours throughout the year for various volunteer functions. These are not tasks which will overwhelm a person's time. Due to the efforts of the current board, staff, and contributing organizations, the workload is spread out among a large group.

The center is still in need of additional books for our library. ### Symbols of A Heritage...

As common as we sometimes think our symbols have become, we still hear Gays ask what the pink triangle or the lambda stand for. Because much of of our heritage and culture is represented by these symbols, we should certainly know what they mean.



The Lambda: The eleventh lower-case letter of the Greek alphabet, a symbol of justice, balance, freedom, equality, and unity, the lambda was adopted by the post-Stonewall Gay liberation movement as an international Gay rights symbol.



190 uThe Pink Triangle: A symbol sewn to the uniforms of Gays in Nazi Germany's concentration camps, the pink triangle was similar to the star of David worn by Jews. The number of Gays executed in Nazi Germany is unknown, but estimates range from 10,000 to 250,000. The pink triangle has since become an international symbol of the oppression of Gay and Lesbian people.

In addition to the geometric symbols, the color lavender has become a universally identifying symbol of what has come to be known as the "lavender culture." A mixture of blue and pink, the traditional "baby colors" of male and female, lavender represents the rejection by Gays of society's demands that we accept its role

models.



Most Mid South Congressmen Vote For the Act President Bush Signs Hate Crimes Statistics Act

On Monday afternoon, April 23, 1990, Pres. George Bush signed into law the Hate Crimes Statistics Act in a signing ceremony held in the Old Executive Office Building adjacent to the White House. The signing was attended by numerous members of Congress, civil rights leaders, and Gay rights leaders. The new law authorizes the Justice Department to tabulate and report crimes that are motivated by hatred or prejudice based on race, religion, ethnicity, or sexual orientation. The inclusion of hate crimes directed against Gay men and Lesbians sparked fierce debate in both the House and Senate.

While Gay rights advocates

generally hailed the new law as a milestone, the President carefully avoided using the "G" word in his prepared speech. Instead, President Bush emphasized the racial and ethnic aspects of the new law. His remarks are as follows:

"We join together to celebrate a significant step to help guarantee civil rights for every American with the passage, and now the signing, of the Hate Crimes Statistics Act. When I first heard that this bill had passed bothhouses of Congress, I though of a photograph in the news recently, and it's the plaza near a Montgomery, Alabama, church where Dr. Martin Luther King, Jr. preached during the '55 bus boycott. And, in that

plaza stands a new civil rights memorial inscribed with the names of 40 brave Americans who died in the civil rights struggle, each one the victim of a hate crime. And, on the memorial's wall, water cascades over the vow made by Dr. King on the steps of the Lincoln Memorial: 'We will not be satisfied until justice rolls down like water, and righteousness like amighty stream.' His pledge is just as powerful today. We will not be satisfied. Justice for all has been the historic mission of the civil rights movement, and it's a mission still to be fulfilled.

"Bigotry and hate, regrettably, still exist in this country, and hate breeds violence, threatening the security of our entire society. We must rid our communities of the poison we call prejudice, bias, and discrimination. And, that's why I'm signing into law today a measure to require the Attorney General to collect as much information as we can on crimes motivated by religion, race, ethnicity, or sexual orientation—the Hate Crimes Statistics Act.

"Now, one of the greatest obligations of this administra-

tion and of the Dept. of Justice is the guarantee of civil rights for all Americans. As I said in my State of the Union address, every one of us must confront and condemn racism, anti-Semitism, bigotry, and hate, not next week, not tomorrow, but right now—every single one of us—for hate crimes cannot be tolerated in a free society. We have vigorously prosecuted federal violations involving hate crimes. We will continue to do so.

"As we speak, 17 racist skinheads in Dallas are waiting to be sentenced by a federal court for conspiring to commit hate crimes against Jewish, Black, and Hispanic citizens. The mail bombings which killed a federal judge and a NAACP lawyer are being investigated tenaciously by federal authorities. We will not rest until the cowards who committed these senseless crimes are behind bars.

"We must work together to build an America of opportunity where every American is free, finally from discrimination. And, I will use this noble office, this bully-pulpit, if you will, to speak out against hate and discrimination everywhere it exists. Enacting this law today helps move us toward our dream—asociety blind to prejudice, a society open to all. Until we reach that day when the bigotry and hate of mail bombings, and the vandalisms of yeshivah schools, and the Catholic churches we've seen recently... we must remember: for America to continue to be a good place for any of us to live, it must be a good place for all of us to live.

Pres. Bush's signing of the Hate Crimes Statistics Act culminated 3 years of efforts by Gay activists. The bill was sent to him following passage by the House of Representatives on April 4 by an overwhelming vote of 402 to 18. With the exception of Arkansas Congressman John Hammerschmidt, all Mid South representatives favored the new law. (Rep. Ford of Memphis was absent for the vote.)

In the Senate vote earlier this year, four Senators opposed the bill, including Trent Lott of Mississippi. The Hate Crimes Statistics Act mandates gathering data on the following categories of crimes: homicide, manslaughter, rape, assault, arson, intimidation, and property crimes.

# Sodomy News From Across the States: "Sod Squad" Formed; Action in Oklahoma, Missouri, and Georgia

Washington—Sodomy law battles are being waged in several communities across the country as the National Gay and Lesbian Task Force (NGLTF) Privacy Project announced new initiatives for repealing the anti-Gay and Lesbian measures.

#### Sod Squad Forms, Seminar Slated For Atlanta

Sodomy law repeal activists came together at the Southeastern Conference for Lesbians and Gay Men last March in Raleigh, NC, to form a new "Sod Squad" aimed at organizing repeal efforts on the grassroots level. Fifteen activists from Florida, New Jersey, Virginia, Texas, Arkansas, North Carolina, Georgia, and the District of Columbia formed the squad, which was facilitated by Sue Hyde, NGLTF Privacy Project director.

Sod Squad members received sodomy reform training from the country's leading experts in an 11-workshop track. The track included subjects such as the impact of sodomy laws on AIDS prevention in the Southeast, criminal code recodification, state court challenges, legislative repeal, and statewide organizing. In a post-conference discussion, "Sod Squaders" enthusiastically endorsed reconvening the Squad at October's Lavender Law Conference and opening it to all interested Lesbian and Gay activists.

Incorporating and updating information from the Southeastern Conference, NGLTF's Hyde will organize a special one-day seminar on sodomy law reform to be held at the National Lesbian and Gay Law Association's Lavender Law II in Atlanta, GA, October 5-8, 1990. The one-day seminar on sodomy law reform will take place on Monday, October 8.

## Crimes Against Nature in Oklahoma

Gay and Lesbian activists in Oklahoma have launched the long process of changing that state's crime against nature law as the Oklahoma Recodification Committee agreed to draft a model "crimes against nature" statute that exempts all consenting adults in private.

Members of the Oklahoma Gay and Lesbian Political Caucus, along with NGLTF's Sue Hyde, provided considerable information and testimony on sodomy law reform to the Recodification Committee staff at the state's Crimes and Punishments Subcommittee meeting on sodomy repeal held in Guthrie, OK, in late March. Activists have targeted both houses of the Oklahoma legislature, which must approve changes to the sodomy law.

#### Missouri Sexual Misconduct

The Missouri sexual misconduct repeal bill was debated in that state's house and senate judiciary committees last March after lobbying, education, and media efforts by the St. Louis Privacy

Rights Education Project (PREP). Although the Missouri legislature did not vote on the repeal bill, PREP activists report only one person showed up to testify against it. The Missouri activists have laid important groundwork for a state-wide repeal effort and hope to move the bill through the next session, with broader support from activists in cities and towns throughout the state.

Coming Back For More In Georgia

Although the Georgia legislature rejected a bill to repeal the state sodomy law last February, sponsoring lawmakers have vowed to bring the bill back in 1991. Activists are poised to pick up the fight at the start of the session. Georgia is the home of the infamous *Bowers vs. Hardwick* anti-Gay Supreme Court sodomy ruling.

"It's been an extremely busy year for all of us working to rid ourselves of these insulting, intrusive, and archaic sodomy laws," said NGLTF's Hyde. "Starting with last January's demonstration for repeal in Atlanta, we've moved to Jefferson City, Raleigh, Oklahoma City, and elsewhere. The Task Force and activists across the nation have recommitted our movement to this important issue."






