Gays Protest Alleged Discrimination At Local Cracker Barrel

West Tennessee Gay rights activists demonstrated Oct. 13 and 20 at a restaurant that is part of a chain they charge has fired homosexual employees and vowed not to hire non-heterosexuals. The demonstrations were among several at Cracker Barrel restaurants around the country.

Cracker Barrel Country Store Inc., based in Tennessee, operates 110 restaurants mainly along interstates in the South. Cracker Barrel's Sycamore View location, the target of the protests, is one of several in the Memphis area.

On Oct. 13 about 30 demonstrators took up 18 of 81 tables by sitting at as many tables as possible and ordering only coffee or tea. The demonstration was organized by the newly-formed organization, LEGAL, but demonstrators came from several groups

LEGAL spokesperson Bret Taylor said, "When we were asked to leave, we know that we were successful by the management's own admission that we were disrupting trheir business." A local restrauanteur estimated that Cracker Barrel lost close to \$1,100 because of the occupied tables.

The Oct. 20 demonstration, organized by Memphis State's Students for Gay and Lesbian Awareness (GALA)

had fewer people, but took the more traditional approach of picketing. At least two network television stations carried stories of the GALA protest featuring Michael LaBonte of GALA.

In a January memo, Cracker Barrel executives wrote that employing people "whose sexual preferences fail to demonstrate normal heterosexual values" was against the chain's traditional family image and should be discontinued.

Critics say the memo also triggered the firing of at least 12 Gay workers.

"They say that they want to uphold traditional values, and they're not upholding traditional values by discriminating against people for any reason whatsoever," said George Frisbie, who said he was fired from a Florida restaurant. "Your ability to do a job (should be) the only reason that you're hired or fired.'

LaBonte complained that Cracker Barrel is even concerned with the "perception" of being Gay or Lesbian. He indicated that the company policy would allow the firing of an employee who was perceived as being Gay.

Protesters demanded the rehiring of the employees and enactment of a nondiscrimination policy.

Company executives, as usual, have declined to discuss the issue.

FDA Approves 2nd AIDS Drug

WASHINGTON (AP) - The Food and Drug Administration approved a second AIDS-fighting drug Oct. 9 despite lingering questions about its safety and effectiveness.

AIDS activists hailed the approval of didanosine, or ddi, as a milestone in the effort to get new drugs from the laboratory to patients. But some scientists said the FDA had set a dangerous precedent in its drug-approval process.

The approval was based on less scientific data than normally required, but FDA Commissioner David Kessler said that had to be balanced against the needs of dying PLWAs. "It is the victims of this dreaded disease who are uppermost on our minds," Kessler said.

Didanosine was approved to treat AIDS patients who don't respond to or can't tolerate AZT, the only other fully approved anti-AIDS drug. Both drugs act to slow progression of AIDS, but neither cures the disease and each can have serious side effects.

Dr. Anthony Fauci, head of the National Institute on Allergy and Infectious Diseases, said studies testing ddi's long-term safety and effectiveness were continuing. "There are still many unanswered questions," he said.

The drug was developed by the National Cancer Institute and has been licensed to Bristol-Myers Squibb Co., which will market it as Videx. Bristol-Myers said it had two programs to help people with limited resources get the drug.

The AIDS Action Council said the FDA had "sensitively balanced a strict scientific standard against the needs of people with no treatments for a lifethreatening illness."

But Dr. Deborah Cotton, a researcher at Boston's Beth Israel Hospital and a member of the FDA's advisory committee that recommended approval of ddi in July, said the benefit of making the drug available "is not balanced by the real loss we've created in credibility by peeking into clinical trials not yet concluded."

"The precedent we've set is a bad one," said Cotton, who voted against the recommendation to approve ddi. "We will see more drugs approved on the basis of very little data and we will have less ability to know how to choose among them or how to use them in combination."

In clinical trials where ddi was

tested on AIDS patients who didn't respond to or could not take AZT, ddi was shown to increase the number of white blood cells, called CD-4 cells, Those cells have been shown to be important to immune system function, which is weakened by AIDS.

We know this drug, ddi, affects CD-4 counts, and we know survival is tied to CD-4 counts," Kessler said. 'There is somewhat of a leap there, but patients are dying and we think that extrapolation makes a lot of sense and is in patients' interests."

Kessler said a "sense of urgency" characterized the testing and intensive review of the drug to speed its approval, and he said that would be a model for future reviews of some drugs, though not for all.

We can't muster for every drug what we mustered for ddi," Kessler said. "It has to be a life-saving drug."

The ddi approval was noteworthy, too, because it applies to adults as well as children, Kessler said. In the past, the FDA has usually approved drugs for adults before allowing their use in children.

The FDA based its decision on early findings of clinical trials involving more than 2,500 AIDS patients and an expanded access program that made the drug available to more than 22,000 people at no charge.

The 8,800 people still in the expanded access program will continue to get the drug at no cost for six to 10 weeks as the program winds down, the company said. For others, the drug will be commercially available within davs

Bristol-Myers said it will help people with limited resources get ddi either through insurance or Medicaid coverage, or by providing it at no cost to those who have no third-party coverage.

The government's licensing agreement requires Bristol-Myers to charge a "reasonable price" for the drug.

Bristol-Myers said its factory price for a year's supply of the most common dose, 400 milligrams per day, will be \$1,745. After markups, the price from retail pharmacies would be \$1,990. Company officials based that on a 14% markup they said was typical for AZT.

A year's course of the most common dose of AZT, 500 milligrams per day, costs \$2,190 wholesale. After a 14% markup, the retail price is close to \$2,500, though some markups drive the cost up to more than \$3,000.

The federal government will get 5% of sales of ddi under the agreement, Bristol-Myers officials said.

Agape New Life **Church Closes** Its Doors

Agape New Life Church, the oldest organized Gay and Lesbian church in Memphis has closed its doors.

The church board voted Oct. 6 to close the church because of a decline in attendance.

The board met on Oct. 20 to vote on dispersing the church's assets. Details were unavailable at press time, but it is believed that some of the assets will be given to local community organizations.

The church's most recent pastor, John Tolley, left this past spring to relocate with his lover in New Jersey. According to Kristie Elrod, until recently interim pastor, the church had been searching for a new minister and had a candidate. Elrod resigned her position as interim pastor in August because of illness in her family.

Tentative plans had also been made to rent space from Prescott Memorial Baptist Church and to move there. However, the board voted the close the church.

Agape New Life Church was founded by John Mark House and Bill Tracer in 1986 after the demise of the local Metropolitan Community Church. In 1988 the church moved to a space at 405 N. Cleveland, Suite 3. It remained the city's only Gay and Lesbian church until earlier this year.

LLDEF Responds to Study Linking Brain Structures to Sexual Orientation

In response to a study released by Science magazine suggesting male sexual orientation could be related to brain structure, Lambda Legal Defense and Education Fund welcomed honest scientific inquiry on issues regarding sexual orientation but cautioned against drawing conclusions about the preliminary findings.

First, as a matter of historical perspective, minority groups have often been the object of studies seeking to locate a biological explanation for difference. Most of these studies have been fully discredited. For example, the first "biology as sociology" re-search was conducted in the 19th Century on prisoners in Paris. Their head size and facial structures were studied to develop the "prototype" of the biological head of a criminal. Whether this preliminary study of the purported "biology" of homosexuality will eventually be confirmed is completely unclear. It is therefore probably prudent not to draw too many sweeping conclusions from the San Diego study.

Second, there are some methodological questions raised by the study. How is homosexuality or heterosexuality defined by the study? If Kinsey was right in finding that human sexuality is not fixed at the poles, but rather distributed across a broad continuum, does this affect the validity of Dr. LeVay's findings?

Third, all of the homosexual men studied in Dr. LeVay's study died of AIDS. It is now understood by medical specialists that HIV disease has a profound impact on the brain, although the degree to which we fully understand this impact is limited. Recent evidence suggests that HIV's effect on the brain may be even greater than originally thought. Until we know more about HIV's effect on the brain, it would seem prudent to hesitate before extrapolating to the general population data regarding the neurological characteristics of men with AIDS.

Furthermore, Lesbians were not studied in the survey. Not only does the study's failure to study sexual orientation in women merely reflect the medical and scientific community's historic failure to include women's issues in their work, but it means that Dr. LeVay's study only addressed one component of the concept of sexual orientation. The research thus exhibits the perpetuation of invisibility of women's and Lesbians' sexuality by the scientific community.

Notwithstanding these methodological questions, Dr. LeVay's findings are intriguing, from a purely scientific perspective. But it is important to remember that, regardless of whether homosexuality is biologically based or accelerated, a person's sexual orientation is an intrinsically private matter. Even if homosexuality were completely the product of free choice, there would still be no basis for criminal, coercive, or discriminatory penalties against same-sex orientation. And regardless of any biological basis for homosexuality, it is difficult to fathom on what moral, ethical, or religious basis one can reasonably discriminate against people who are sexually and emotionally oriented toward their own gender. Homosexuality, since it clearly occurs with a significant frequency and regularity in all cultures, is an orientation that is as "natural" as heterosexuality. This fact remains true whatever the "origins" of homosexuality.

Dr. LeVay's research, and other studies of its kind that may follow, does raise profound ethical issues that ought to be addressed. The history of this century, which has included the racial eugenics movement and Hitler's Germany, should make us wary of the uses to which such preliminary findings might be put by the unenlightened. A key historical and ethical lesson which our culture seems astonishingly hesitant to understand is that diversity is not a problem to be dealt with, but instead is one of the most beautiful characteristics of human existence. If research like Dr.

LeVay's assists in helping society understand the beauty of human difference, then it is to be welcomed. The Lesbian and Gay community, however, has no intention of watching such preliminary research become the putty for biological engineers who want to make homosexuality extinct.

Finally, we have to question why the media is so interested in this study and the origins of sexual orientation. During the past two decades, many more significant data have been available (e.g., statistics of violence against us, our lack of access to health care, the denial of benefits to same-sex partners, the denial of rights to care for and raise children, discrimination in the workplace); almost never has one of these issues reached the front page of the New York Times. We would propose one answer to the question: stories like this one of Dr. LeVay's preliminary findings do not require the media to treat us like subjects, like equal members of a greater community struggling for full participation and inclusion, but rather, they can continue to see us as objects whose deviance is fascinating like that of psychotic murderers or a newly discovered animal. A story of this nature merits space in the science section. The front page placement, the wire service response, the television coverage all suggest a sensational tidbit meant to grab a market share and not a serious interest in the lives and concerns of some members of our community.

Hey Health Department! Don't Make HIV Reportable by Name!

The following statement was read into the record of the public hearing held Oct. 17 at the Memphis/Shelby County Health Department. The hearing was one of three being held across the state pursuant to a change in Health Department rules making HIV test results reportable by name and instituting contact tracing for partners of HIV-infected people.

My name is Allen Cook. I am a member of the board of directors of the Aid to End AIDS Committee as well as publisher of the *Triangle Journal News*, a monthly newspaper for the Gay and Lesbian Community of Memphis.

It is with great concern that I view the elimination of anonymous HIV testing in Tennessee and the establishment of a list or "registry" of HIV positive individuals.

According to the "final plan" distributed to HIV/AIDS communitybased organizations on August 16, 1991, the purpose for making HIV reportable is "to help individuals and to promote disease intervention measures in a caring, sensitive manner." I submit that the elimination of anonymous testing will not accomplish this. Making HIV infection a reportable condition will only serve to keep people away from the testing process. If helping individuals and promoting disease intervention measures is in fact the rationale for making HIV reportable, I would submit that this is already being done through anonymous testing. I further submit that there are very few individuals who, upon learning they have a life-threatening disease, would not take it upon themselves to seek early intervention medical measures. And if they do not so choose, is it the intention of the Health Department to force people into treatment? I think not.

Given the suspicion that many people have about governmental incompetency and their fear of an accidental, if not purposeful, disclosure of this "list" at some point in the future, I submit it is far more "sensitive and caring" to maintain anonymous testing.

A second rationale in the "final plan" is that the Health Department believes that making HIV reportable will allow "more effective targeting of preventive educational resources." An analysis of the trends in new cases can tell us that already. The answer seems to us to target everyone. Create specific educational campaigns to all ages, sexes, and cultures. To do less, is to accept the notion that a) some people aren't worth worrying about or b) that some people are immune. In any case, this can be done without a "registry." The final plan also calls for contact tracing. While contact tracing may be fine for diseases with short incubation periods, there is no practical evidence that it will be beneficial in dealing with a disease like AIDS which may take 7-10 years to show symptoms.

Studies of systems which have attempted contact tracing for AIDS have found virtually NO useful information - only a tremendous waste of money. Contact tracing only works well when a cure is easily obtained and the spread stopped. I would also question the efficacy of contact tracing-at least in the Memphis area. If it's so good and works so well, why does Memphis have some of the highest numbers of syphilis and gonorrhea cases in the country? Why are the numbers not coming down? Years of contact tracing apparently have done little good.

Finally, in the absence of any legislative safeguards for the employment, housing, or other discrimination surrounding this condition, I urge the Health Department NOT to implement these new rules. Over the years, Health Department officials have repeatedly tried to tell local AIDS service organizations that they are the good guys and that we should get our constituencies to trust them. Just when we have begun changing people's attitudes about getting tested at all, they

Demonstrators March On California Capitol To Protest Gay-Rights Veto

SACRAMENTO (AP) — Thousands of Gay-rights protesters loudly sought political revenge with a Capitol demonstration against Gov. Pete Wilson's veto of an anti-discrimination bill.

Demonstrators blew whistles, waved anti-Wilson placards, burned flags, blocked traffic, threw paint balls, staged a kiss-in and chanted "Recall Pete" and "We won't go away." Late into the evening Oct. 11, hundreds milled in Capitol Park, some holding lighted candles.

Activists said the rally wasn't meant to change Wilson's mind, but make him regret his veto. The rally was held on National Coming Out Day, which is organized by pro-Gay groups that want to encourage homosexuals to make themselves known in their communities.

On Sept. 29, Wilson vetoed a bill that would have outlawed job discrimination based on sexual orientation, saying the measure would unduly burden employers with litigation. Gay rights activists have held protests almost daily since.

"It's the object, the goal of this community to try to make the governor pay the political price for what he's done to us," said San Francisco County Supervisor Roberta Achtenberg.

Police said about 4,000 people attended the protest on the Capitol steps. Rally organizers said there were 10,000 to 12,000 protesters, including many who traveled from Los Angeles and San Francisco.

Several shoving and shouting matches marred an otherwise nonviolent protest. Police said three people were arrested after some protesters threw dye-filled eggs, paint balls, glass soda bottles and Christmas ornaments on the Capitol steps and at officers. No injuries were reported.

More than 200 police officers ringed the Capitol. Police helicopters circled overhead.

Kurt Brown, 20, drove seven hours from West Hollywood for the demonstration. "This is something I really believe in," Brown said. "I don't believe in the violence, but I believe we should stand up for our rights."

"I haven't been to a demonstration in a long time, but with the way things are going in this country, I think it's important," said Patricia Byrne, 42, of Long Beach.

Demonstrators wore buttons with pink triangles and T-shirts with a circle and a slash over Wilson's name. Some men wore dresses, wigs, pancake makeup and mesh stockings.

A giant rainbow flag, a symbol of the Gay movement, was draped over the Capitol's west entrance.

Wilson worked in his office, un-

disturbed by the protest, said spokesman James Lee. "Obviously, we're not going to dignify any of those personal attacks with a response," Lee said.

In another development related to National Coming Out Day, Berkeley, Calif., began accepting applications Friday under a law that recognizes non-married couples — both homosexual and heterosexual — nationwide. The city pioneered a domestic partners law for city employees.

Vetoed Bill's Author Condemns Violence, 'Outing'

LOS ANGELES (AP) — The assemblyman whose Gay rights bill was vetoed by Gov. Pete Wilson called on activists to reject violent protest or the vengeful act of "outing" any of Wilson's staff who might be homosexual.

Assemblyman Terry Friedman, D-Los Angeles, vowed to introduce a new version of the vetoed AB101 in January to outlaw job discrimination against Gays and Lesbians.

Friedman said he understood the rage the bill's supporters felt after the veto, but he urged them to "heed the voice of reason."

They must avoid violence and the "despicable practice of outing, the public disclosure of homosexuality as has been threatened against members of the governor's staff," Friedman told a news conference. "That is a repugnant invasion of privacy and I deplore it," he said.

"Now is not the time for smashing windows, or blocking doors, or spilling blood or violence. Now is the time for calm and reason and abiding the law," Friedman said. "Ultimately, in our democracy, victory comes through the process of law. And it will come on this issue as well."

The veto "crystallized" the rage building in the community because of the AIDS crisis and attacks on homosexuals, said Michael Weinstein, president of the AIDS Healthcare Foundation in Los Angeles.

"We have yet to see the tip of the iceberg of anger that exists after 10 years of losses to AIDS and after 10 years of being bashed by religious fundamentalists," Weinstein said in an interview.

A Nov. 3 AIDS fundraiser previously planned for downtown Los Angeles is expected to turn into a major march against discrimination.





ACLU Sues Georgia Attorney General Over Lesbian Marriage Case

ATLANTA (AP) — The American Civil Liberties Union filed a sexand religious-discrimination suit against Georgia's attorney general Oct. 3 for revoking a job offer to a female attorney who married another woman.

ACLU lawyers charged Attorney General Michael Bowers illegally withdrew an employment offer to Robin Joy Shahar, 28, after learning she planned to participate in a Jewish marriage ceremony with another woman.

William B. Rubenstein, director of the ACLU's Lesbian and Gay Rights Project, said the action threatens religious liberty in Georgia.

"If Michael Bowers can fire Robin today because he doesn't like the marriage she engaged in, will he fire someone tomorrow because they don't sing loud enough or kneel deep enough in their particular religious practices?" he asked in a news conference.

Bowers responded later:

"The only issue is whether the state of Georgia recognizes homosexual marriages, and it doesn't. And I'm not going to hire someone who holds themself out to the public by their own admission as being engaged in a homosexual marriage."

Ms. Shahar is a 1991 graduate of Emory University Law School. Bowers and his staff have been banned from recruiting at the school because of the incident.

State law does not expressly prohibit homosexual marriage, but it officially acknowledges only heterosexual marriages. State law also prohibits sexual relations, generally called "sodomy," between members of the same sex.

Bowers defended the state's sodomy law in a case that led to a 1986 U.S. Supreme Court decision upholding it.

The suit contends Ms. Shahar worked for Bowers as a summer law clerk in 1990 between her second and third years of law school, and was given a written offer of employment that fall, contingent upon her completion of school and success with bar examinations.

She graduated sixth in a class of over 200 in June, and was told to report for work Sept. 23, according to the suit. Bowers withdrew the offer of employment in a letter dated July 9, citing "information ... (of) a purported marriage between you and another woman."

According to the suit, Ms. Shahar and her partner of nearly five years undertook a Jewish marriage ceremony July 28.

Ms. Shahar told reporters, "Fran and I chose to get married for the same reasons that any two people do ... we fell in love, we wanted to spend our lives together. ... We wanted to celebrate our love and our commitment

to each other surrounded by the people that we love and in accordance with our Jewish traditions."

She said she viewed the ceremony as a purely religious one with no significance under civil law.

Bowers said he doesn't ask prospective employees their sexual orientation, but discovered Ms. Shahar's when she "told us on her employment application that she was going to get married to a female."

The attorney general said he feared employing Ms. Shahar would indicate his tacit approval of homosexual marriages.

"If we are to have so significant a societal change ... we're not going to do it on the basis of an employment application as to which it might be said, 'Well, the Attorney General has tacitly approved this because here it is in his office."

The ACLU's Rubenstein agreed state law "does not ... recognize Lesbian and Gay marriages." But he added, "That does not mean that Robin is not entitled to engage in this religious ceremony, nor does it make

Atlanta Police Chief Denies Discriminating

ATLANTA (AP) — Police Chief Eldrin Bell said Oct. 2 his department is moving to end discrimination against Gays and Lesbians on the Atlanta police force and in the community.


Bell commented at a City Council Public Safety Committee hearing. He denied charges that the police department has been sloppy in reporting hate crimes and has done nothing to recruit Gay and Lesbian officer candidates.

"We do not now today nor have we ever discriminated against anyone," Bell said to derisive laughter from an audience that included many Gay and Lesbian activists at the meeting.

"It was absolute and total garbage. I'm so mad," Cathy Woolard of the ACLU Gay and Lesbian Police Advisory Board, said after the hearing ended. "The issue is, we've got concerns and he won't answer them."

Bell said he had not addressed the Gay community's concerns about recruitment, "because we are not doing any recruiting. Before we recruit we will consider that policy."

On the hate crimes issue, Bell said he now requires officers in the intelligence and records sections to hold "a face-to-face meeting" in developing the department's semiannual bias crimes report, which Gays say was replete with omissions and inaccuracies.

Bowers countered, "This wasn't represented to me as a religious thing. This was represented to me as a homosexual marriage — by her."

That, he said, is against the law, even if performed as a religious and not a civil rite.

The dean of Emory's law school disagreed.

"As far as I can determine, the laws of the state of Georgia don't say one way or another anything about homosexual marriages," said Dean Howard O. Hunter. "I think the laws are silent on that."

The attorney general's office joined the U.S. military as the only agencies refused admission to the law school for recruiting purposes, said law school spokeswoman Nancy Seideman. The military has a policy of denying admission to anyone who is homosexual.

The suit, filed in U.S. District Court, contends Bowers violated Ms. Shahar's rights to religious freedom, freedom of association and equal protection under the U.S. Constitution.

Donna Summer Files Libel Suit Against Magazine

LOS ANGELES (AP) — Singer Donna Summer filed a \$30 million libel lawsuit Oct. 1 against *New York* magazine. She said it falsely quoted her as once saying AIDS was a "divine ruling" against homosexuals.

"That is completely false. I did not say it. I do not believe it," Miss Summer said at a news conference to announce the Superior Court lawsuit.

New York magazine's Aug. 5 issue said Miss Summer, 42, a bornagain Christian for several years, once described homosexuals as "sinners" and said AIDS was "a divine ruling." The three-paragraph article gave no specifics on when or where she allegedly made the remarks.

The article, quoting a "music-industry insider" it didn't name, said Miss Summer decided against including on her new album a song that would serve as an apology to Gays for the comments.

The lawsuit also says the report about the song is false.

"The article in *New York* magazine hurts me deeply. It also hurts those people who read the article and believe it to be true," Miss Summer said.

Fran Kessler, assistant to the editor of the magazine, wouldn't comment and said the magazine had not been served with the lawsuit.

Attorney Elizabeth Mann, who represents the singer, said the article damaged prospects for Miss Summers' new Atlantic Records album, *Mistaken Identity*. The lawyer said some disc jockeys and clubs refuse to play the record because of the statements attributed to her.

Lesbian Couples Property Contract Questioned

ATLANTA — The Georgia Supreme Court has heard oral arguments on whether the joint property agreement of a Lesbian couple is legally enforceable under state law. The case, *Crooke v. Gilden*, is the first of its kind to be decided by the Georgia high court, and is one of only a handful of cases involving the enforceability of contract entered into by Lesbian and Gay couples.

The two women, Patricia Gagne Gilden and Florence Crooke, began their relationship in 1982. Shortly after Gilden moved into Crooke's home, they retained a lawyer to draft for them a joint ownership agreement setting forth terms of their ownership of the house and other personal property. The written agreement stipulated that Crooke would convey to Gilden a one-half-ownership interest in the house. In exchange, Gilden contributed money towards renovations on the house. The contract also stated that

When the couple ended their relationship in 1989, Gilden asked for her one-half share of the home and her equal share of the personal property. Crooke refused and Gilden filed an action asking the court to enforce the written agreement. In response to Gilden's lawsuit, Crooke, as a Lesbian, took the inexplicable position that the contract was unenforceable because of their Lesbian relationship, which violates the state's public policy and criminal laws.

The trial court accepted Crooke's arguments and refused to enforce the agreement on the grounds that the women entered into the contract "to facilitate a relationship which in Georgia is considered illegal and immoral." "It's, absurd that the trial court would impute some immoral purpose into this garden variety legal contract simply because the parties involved were Lesbians," stated Paula Ettelbrick, Legal Director for Lambda Legal Defense and Education Fund. "Since the law does not protect our relationships, it is absolutely imperative that we fight for the right to enforce our valid agreements."

Traditionally, courts have been reluctant to enforce "relationship agreements' between two unmarried people who live together on the theory that allowing unmarried couples to designate their own rights would denigrate the institution of marriage. The Georgia case is thought to be the first Lesbian couple contract enforcement case to go to a state's highest court.

"Despite the growing practice of drafting cohabitation or property agreements for Lesbian and Gay couples, there are many unanswered questions about whether the contracts are enforceable if one of the partners refuses to comply," said attorney Maria Gil de Lamadrid.

Students, Faculty Reject Code After Sexual Orientation Part Deleted

FORT WAYNE, Ind. (AP) — The student and faculty governing bodies at Indiana-Purdue at Fort Wayne have withdrawn their support for part of a new student code of rights after the words "sexual orientation" were deleted from a section dealing with discrimination and harassment.

The 18-member Student Government Association voted unanimously on Sept. 4 against the new wording, noting that it "strongly objects" to the change.

On Sept. 16, the Faculty Senate also voted to "reject the substance of the amendment and the manner in which it was made."

The IPFW Student Code of Rights, Responsibilities and Conduct includes paragraphs on discrimination and harassment and offering protection from such practices.

The IPFW code mentions race, religion, color, gender, age, national origin, ethnicity, handicap and status as a disabled or Vietnam-era veteran. Before approval, it also included the words "sexual orientation."

The Purdue board of trustees and President Steven Beering deleted the words on advice from their attorney, according to the student government resolution.

The resolution said an individual's sexual orientation should not be allowed to stand in the way of admission to the school or employment.

"Even though 'sexual orientation' is not a protected class under state law," the resolution reads, "Indiana University (including all of its regional campuses except Fort Wayne) does allow 'sexual orientation' to be regarded as a protected class."

In a letter dated May 21 to the

school's two governing bodies, IPFW Chancellor Joanne B. Lantz said, "This change does not mean that discrimination and harassment on the basis of sexual orientation will be tolerated at IPFW."

About 20 Attend Gay Kiss-In At University

NORMAN, Okla. (AP) — About 20 Gays and Lesbians smooched their partners Oct. 10 as part of a Gay rights demonstration at the University of Oklahoma president's office.

The demonstrators hoped their "kiss-in" would help convince the university to recognize Gay and Lesbian alumni groups as part of the University of Oklahoma Alumni Association, said spokesman Michael Split.

"I don't think it's been done before in Oklahoma, but I'm not sure," Split said.

Participants stood by while a brief statement requesting recognition of their organization was read. Then they kissed their partners.

Network Wants Quantum Leap To Pay If Sponsors Pull Out

BURBANK, Calif. (AP) — NBC wants the producer of the hit series *Quantum Leap* to accept financial responsibility if an episode about a Gay teen-ager scares off advertisers.

The network asked Universal

Television to make changes in the episode or face some financial responsibility for what one executive said could be a \$1 million loss in ads. The request was reported in the Sept. 28 editions of the *Los Angeles Times*.

The networks have lost advertisers' money before with controversial shows on abortion and nuclear war. The recession and a continuing decline in viewership also has affected the networks' financial condition.

However, NBC's request to Universal Television is believed to be the first of its kind.

The issue was raised at a meeting with NBC Entertainment executives in Burbank, said Don Bellisario, executive producer of *Quantum Leap*.

"We said you can go ahead and shoot this, but NBC is not prepared to accept any financial responsibility for this episode," said Sue Binford, a spokeswoman for NBC Entertainment.

The executives were concerned about a scene in the yet-to-be-produced episode involving the suicide of a Gay teen-age cadet at a military school. Sam Beckett, played by Scott Bakula, goes back in time to try to save the teen-ager.


Bellisario said he was asked what could be done "to reduce the liability," but that the network didn't demand direct compensation.

The *Times* quoted an unidentified NBC source as saying it was suggested that Universal make up for lost advertising with commercials for its upcoming films.

Bellisario said that he slightly revised the script and hopes the episode will air this season.

The network request was condemned by a Gay leader.

"NBC is sending a message that Gay characters, even Gay teen-agers who exist in our society and are persecuted, are not wanted on NBC," said Richard Jennings, executive director of the Los Angeles chapter of the Gay and Lesbian Alliance Against Defamation.

"Do me wrong, do me right. Tell me lies but hold me tight..." Don't Let Me Be Lonely Tonight

—James Taylor. Sexual addicts "come on" and romance addicts "move on." Relationship addicts just keep hanging and holding on.

There are two types of relationship addiction: being hooked on the idea of a relationship and being hooked on the person.

Either way, relationship addicts don't have relationships, they have hostages. The reality of the other person is irrelevant; all that matters is that the addict must be part of a couple.

Both types of relationship addicts have highly developed "relationships" skills which make them look as if they genuinely care: They are good listeners, share feelings; they re there when you need them and hang on every word. Both are also very controlling, believing they can make relationships happen and make someone love them through sheer force of will and tenacity. Scratch the surface and you'll find individuals who because they have no strong sense of their own identities, cling to relationships for dear life even when they know it's destructive. In fact, they're so terrified of being alone that if someone leaves them they'll move immediately on to another relationship without taking any time to grieve.

Relationship addicts spend so much time and energy trying to maintain a relationship, they neglect personal growth and development and become progressively burned out and deadened.

While relationship addicts appear to do all the right things, they are actually terrified of intimacy, and much more comfortable with a pseudo relationship than a real one.

Are you hooked on a person or a relationship? Trapped in a false friendship that offers nothing but a phony sense of belonging? Because it's often hard to tell, we've designed a quiz to help you determine whether you're avoiding intimacy through pseudo relationships. Only by realizing that you're caught in an empty, "user" relationship can you get the help you need to build real and intimate relationships. Answer each question true or false; see scoring directions below.





Video Review **Parting Glances**

Michael and Robert have been together for six years and are about to be split up for two years while Robert goes to Africa for his international health organization. What unfolds in the 24 hours that Parting Glances

covers is that Robert has engineered this separation because he feels his relationship with Michael has become "too settled, predictable." Parting Glances

examines the New York of these two

attractive men, along with their friends and ex-lovers, both straight and Gay, as Michael and Robert cope with their impending separation. All is not a fairy-tale too good to be true. Michael, a writer, is a care-giver to his ex-lover Nick (Steve Buscemi of Mystery Train), a rock singer with AIDS. Robert can't deal with illness and Michael accuses him of running away to Africa until it's over. When their cab driver mutters "faggots," Michael tells him to mind his own business and "just drive the cab, asshole" and Robert tells Michael that he was rude. Michael is extremely witty while Robert is more placid and not considered quick-witted (Nick refers to him as "Ken Doll" and "Dildo Head"). Michael is a good housekeeper and Robert, pretty much a slob. The Africa separation highlights these irritants in the relationship, many of which are faced by all Gay couples.

The supporting characters also color in the broad range of Gay life. Peter, a record store sales clerk, is interested in Michael whom he follows to Robert's going away party given by Joan, a free-lance artist. There he is ogled by older Gays who consider him an untouchable pretty boy when in reality Peter wants to be

the chaser not the pursued. He has a stairway talk with Nick while both describe the Gay life they have experienced and that the other will never experience because Nick has AIDS and

the anything-goes days of the past are not available to Peter. Nick's video living will to his father and friends is hilarious.

Parting Glances, directed by Bill Sherwood in 1986, is sad but mostly funny. There is lots of affection shown between Robert and Michael (including a shower scene), a hearing-impaired couple signing at a Gay disco where shirtless men dance, the ghost of the Commandant from Mozart's "Don Giovanni," a dishes breaking scene to relieve tension and a poolside fantasy sequence. A tattooed lady dances and the viewer even learns a little about "S&M Sci-Fi Porn." The term "politically correct" also appears in this 1986 film whose director died at the age of 37. Parting Glances is highly recommended and is available locally at Star Search Video, 1411 Poplar Avenue, open 11 a.m.-11p.m daily.

Book Review Advocate Adviser

In each issue of the biweekly Advocate, "the National Gay and Les-Newsmagazine,' bian question-and-answer column called "The Adviser" appears. "The Adviser" has its own Ann Landers/Dear Abby in popular Lesbian author Pat Califia. Advocate Adviser is 213 pages of her most provocative, most-fre-quently-asked-for and most informative columns.

Neither Gays nor Lesbians are slighted in this book which also has an index of many books and publications available to satisfy almost any taste. As Pat Califia put it, "I spent most of my spare time either reading about or talking about sex. I didn't discriminate. Pleasure—mine, other people's, our ancestors', that of future generations, leaders of the New Right, and space aliens'-fascinated me." Advocate Adviser covers almost

every conceivable topic from coming out, meeting potential lovers to death and wills and everything in between. Do penis enlargers work? Where are goal of all Lesbians to "build a nest with Ms. Right?" Where do I meet Black lovers in Canada? Can dealing with hustlers ever be considered safe in the age of AIDS? As a Lesbian mother whose lover hates my child, what do I do? Where do I get Gay porn about older men? Is it worth it to come out as a disabled person in a wheel chair? How do I break up with my lover?

Advocate Adviser is divided by topics for easy reference. "Solidarity' is about the differences and similarities between Gays and Lesbians. Are Lesbians more welcome in Gay bars than vice versa? Is it true that Gay men are "genitally-oriented" while Lesbians care more about the "whole person"?

On all levels, Advocate Adviser is informative and thought-provoking. The book is available locally for \$8.95 from Meristem, 930 South Cooper, one mile south of the intersection of Cooper and Union. Meristem is open Wednesday-Saturday from 10 a.m.-6 p.m. and on Sundays from 1-5 p.m..



American Association of Physicians for Human Rights

The AAPHR (American Association of Physicians for Human Rights) met August 22-24, 1991. From Little Rock, Arkansas, Richard Johnson, M.D. and Chuck Higgins S.O. (Significant Other) joined 250 other physicians, healthcare workers and S.O.'s at Provincetown, MA.

The major thrust of the meeting was the discussion of the impact of the new CDC (Center for Disease Control) guidelines re: testing healthcare workers. Efforts are being pushed by none other than Jesse Helms for mandatory testing of all healthcare workers. Even though the CDC guidelines were the response to demands from the country resulting from the Kimberly Bergalis incident, the CDC guidelines were printed on paper watermarked "Homophobia." The right-wing radicals are fanning the situation so that the homophobia converts into fear and panic.

Although there has never been a documented case of HIV being passed from a physician or nurse to a patient, all potentially HIV-infected healthworkers are being made the scapegoats. The livelihoods and professions of as many as 30,000 healthcare workers are being placed in jeopardy. As misfortune would have it, those in jeopardy are the very ones most likely to be providing care for patients with HIV-related diseases. The potential damage is catastrophic.

Speakers with national reputations such as Congressman Gerry Studds, Urvashi Vaid (National Gay and Les-bian Task Force) and Virginia Appuzzo (longtime activist) emphasized the absolute necessity for all of us to become more involved, more politically active and to begin standing up for our rights before they are taken away from us.

In a larger sense, said Eric Rofes from the San Francisco Shanti Project, it has become increasingly evident that we, as a community must increase our cooperation and combine our strengths to keep the right-wing conservatives from taking away those rights we have fought to achieve and maintain.

The wide variety of topics discussed at the conference included such subjects as the ethics of outing, the role of ACT-UP in liberalizing policy regarding new anti-HIV drugs and the future of our culture. AIDS specialists from both coasts gave an update on new treatments.

One message of the conference rang out loud and clear: "In-fighting

gains nothing. In-fighting drains us of our resources. In-fighting plays into the hands of those who would oppress us. We must stop our own self-destructive behavior and look for ways to recognize our diversity as a source of strength."


Shana Saunders, the vice-chair, gave her personal coming out story while her mother listened in the audience.

Oral Sex and the Risk of HIV Infection

Decisions in the age of HIV/AIDS concerning sex are not easy. It is important to make an informed decision based on the facts.

Performing oral sex has greater risk for getting HIV infection than receiving oral sex. In fact, receiving oral sex is very unlikely to transmit HIV.

There are many studies which believe that there is no connection between oral sex and getting HIV and other studies which believe the possibilities are small. It has been believed that cuts or sores would have to be present for transmission to occur. HIV must have a way to get into the blood stream.

But, according to a study at Dana-Farber Cancer Institute, dendritic cells may be a source of HIV infection. Dendritic cells are present on the surface of the mucous membranes that line the mouth, anus, and vagina. In the test tube, dendritic cells are easily infected. In the body, it is believed these cells carry the virus to other tissues and to the T-cells in blood. If this study proves to be accurate, a cut or sore does not have to be present for HIV transmission to occur in oral

If you want to make oral sex safer, use a latex non-lubricated condom. Condoms also protect you against getting other sexually transmitted diseases like syphilis or gonorrhea.

If you choose not to use condoms, don't brush your teeth or floss before having oral sex. If you have cuts or sores or recently had dental work done, do not have oral sex.

Lab Workers Accused Of **Revealing AIDS Test Results**

LENEXA, Kan. (AP) - A labo- out of Tom Cruise's test results. ratory that conducts AIDS tests has assailed a magazine report accusing lab employees of revealing test results of Hollywood celebrities such as Oprah Winfrey and Tom Cruise.

An article in the November edition of Details magazine said workers at Home Office Reference Laboratory Inc. often gossiped about results of celebrities' tests, including AIDS tests.

"I can't say it never happens," said Gregg Sadler, Home Office executive vice president. "But it's against company policy, and the company would discipline any employee who did that.

Home Office conducts blood and urine tests for insurance companies, which use the results to determine the risk of potential policyholders. The company employs about 550 workers in laboratories in Lenexa and **Overland** Park.

The Details article was written by Jared Goldstein, a freelance writer who is working on his master's degree in economics at the University of Kansas

Details is a men's monthly magazine that focuses on fashion, music and pop culture.

Goldstein said he was hired by Home Office through a temporary employment agency and worked there in April and May. He said he did not intend to write an article when he was hired at Home Office.

Goldstein said employees made photocopies of celebrity consent forms and accessed test results from computers.

He said a former Home Office employee gave him a computer print-

"A celebrity's test isn't considered a secret," the article said. "It's a status symbol."

Sadler said Goldstein, not Home Office, was "the one who disclosed celebrity names and test results.

Home Office had "very strict" policies and procedures about the confidentiality of the results, and supervisors and managers monitor employees, Sadler said.

'Very few people in the company have access to confidential results, he said

State Assured Access To **Records Of HIV-Positive Workers**

MONTGOMERY, Ala, (AP) - A panel of Alabama public health officials has approved a rule giving the state access to records of health care workers who test positive for the virus that causes AIDS.

But there's no penalty for refusing to cooperate.

The State Committee of Public Health Oct. 16 agreed without dissent to make permanent an emergency measure the panel approved in August.

The measure also gives state health officials access to medical records of health care workers who test positive for hepatitis B.

The new policy does not require that health care workers be tested for the AIDS virus.

Laboratories and physicians are already required to report cases of HIV virus to state health officials.

That reporting is across the board," said Dr. Don Williamson, state director of disease control. "If

reported by that system and it looks like a (health care worker) situation we ought to investigate." The rule provides access to the records needed to trace contacts with co-workers and patients.

There will not be a circumstance where we would just randomly go in and ask for records," Williamson said

He said the rule guarantees "that we do have access" to records. He said there is no penalty provision for anyone who refuses to cooperate.

Health officials estimate that 10,000 people in Alabama are HIVpositive and don't know it. There are more than 1,100 known cases of AIDS in Alabama and about 2,700 people are known to have the HIV virus.

Health officials said the rule does not compromise confidentiality.

State Health Officer Earl Fox has said health officials must be able to investigate cases of possible transmission of the HIV virus from health workers to patients.

The rule is in response to a federal Centers for Disease Control recommendation that states take steps to better track possible risks of transmitting HIV and hepatitis B during procedures involving infected health care workers.

A spokeswoman for the AIDS Action Council in Washington said in August that five patients nationwide have been shown to have gotten the deadly virus from a health care worker



Retrovir, is not a cure for the HIV infection, but has been found to delay progression of the illness. After prolonged treatment, some patients seem to derive less benefit, possibly because the virus has become resistant to the drug.

In the study, scientists analyzed strains of HIV isolated from five patients with advanced HIV disease. The patients had undergone treatment with AZT and then, when the drug appeared to be failing, were taken off AZT and put on ddi, or dideanosine, a drug developed by Bristol-Myers Squibb Co. which the FDA recently approved (see story on page 1).

Doing test tube experiments, the scientists found that the virus samples quickly became resistant to ddi but became more sensitive to AZT.

The theory behind combining drugs is that two agents can increase effectiveness, delay or overcome possible drug resistance, and reduce side effects.

RESEARCH TRIANGLE PARK, N.C. (AP) — Combination drug therapy is used to treat diseases such as cancer and tuberculosis, and researchers at Burroughs Wellcome Co. say it should be used for AIDS, too.

The bottom line is, this says combination therapy is clearly the way we should move to handle HIV-infected individuals," said Sandra Nusinoff-Lehrman, head of the department of infectious diseases at Burroughs Wellcome.

Research by the Burroughs Wellcome scientists concluded that the AIDS virus was less resistant to AZT when it was used in combination with another AIDS drug.

The research was published in the journal Science.




