Rogers Man Argues Against Fayetteville, Ark. Resolution

SPRINGDALE, Ark. (AP) — Opponents of an anti-discrimination item on the fall ballot in Fayetteville say the measure would affect surrounding communities if it passes.

The proposal would prohibit businesses in the city from discriminating in hiring on the basis of sexual orientation or family status. It also says the city won't discriminate on the basis of race, sex, disability and other reasons.

"When Fayetteville sneezes, Springdale, Rogers and Bentonville all get wet," said Kirk Hartness of Rogers, coordinator for the Citizens Aware Group.

Fayetteville's city council approved the resolution in April, but Mayor Fred Hanna vetoed it. The city council overrode the veto May 6, and a group called the Citizens Aware committee collected enough signatures to put the measure on the Nov. 3 ballot.

Hartness said that there is more to the resolution than meets the eye. He said businesses would be "forced to cave-in to hiring and benefit policies catering to homosexuals." He also said there would be access to the public schools "with an agenda to teach children 5, 6 and 7-year-old their bizarre and destructive sexual practices are just another lifestyle."

Hartness spoke after Christian Coalition Chairman Brent Watson of Fayetteville yielded the floor at a candidates' forum attended by about 20 people.

Citizens for Fair Government, a local political action group, says it hopes to educate people about the issue so they will vote for the resolution.

Hartness said he was asked by Rev. Gene Fulcher and Rev. Charlie Brown, the co-chairmen of the Citizens Aware steering group to head the campaign.

He said the group had struggled for a name of the resolution, but "we have to be careful with these things in the public though because we don't want to identify this specifically as a piece of homosexual legislation—however you should be aware for the purposes of discussion—that is what this is really all about."

He said similar resolutions had been passed in communities on or near college campuses and that the resolutions are not about equal access to jobs or education.



Holy Trinity Purchases Property for New Church, Plans Move this Fall

For nearly two years the membership and leadership of Holy Trinity Community Church have been involved in an extensive search for a new home. The church has strong ties to Midtown and particularly to the Gay community.

Holy Trinity has purchased the former First Tennessee bank building at 3430 Summer Ave. with the help of realtor Polly Bolin. Members of the board signed over their bank accounts and homes out of their deep commitment for Holy Trinity and its ministries.

"The building is architecturally post modern with a vast openness that would allow us to do whatever we want," said Meadows.

Holy Trinity also marks the purchase of a building as a sign of permanence in the Memphis community, an achievement far greater than one might think. There have been several religious groups and circles that have sprung up and burned out. Midtown has also seen several churches relocate or close as members continue to move east.

Holy Trinity Pastor, Tim Meadows remarks, "This part of Memphis is not noted as a great bed of church growth in the traditional sense, especially of those churches which are largely homophobic, white and middleclass."

Church vestry members established a task force which led a prolonged process of congregational meetings and surveys to establish costs, demographic information, location guidelines and future planning strategies.

"Early on we made the decision to stay in the Midtown area even through many of our members live in the suburbs," said Jodie Felmet, vestry moderator.



Holy Trinity Community Church has purchased this 5000 square foot building at 3430 Summer Ave. The building was built in 1963. Initial plans include renovating the exisiting space for church use; long-terms plans call for a sanctuary addition to the building.

"We also had a modest budget within which to work... we did not want to be building poor," added Felmet.

The goal was to stay west of Highland and south of Jackson with Park Avenue as a southern border and the Mississippi River to the west. "There is not a whole lot of property within our price range that is adaptable and in good working order within these parameters," said Church Treasurer Don Morgan.

The property has access to Faxon, National Boulevard, and frontage on Summer Avenue. There seems to be ample parking with landscaped grounds. The interior is a vast box waiting for Holy Trinity to transform the building.

The church has hired Ed Bridges, an area designer, to design changes to the building.

Holy Trinity celebrated its eighth anniversary this year with a strong and growing congregation. Holy Trinity is unusual because the church has no ties to any religious denomination and was born out of the Gay and Lesbian Christian community in Memphis. The diversity of persons in the congregation is a rare find. When HTCC gathers each Sunday, it is a mixture of heartfelt music, evangelical zeal and an open sharing of Holy Communion.

"It's like we have bought our first home," remarked Lori Eades, who will be heading up the church's moving program. The church anticipates moving in mid-autumn.

The acquisition begins the first phase of a five-year building program which will end with the completion of a sanctuary adjacent to the Summer Avenue building.

"This is a significant step forward not only for Holy Trinity, but for Gay and Lesbian people of faith in Memphis, points out Jean Crawford, Holy Trinity vestry member.

Friends would not let her celebrate on her own, so a surprise birthday celebration, attended by a capacity audience, was planned for Sharon on Fri., Aug. 28, at Madison Flame. Her 50th birthday celebration was a veritable "This Is Your Life" party and, as it turned out, one of the last great gatherings of the movers and shakers of the 60s and 70s.

The plans include arrival at the bar by horse-drawn carriage; faces from past and present in the crowd; drag, performers, loyal customers, Lesbian organizations and members of Memphis' leather community on hand to wish her well and a buffet. Jimmy Gray (aka Dee Dee Whitaker) emceeing a show full of talent and tales with Vincent Astor, of TJN, as main roaster were also planned.

The New "Other"

There is a certain Nazi logic to the invective of several politicians and some religious political extremist groups in the United States. Each group is using homophobia, fear and ignorance to curry favor with voters for upcoming local and national elections. There are disturbing parallels in this logic which brings to mind the Third Reich's use of the Jew to electrify, excite and unite a nation. For the Third Reich to work, there needed to be an "Other," an outsider, a minority that was feared and loathed for illogical reasons. On that "Other" could be heaped the blame for all the ills that transpired in a society that lost a world war and was mired in the depression. That "Other" was exploited by the creators of the Third Reich. Somehow if the "Other" was purged from the soci-

ety, harmony and economic well-being would return to the nation which would once again return to the righteous path. This Nazi logic lead to intolerance and discrimination so terrible that Jews were eventually stripped of their citizenship, property, homes and lives, all accomplished using existing German laws. The dance floor at Crossroads was built by Chaps and owner David Bulliner especially for Southern Country.

Southern Country had a long run at the former Reflections, making regular use of its smaller dance rooms and holding its early Hoedowns in the larger area. The picture in the mirrors of that room of 40 couples doing the sway in perfect unison is an image that I remember with great fondness.

The club then alternated between 501 (with another new custom dance floor) and WKRB. For reasons of its own and the change in ownership of WKRB, the club ended up at Madison Flame (on another very fine dance floor, this time the floor came


first)

I never felt that one should exhibit "bar attitude" to another person wearing the same badge as oneself, particularly if one has a high profile. This attitude happened to me a number of times. Last time I went on a Tuesday (at Lorenz) I only saw one person I remembered from my fun days with this club. Very few people were there. I don't know where the club will be going now and I hope that those who are left will enjoy one another. The club did a lot of good with their fund-raisers and their use of the Holiday Inn Midtown for their hoedowns helped move Gay/Lesbian events out into more public areas. 

Anti-Gay Hefley Amendment to Overturn Clinton's Executive Order Banning Job Discrimination Defeated

WASHINGTON — The U.S. House of Representatives Aug. 6 defeated the Hefley Amendment by a vote of 252-176.

The amendment to the House Commerce, Justice, State Appropriations bill, which would have overturned President Clinton's May 28th executive order banning workplace discrimination based on sexual orientation, is a serious setback to the Far Right's recent anti-Gay legislative crusade.

The vote signals that members of Congress may fear a backlash from voters who overwhelmingly believe discrimination against Gay Americans is wrong, according to the Human Rights Campaign.

"This vote was historic. For the first time in the history of this country, the U.S. House of Rep-

resentatives voted that discrimination against Gay and Lesbian Americans is wrong," said HRC Executive Director Elizabeth Birch. "Religious political groups and the Congressional allies overreached and, in the process, delivered our community a strong statement from Congress that they agree with most Americans and support protecting Gay Americans from unfair discrimination.

"Republicans, Democrats, and independents in Congress did not want to add the official stamp of approval for anti-Gay workplace discrimination in federal agencies."

Most Americans adamantly oppose the Hefley Amendment and its goal of legalizing discrimination," said HRC Political Director Winnie Stachelberg. Birch and Stachelberg praised Rep. Barney Frank (D-MA) and Rep. Jim Kolbe (R-AZ) for their leadership in defeating this amendment.

The amendment, sponsored by Rep. Joel Hefley (R-CO), was out-of-step with public opinion. A new poll released by HRC and conducted by the polling firm Penn, Schoen and Berland shows 64 percent of Americans said they are against Congress overturning the executive order, compared to only 28 percent who support overturning the discrimination ban.

A Wall Street Journal/NBC News poll released last week reaffirms the HRC findings with 72 percent of the American public supporting President Clinton's Executive Order against anti-Gay bias in federal agencies. An April 1997 poll conducted for the Human Rights Campaign by the Tarrance Group, shows that 80 percent of the American public says that homosexuals should have equal rights in terms of job opportunities.

Before this executive order was issued, many federal agencies had their own separate policies banning discrimination based on sexual orientation. This often led to confusion amongst government workers as to whether or not they were protected. Contrary to the claims of the

GOP leadership, this executive order helps clarify the law for government workers by bringing uniformity to existing anti-discrimination policies across the federal government. The order adds sexual orientation to the list of protected categories for which discrimination is already prohibited, i.e., race, color, religion, sex, national origin, disability and age. In issuing the order, Clinton noted that this policy does not add any new enforcement rights, such as the ability of a civilian federal worker to appeal an anti-Gay job discrimination case before the Equal Employment Opportunity



WASHINGTON — In the latest of series of legislative attacks against Gay Americans and people at risk for HIV, two amendments to the District of Columbia House Appropriations Bill were passed that would prohibit unmarried couples from jointly adopting and deny money for needle exchange programs.

The discriminatory adoption amendment, offered by Oklahoma Republican Steve Largent, is unmistakably anti-gay and is an intrusion into local government that will put thousands of D.C. children at risk, according to the Human Rights Campaign.

"The contradictions and illogic of Largent's anti-gay amendment are unbelievable. On the one hand, those pushing it say they want to provide greater security for children. But in reality, they are creating less stability by limiting the number of guardians which will leave children vulnerable," said HRC Political Director Winnie Stachelberg.

"The American public doesn't want family policy made by the federal government. It is hypocritical that these vocal proponents of more local control want to play national nanny and micro-manage adoption decisions that should be made on a case-by-case basis by parents and professionals."

Under the Largent amendment, which passed on a 227-192 vote, single D.C. residents would still have the ability to adopt children. The amendment will ban joint adoption by unrelated persons.

While both parties of an unmarried couple would obviously still serve as parents to the child, the second parent would have no legal responsibility or protections for the child, including financial. In unfortunate circumstances, such as a break-up or the death of a legal parent, the non-legal parent would have no legal responsibility to care for the child.

As of June 22, 1998, there were 3,600 children in the D.C. foster care system waiting to be adopted.

The passage of Rep. Largent's amendment follows last week's rejection of the same amendment offered by Rep. Tiahrt to the House Appropriations Committee. For three years, there have been attempts to attach similar language on adoption in the D.C. appropriations bill.

This is the first time such language has passed. An August 1997 poll conducted by Penn, Schoen & Berland Associates shows that most Americans agree that the federal government should stay out of family law decisions. In fact, Americans categorically reject the notion that the government should

take a greater role in deciding who can and cannot adopt children. By a margin of nearly four to one (74 to 19 percent,) voters say we should keep the system we currently have, rather than allow the federal government to take a greater role.

Kansas Republican Rep. Tiahrt's amendment to the bill also passed by a vote of 250-169. The Tiahrt amendment would prohibit the use of federal and District funds from being used for needle exchange programs. The amendment further prohibits funds from being paid to any organization that carries out such programs.


"This crass political opportunism and intrusion into local District affairs will result in more people suffering and becoming infected with HIV," said HRC Senior Health Policy Advocate Seth Kilbourn.

The Tiahrt amendment is a radical departure from previous Congressional action on this issue and sets a dangerous precedent for many states and localities where needle exchange programs operate using local and state funds.

The District of Columbia has chosen to use its own funds to address an urgent local need. Congress should not encroach on the ability of any state or locality to implement successful programs to prevent the transmission of HIV.

"We will work tirelessly during the months ahead to defeat both of these amendments in conference," said Stachelberg.





HRC Asserts Christian Coalition Breaking Hawaiian Fund-Raising Laws in Anti-Gay Campaign

WASHINGTON — Protect Our Constitution and Protect Our Constitution/Human Rights Campaign, the two groups fighting the anti-gay ballot measure in Hawaii, have filed a formal complaint July 30 with the Campaign Spending Commission.

The groups charge that the Christian Coalition and its local affiliate, the Hawaii Christian Coalition, are blatantly flouting Hawaii campaign spending laws.

"The Christian Coalition is not above the law and has no special right to ignore Hawaii's rules on campaign spending. The citizens of Hawaii ought to be concerned when religious activist groups, like the Christian Coalition, believe they can brazenly disregard laws in their effort to impose their narrow views on Hawaii citizens," said HRC Communications Director and Senior Strategist David M. Smith.

The state legislature has placed a question on the ballot for the November election, to determine whether the Hawaii constitution should be amended to grant the legislature the power to limit marriages to opposite sex couples. This has brought in a flood of religious political activist groups who want to export intolerance into Hawaii.

Under the Hawaii campaign spending law, any group which raises more than \$1,000 in support of a ballot question must register and file reports with the Campaign Spending Commission.

Neither the Christian Coalition nor the Hawaii Christian Coalition, have registered. Yet, these groups have embarked on a full-fledged electronic fund-raising appeal with explicit instructions on how to give money by credit card.

The Christian Coalition is even electronically soliciting cash from overseas to help raise the \$1.5 million they believe is needed to buy this referendum. Posted on the Hawaii Christian Coalition website, in boldface type it says, "Foreign Checks Also Accepted."

"If past pro-discrimination campaigns are any indication, this end-around by the right could be the first of many unscrupulous tactics and tricks we may see between now and November," said Smith.

The complaint was filed by Protect Our Constitution Campaign Manager Jackie Young and Smith, Protect Our Constitution/Human Rights Campaign's representative.

"Today's complaint asked that the Commission declare the Christian Coalition and Christian Coalition Hawaii in violation of the law. compel them to register, and impose all appropriate penalties under the law. These groups need to learn that in Hawaii, there are consequences for those who do not

play by the rules," said Young.

Christian Groups Plan to Run Anti-Gay Ad in San Francisco

SAN FRANCISCO (AP) — Christian groups are bringing their national anti-Gay advertising campaign to San Francisco's Sunday newspaper, causing concern in the city's large Gay and Lesbian community.

Fifteen Christian groups paid \$35,000 to buy the ad, which will be published in a section of the Sunday paper prepared by the San Francisco Examiner. The Sunday paper also contains sections produced by the San Francisco Chronicle.

The full-page ad suggests that Gay men and Lesbians can change their sexual orientation if they pray and get help from "ex-Gay ministries," groups of people who say they once were Gay but became heterosexual.

It is one of four such ads that the groups have placed in the *New York Times, Washington Post, USA Today* and other papers over the last few weeks.

Some members of San Francisco's Gay community considered running an opposing ad in the same section, which is what other groups have done in other cities. Some said the ads were distasteful, but said First Amendment rights come first.

The Christian groups, led by Janet Folger of the Florida-based Center for Reclaiming America, first approached the San Francisco Chronicle — which rejected the ad.

"We reviewed it, and we had several concerns about the ad and made the decision that we were not going to run it," Chronicle Publisher John B. Sias said.

The San Francisco Newspaper Agency, which sells advertising for both the *Chronicle* and *Examiner* under a joint operating agreement, suggested the ad could run in the Sunday news sections, which are produced by the *Examiner*.


Guittar accepted the ad.

"We do not like to censor ads or suppress the free flow of information," Guittar said. "This is an issue up to debate. The *Examiner*'s position is that we don't agree with the philosophy this organization is espousing. We believe they have the right to express their opinion."

The newspaper will also print an editorial that will challenge the ad.

Examiner Executive Editor Phil Bronstein said running the ad was a business decision and had nothing to do with the newspaper's commitment to coverage of Gay and Lesbian issues.

"It is also our responsibility to cover the controversy over these ads, which we are doing," Bronstein said, "and to deal with the deeper issues the ads raise, about claims made in the ads, and about the obviously contradictory views people hold."

Licensed to Kill: A Story Worth Telling

"We've never had a queer rally before and we don't want one in our town." "It pisses me off to see one man holding another man's hand." "I don't believe there's anything in our Constitution that gives anybody any rights to be accepted." "Homosexuals make themselves easy targets." "We had it imbedded in our hearts that homosexuals are weak." "The bullet I fired killed him. I didn't mean to take his life." "If I get off death row, great. If not, they're doing me a favor." "We was really, really drunk." "Sometimes people need to be dragged out of the closet." "Religion is a vicious thing." "We must defeat militant homosexuality or it will defeat us." "I told my mother to take my brother and get him layed. I don't want him turning into a faggot." "I have no opinion about homosexuals except that they all ought to be taken care of." "I don't even think police should kill people."

The statements above are from the documentary *Licensed to Kill*. This public television *Point of View* presentation aired on Channel 10, Tues., Aug. 11. In it independent filmmaker Artlier Dong searched the hearts, minds and souls of seven men who murdered Gay men. The

film, a winner of two top awards at the 1997 Sundance Film Festival, was locally underwritten on Channel 10 by Memphis Pride, Inc.

Viewing the documentary, one could not help but be moved to tears and shame by the graphic violence inflicted on these innocent victims simply because of their sexual orientation. In a world where we would like to think such behavior does not exist, we are

poignantly reminded of man's inhumanity to man. This was not a documentary for the squeamish

or faint of heart.

viewed, a litany of narrow-minded, ignorant and downright stupid statements spewed forth. Men who were brought up to hate anything that wasn't white, Anglo-Saxon, Protestant and heterosexual were speaking their special brand of hatred. As they were being interviewed, pictures of their victims were shown. These were not pretty pictures. Young lives, unfulfilled lives, lying in pools of blood. Their bodies beaten unrecognizable, their battered faces displaying the horror and fear they experienced as

they were helpless to defend them-

No, these hate crimes did not happen 15 or 20 years ago. These were all crimes of the 90s. The inmates were products of a culture where sexual tolerance is extended only to the heterosexual. Gay men, Lesbians, transsexuals, bisexuals, etc. have no place in their society.

Of particular interest was one inmate of biracial parentage whose

father was a minister. The inmate admitted to having had homosexual experiences himself. He said that even though he

has homosexual tendencies still, the thought of homosexuality being an abomination and a sin is always in his mind. He had a lot of internal, intellectual conflict going on. He was obviously well-educated and knew the difference between right and wrong. He killed nonetheless.

The other inmates, five white and one Black, were basically uneducated and the victims of a closed mind and an amoral heart. All spoke poor English and reflected lower class values. The scary part of it all is that there are millions more like them walking

the streets. None of us is safe from their loathing and any of us could become their next victim.

This documentary deserves to be-shown on network television in prime time. It should be a part of every high school curriculum. It should be shown in churches and synagogues. Licensed to Kill is a wake-up call to our nation. It's telling us that ours is a nation rabid with homophobia. It's telling us that sexual bigotry knows no racial, socioeconomic, political, ethnic or cultural bounds. It's telling us that the civil rights of Gay and Lesbian people are being taken for granted and that it seems nobody cares.

The Gay-rights movement is the civil rights movement of the 1990s.

We need to worry less about how it parallels the 1960s civil rights movement and worry more about how we can educate a a nation filled with fundamentalist, Gaybashing, uneducated, ill-informed people.

It is true that hate crimes based on sexual orientation are on the increase. It is true that many refuse to see Gay-bashing and the senseless murdering of homosexuals in the same light as the civil rights crimes of the 1960s. What a pity. The truth is, whether a person is murdered for being Black or being homosexual, either way, he's just

Ex-worker Sues Yankees Claiming Gay-bashing, AIDS Discrimination

NEW YORK (AP) — A former New York Yankees clubhouse worker charges he was the target of Gay-bashing by players and that the team fired him because he has the AIDS virus.

The lawsuit of Paul Priore, 34, charges that Yankees relief pitchers Mariano Rivera and Jeff Nelson, and former reliever Bob Wickman, made anti-Gay remarks and played cruel pranks on the equipment worker.

He claims the players threatened "to perform assaultive and sexual acts" on him between April and July 1996. At one point, Nelson and Wickman allegedly waved a baseball bat at Priore and threatened him, the lawsuit charges.

"I've never heard anything like that," Nelson told the *Daily News*. "Nobody did it. ... It's sad. I guess nowadays you can sue for anything."

Rivera declined comment.

Priore, who reportedly worked for the team since 1990, was fired in August 1997 after being accused of theft. He was supervised by his father, longtime Equipment Manager Nick Priore, who himself was fired by the Yankees late last year.

"I don't want to talk about it," Nick Priore told the New York Post. Paul Priore was not at home, his father added.

The lawsuit also accuses two

team executives, General Manager Brian Cashman and Major League Administrator Thomas May, of ignoring the alleged abuse and falsely charging Priore with stealing team uniforms. Cashman was an assistant general manager at the time.

Yankees spokesman Rick Cerrone called the suit "ludicrous and meritless." "Our normal policy would be not to comment on any pending litigation," he said. "But this is so baseless that it doesn't even merit adhering to that policy." Wickman, now with the Milwaukee Brewers, was with his team in Cincinnati and not immediately available to comment.

McDonald's Applicant Wants Settlement in Gay Bias Claim

KILLINGLY, Conn. (AP) — A local man has filed a complaint against McDonald's, claiming he was denied a job at the fast food restaurant because he is Gay.

The state Commission on Human Rights and Opportunities told Joseph Nichols they will investigate his allegations, and the 18-year-old is waiting to hear if the restaurant will settle the case. A commission spokeswoman declined comment because it is pending.

According to Nichols' complaint, he applied for a job at the McDonald's in nearby Brooklyn in May. At the end of the interview, he recommended his boyfriend, Trevor Clark, 21, for a job at the restaurant.

The two men had moved to Connecticut from Massachusetts, where Nichols worked at a McDonald's in West Boylston.

Two days after the interview, Nichols inquired about the job. He was told he couldn't be hired, despite a recommendation from the West Boylston restaurant, the complaint said. Nichols said the interviewer first told him it was because he is Gay, then said the restaurant didn't hire former McDonald's employees.

McDonald's has denied the al-

legations and has asked for the case to be thrown out.

Nichols said Aug. 10 he will settle for the full-time crew manager position he wanted and the \$3,000 in pay he would have received if he got the \$6.50-an-hour job three months ago.

Nichols said he expects to hear by Wednesday if McDonald's will settle the case.

"I'm not working and I want to work," Nichols said. "I'm finding it very frustrating."

Anti-Gay Firefighter Sues over Job Firing, Seeks Order to Reinstate Him

MADISON, Wis. (AP) — A firefighter who was suspended once for distributing anti-Gay material at the fire station and again for issuing a news release critical of the chief has filed suit claiming his free speech rights were violated.

The lawsuit filed in U.S. District Court Aug. 5 by Ron Greer came in response to his firing July 31 for distributing the critical press release in 1997. He had been on suspension since the incident.

Greer also seeks a temporary restraining order for an immediate

return to duty pending the outcome of the lawsuit, said Mike Maxwell, the manager of Greer's campaign for the Republican nomination for Congress.


Greer claims the firing violated his rights to free speech and due process.

The firing came a year after Greer was suspended for issuing the release criticizing Chief Debra Amesqua and alleging a cover-up of an assault during training activities.

The lawsuit names Amesqua,

the fire department, and the Madison Police and Fire Commission as defendants.

Greer was suspended another time in 1997 for distributing anti-Gay material at a fire station. He filed a similar free speech lawsuit over that suspension.



Anti-Gay Vote at Anglican Lambeth Conference Leaves Some Feeling "Gutted and Lynched"

In the aftermath of the anti-Gay/ Lesbian vote of Anglican bishops, at their Lambeth Conference, there is anger, rejection, defiance, networking, mourning, organizing, and that "gutted and lynched feel-

The lasting image of the now concluded global Lambeth Conference of Anglican bishops will likely prove to be the confrontation between Nigerian Bishop Enugi Emmanuel Chukwuma and Lesbian and Gay Christian Movement leader Rev. Richard Kirker, the larger Black African shaking his finger in the face of the small white Briton, admonishing him to repent and return to a more traditional Christianity — like the one the British imposed on their empire in another era.

That the growing Third World Anglican movements, especially in Africa, numerically and otherwise dominated the diminishing Anglican establishments of white Western countries was a key first for this conference. That new Third World majority declared from the depths of their experience that anything less than a condemnation of homosexuality would be "evangelical suicide" for them.

A number of liberal bishops who were largely silent in debate as the conference overwhelmingly rejected homosexual acts in any contexts as "incompatible with Scripture," are speaking out strongly in the aftermath, some in anger, others with simple assurances that nothing will change when they return home.

Gay and Lesbian Anglicans, disappointed in their hopes for recognition of their committed relationships and for ordination without celibacy, have developed a new global network of their own. Rev. Mel White of the Gay-affirming Universal Fellowship of Met-

ropolitan Community Churches (UFMCC) declared Aug. 9 as a day of mourning for all people of faith.

In the hours before the Aug. 5 vote, it was Chukwuma who confronted Kirker, screaming at him for his sin. At one point he forced his hands on to Kirker's head and attempted to "cast out the demons of homosexuality" from him in an act Kirker later described as "spiritual bullying," but answered gently at the time saying, "May God bless you and deliver you from your prejudice against human cre-

As Chukwuma thundered at Kirker, there was a moment poignant with the possibility of connection when Kirker revealed that he had been born in Nigeria and lived there for his first 18 years. Chukwuma for the first time seemed ready to listen - but that ended abruptly when Kirker added, "The first person I ever had sex with was another Nigeria boy when

"You brought it in!" cried the bishop, apparently basing his comment on the discredited believe that the "white man's disease" of homosexuality was unknown in African culture before European

But the angriest liberal, Primus of the Scottish Episcopal Church and Bishop of Edinburgh Richard Holloway, blames the anti-Gay elements of the conference statement about homosexuality not on the Africans, but on U.S. conserva-

He said, "There was a lot of American money from a very traditionalist diocese, and a lot of entertaining of bishops from [the developing countries]. What they have done is, having failed in their own church at home, they have hired the opposition from abroad. This is a substantial and worrying

trend that ought to be noted."

Others also remarked on the ways in which the conference resembled more a political than a religious gathering, as conservatives organized strategically in a way which liberals were not prepared to

Holloway described the African

bishops' Christianity "Islamified," saying that living in Islamic countries, their religion had become "more severe, Protestant and legalistic."

"I can now understand how it feels for Gay and Lesbian people to be on the edge of this kind of virulent homophobia," Holloway

said, variously describing his experience of the sexuality debate as feeling "gutted" and "lynched."

He called Archbishop of Canterbury Dr. George Carey's leadership "pathetic." Holloway promised that the Episcopal Church of Scotland would remain "hospitable" to Gays and Lesbians.

ing both sides. (The quotes in this story were taken from that USA Today edition. The commentary is that of the author.)

The wife in the first couple is described as "wife, mother, former Lesbian" — and claims that God's love "can set you free" from "sexual sin." (Translation: God can turn you from homosexual to heterosexual. This is apparently what He has done for her and her husband. Both are products of "conversion therapy." Such therapy is practiced in groups like Exodus International and Love In Action (headquartered here in Memphis).

Conversion is coming under fire by practicing psychologists. - words of Joe Dallas, a graduate Caltlin Ryan, a Washington of Exodus International who D.C. so-

cial worker, is worried that ads

such as those that ran in USA Today in July will encourage parents to push adolescents into therapy. Many parents, she says, already "push Gay youths into heterosexual experiences, thinking if they have heterosexual sex or have a boyfriend or a girlfriend, then they won't be Gay anymore."

"Conversion ministries also hurt families because they tell people that their homosexuality was caused by early trauma or emotional neglect, Doug Upchurch says. Upchurch is a Houston male who runs a Web site for "ex-ex-Gays" like himself, people who have tried conversion therapy, but now lead Gay lives. "One of the first things you learn is that it's your parents' fault that you re Gay," something mainstream therapists have long ceased to be-lieve, he says. "These groups tear families apart."

While parents of young Gays are seeking "help" for their children, they should listen to the

> runs Genesis Counseling in Orange, CA. He says "suggesting therapy to

their sons and daughters will probably backfire. Conversion therapy has a chance of succeeding only when people are deeply committed to it.'

The mental health community (which includes sociologists and psychologists) is overwhelmingly on the side of those who say homosexuality is not a sickness or a choice that can or should be changed. Although some psychiatrists still offer treatment for homosexuality, the American Psychiatric Association says that there's no evidence such therapy works and that it may do more harm than

The American Academy of Pediatrics says that, while some teens who are uncertain about their sexual orientation might benefit from therapy, therapy designed to choose "since it can provoke guilt and anxiety" holds little or no potential for

Conversion groups admit that they look for roots of homosexuality in troubled families or early abuse. They cannot believe (or refuse to believe) that anyone is born with a same-sex orientation.

They assume that anyone with a same-sex attraction is out of fellowship with God. They want to make choices for everyone. Groups like The Moral Majority, Exodus International, Love In Action, etc., do not help. These groups are usually filled with self-serving, Bible-thumping, narrowminded know-nothings whose purpose in life is to make others miserable. They decide what is sin an what is not. They decide whom God loves and whom He doesn't. They play judge and jury for the rest of the world. They also pay for those Gay-bashing ads.

"What we are not hearing about in these ads are the stories of people who have killed themselves because they couldn't change," says Upchurch.

One of the facts those practicing conversion therapy do not tell you is that most of the staff in their offices are not qualified to act as guidance counselors for those with sexual orientation issues. Most are church members whose only qualification is that they are born-again Christians with a very definite, albeit very fixed, view of the world and the people in it. There are very few with degrees in psychology, sociology, medicine, etc. This makes them, at best, sanctimonious sexual bigots, quacks, and hardly qualifies them to be dealing with the psyches of confused youth and adults struggling to understand who

and what they are. It is no secret that bigotry is alive and well in America. It is no secret that much of that bigotry is perpetuated by mainline churches. It is no secret that sexual orientation is a personal and private matter. It is no secret that the mainline churches need to worry more about how they are going to answer to God for their ill treatment of homosexuals and less about personal sexual orientation. The commandment to love one another as Christ loves us has no caveats. If we are bold enough to call ourselves Christians, then we do not have the freedom or the luxury to pick and choose who to love.

Trail-blazing Gay Paper Folds After 22 Years

NORFOLK, Va. (AP) — A Gay and Lesbian newspaper that began as a few mimeographed pages with handwritten headlines and grew into a computer-designed national publication is folding after 22 years.

The last issue of Our Own Community Press was distributed Aug. 18, leaving Hampton Roads with a single Gay-interest newspaper, Out & About.

Kirk Read, editor of *Our Own*, said the newspaper was built by indefatigable volunteers who saw themselves on the front lines of a civil rights struggle. But in recent years, the passion has faded.

"Apathy is not good for growth," Read said. "There is not that feeling now that people are storming the barricades by putting together a newspaper."

Also, mainstream media now cover Gay and Lesbian issues, and

more people have access to information on the Internet.

Current and former staffers gathered Aug. 15 to put together the last, abbreviated edition—eight pages, much of it a retrospective of the paper's more than 250 editions.

"I'm struck by the spirit of that early newspaper, the people who put it out and their bravery," Read said. "It was their life, but many couldn't even use their last names at the time."

News of the paper's demise came as a surprise in a community that came to rely on the publication

"It's like losing a friend, and I've had that happen too many times," said Mark Powers, 43, of Virginia Beach. "It's been part of my life for so long, I just take it for granted it will always be there."

The editor of Out & About, who

Jenny Jones Case Delayed by Fieger Campaign

PONTIAC, Mich. (AP) — Geoffrey Fieger's campaign for governor could delay a \$50 million wrongful death suit against talk show host Jenny Jones.

Fieger is representing the family of Scott Amedure, a Gay man murdered by a fellow guest days after they appeared on Jones' show.

The civil trial was set for Sept. 14 before Oakland County Circuit Judge Gene Schnelz. But attorneys for both sides say there is a tentative agreement to postpone the case until after the November general election.

"Right now, in the middle of the campaign, I don't think it would be fair for either side," Fieger told the Detroit Free Press.

Amedure revealed that he was

attracted to Jonathan Schmitz, a heterosexual, on the Jenny Jones talk show. Schmitz went to Chicago for the show thinking a woman was going to reveal a secret crush.

When the two returned to Michigan, Schmitz shot and killed Amedure at his Orion Township mobile home. He later told police he was humiliated by the surprise on-camera announcement.

He was convicted in 1996 of second-degree murder and is serving a 25- to 50-year sentence.

Amedure's family says Jones helped contribute to Amedure's death by playing on Schmitz's emotions. They are suing Jones, her show, Warner Bros. and Telepictures.

Managing Director of Gay Games Dismissed for Overspending

AMSTERDAM, Netherlands (AP) — The managing director of the 1998 Gay Games was fired for overspending just after the Olympics-style event began.

The board of directors for the quadrennial homosexual sports and cultural festival issued a statement Aug. 3, saying it had "revoked the mandate" of Dutchman Marc Janssens on Sunday, the day after the opening ceremonies.

"The reason is that Mr. Janssens made commitments outside the approved budget, commitments that were also bigger than his authority," the statement said. It did not elaborate.

"We have no overview of the complete situation," said Games spokesman Paul van Yperen, adding the directors are still investigating the extent of the financial problem.

The Gay Games, which began on Aug. 1 and ran through Aug. 8, expected to attract 15,000 participants and 200,000 visitors from 66 countries.

The event cost \$7 million. Organizers received \$1.5 million in government subsidies and another \$1.5 million from corporate sponsors such as KLM Royal Dutch Airlines and Kodak.





the minister conducting the event caught her eye and suddenly her hand trembled, She dropped the coffee cup, and it shattered on the oak flooring.


"Why? After all this time? Why here of all places? Who in the world would have thought he would become a minister like his father?" She reached for another cigarette and lit it with quivering hands.





North Carolina Supreme Court Takes Custody of Sons from Gay Father

NEW YORK -- The North Carolina Supreme Court July 30 overturned an appeals court and reinstated a ruling that revoked a Gay father's custody of his two sons solely because of his relationship with his male partner, said Lambda Legal Defense and Education Fund.

The ruling means that Fred Smith, a Henderson County, N.C., resident, will not regain primary custody of the boys he raised from birth up until his exwife uprooted them with a change of custody in 1995. She argued that, despite all evidence that the children were thriving in their father's care, Smith's sexual orientation and her recent remarriage warranted a change in custody.

Lambda and North Carolina Gay and Lesbian Attorneys (NC GALA) represent Smith.

'The Court went to extraordinary lengths to rule against this Gay father," said Lambda Legal Director Beatrice Dohrn, expressing shock at the decision. "This ruling undermines non-Gay as well as Gay parents in unmarried relationships, no matter how proven their parenting ability. The Court has opened the door to relitigating current custody arrangements for many families in North Carolina.'

Co-counsel Sharon Thompson of NC GALA said, "North Carolina has a past history of determining custody not on societal prejudice, but on the health and happiness of children. It is a terrible misfortune to Fred, his family and all North Carolina parents that anti-Gay prejudice overruled the children's experiences in this case."

Justice John Webb also disagreed with the Court, stating in his dissent, "The difficulty with the majority opinion for me is that it recites actions by the defendant which the majority considers to be distasteful, immoral or even illegal and says this evidence supports findings in fact which allow a change in custody. There is virtually no showing that these acts by the defendant have adversely affected the two children. The test should be how the action affects the children and not whether we approve of it I do not believe we should allow a change in custody on evidence which shows only that the defendant is a practicing homosexual."

The 5-1 ruling, with a seventh justice concurring only with the result, pointed to Smith's long-"Members of Congress who people to kleptomaniacs, is di-

term relationship with his domestic partner, Tim Tipton, who also helps care for the boys, as the reason for reversing an appellate ruling and supporting a trial court's order for a change

In an apparently contradictory statement, the Court said, "We do not agree with the conclusion of Justice Webb's dissent that the only basis upon which the trial court changed custody was that the defendant is a 'practicing homosexual.' Instead, we conclude that the trial court could and did order a change in custody based in part on proper findings of fact to the effect that defendant-father was regularly engaging in sexual acts with Mr. Tipton in the home while the children were present and upon other improper condice, pure and simple," he said. duct by these two men."

The Court also disapproved* of the fact that Smith and Tipton kissed each other in the presence of the children and that, although always keeping their bedroom door closed and locked if they were having sex, the couple allowed the children into the bedroom when simply in bed together. It cited these facts in support of the decision to remove custody from Smith.

"Sadly, this decision means that two kids have been torn away from a great father only because that father is Gay," said Stephen Scarborough, staff attorney in Lambda's Southern Regional Office in Atlanta. "That's not the 'best interest standard,' at work. That's preju-

Dohrn added, "Although professing not to, the Court applied a double standard to the Gay men in this case. Non-Gay parents are not judged negatively for showing affection in front of their children or for being honest with them. For any parents, those are healthy examples to model to children."

In October, 1996, the state Court of Appeals rejected a trial judge's decision and ordered the children's custody be restored to their father. It said that the trial court's conclusions against Smith were based on improper speculation rather than facts in evidence. But that order was stayed pending appeal by the mother, Carol Pulliam. The Supreme Court heard Pulliam v. Smith appeal in May 14, 1997

In 1991, Pulliam left Smith and the children, now 12 and 9. to live in Kansas with Bill Pulliam, whom she later married. After Smith's partner moved into his home in 1995, Pulliam sought the children's custody. Her challenge received support from the Family Research Council of North Carolina, which used extremist anti-Gay arguments against Smith.

New Poll Shows Latest Right Wing Attacks Against Gay Americans Have Severe Political Repercussions for GOP

WASHINGTON — A new poll released July 30 by the Human Rights Campaign and conducted by the polling firm Penn, Schoen and Berland shows that dire political consequences await the GOP if they continue down their current path of anti-Gay rhetoric and discriminatory legislation against Gay Americans, according to HRC.

The vast majority of Americans are appalled by the recent anti-Gay crusade waged by the right wing. This poll shows that politicians who once thought they benefitted from attacking Gays may be in for a rude awakening in November. America has drawn a line in the sand that says that job discrimination and singling out one group of Americans is morally and politically unacceptable," said HRC Communications Director and Senior Strategist David M.

The poll results show that Americans overwhelmingly opposed the Hefley amendment, which would have reversed President Clinton's executive order banning discrimination against Gay men and women in federal employment. Sixty-four percent of Americans said they were against Congress overturning the executive order, compared to only 28 percent who supported overturning the discrimination ban.

The Hefley amendment to the Commerce, Justice, State Appropriations bill was defeated

vote for the Hefley amendment are clearly out of touch with the American people. Those who choose to support this amendment are branding themselves with a big scarlet letter that screams, 'I am intolerant.' Our poll shows that there are grave consequences for members of Congress who align themselves with religious political extremists," said HRC Political Director Winnie Stachelberg.

Among the findings in the poll is that 75 percent of Americans believe job discrimination against Gay people should be illegal. The poll also shows that there are political consequences for Gay-bashing with 48 percent of likely voters saying that they would be "less likely" to vote for a Congress-person who voted to overturn President Clinton's ban barring job discrimination against Gays. Only 17 percent of respondents said overturning the discrimination ban would make them "more likely" to vote for their Congressperson. The poll also asked how the recent attacks on Gay Americans by the GOP affected the respondents opinion of the Republican party. Forty percent said their opinion was "less favorable." Only 18 percent said anti-Gay rhetoric made their impression of the party "more favorable."

According to the poll, Americans overwhelming believe the recent anti-Gay rhetoric, such as Senate Majority leader Trent Lott's comparison of Gay

visive. Sixty-two percent said they believe that the recent public "discussion" on the equality of Gay Americans hurts the country and fosters a climate of intolerance and hostility, while just 24 percent of say it helps the country. "Voters are perplexed by this new obsession with Gay people and are wondering when Congress will realize it is time to start focusing on real issues instead of redmeat for the Far Right," Smith

In an effort to appease Focus on the Family's James Dobson and his political deputy Gary Bauer, Senate Majority Leader Trent Lott kicked off a wave of anti-Gay rhetoric when he recently said that homosexuality was a sin and likened Gays to alcoholics and kleptomaniacs. His comments were followed by disparaging remarks about Gay people by several public officials including Senator Don

Nickles (R-Okla.), Rep. Dick Armey (R-TX.) and Sen. Jesse Helms (R-N.C.).

These attacks intensified after 15 religious political organizations embarked on a divisive ad campaign targeting Gay Americans and their family members. This orchestrated campaign of discrimination has now spread to the House where a plethora of anti-Gay legislation has been introduced. Recently, the House narrowly passed two amendments to the VA/HUD appropriations bill that have grave implications for Gay Americans. The Hilleary amendment, which passed by a vote of 231-230; would drastically cut housing funds for people with AIDS. The Riggs amendment, which passed by a vote of 214-212, would prohibit San Francisco from using VA-HUD funds to implement its city ordinance against discrimination in city contracts.


Sad to say... Backstreet had inadvertently scheduled and beautifully advertised a fund-raiser for Feast For Friends the same night as the Drag Olympics.


Happy to hear... This reinforces what I have always heard... it's tough to marry a Greek, because he doesn't want to leave his brothers (brothers'?) behind.

Black males make up 56 percent of the 3,141 HIV cases (separate from reported AIDS cases) reported in Shelby County vs.18 percent for white males; Black females account for 23 percent vs. 2 percent for white females. AIDS is the number one cause of death of Black men and women ages 25-44.

Happy to hear... The Congressional Black Caucus and, finally, the NAACP are calling for action and more education and prevention to deal with the disproportionate rate of HIV infection. Now, let's see them walk the walk, not just talk the talk.

Sad to say... The topic of religion and homosexuality (together, not singularly) absolutely makes my T-cells plummet! I just can't believe God created me and loves me, but organized religion rejects me. Now the Judicial Council of the United Methodist Church has ruled that same-sex marriage is against church law. The manager of the Economy Inn said she came in about once a week with different men who would pay the \$25 room rate.

Happy to hear... She is being charged with two counts of criminal exposure to HIV and more charges could possibly be filed.

Sad to say... While Blacks make up 13 percent of this country's population, they account for 57 percent of new HIV infections. Even more disturbing is that more than 80 percent of HIV-positive women ages 13 to 24 are Black or Hispanic.

Happy to hear... Surgeon General David Satcher, who happens to be Black, is urging Black leaders to mobilize against the disease, even comparing the epidemic to the civil rights struggle. "We need to educate as we've never educated before," he told the leaders of the Southern Christian Leadership Council. I don't like to see anyone getting HIV, but finally, some other "group" can help draw attention to the disease.

Sad to say... Garden of the Moon, a lunar culinary experience, was almost the Garden of the Rain. All was ready when the "rain hit the fan." Everything had to be broken down, rewashed, repolished, re-everything. Tammy Gurley Drown and Kim Drown, the ladies who supplied and set up just about everything, worked themselves into a frazzle

A study out of San Francisco suggests half of the HIV+ Gay men who had a history of receptive anal sex had rectal pap smears consistent with anal intraepithelial neoplasia (AIN). "The natural course of this disease is not well established but as patients with severe immune suppression survive longer, we may see an epidemic of invasive anal cancer." That sounds just lovely.

Sad to say... OK... so by now you know Friends For Life has lost major funding.

Gay Softball World Series Report

For the Autumn St. Haze and J-Wag's Jaguars, their first experience playing in the Gay Softball World Series was a multitude of feelings of excitement, extreme efforts, queasy stomachs, dramatic comebacks, exhilaration and disappointment all rolled into one week of softball. If this sounds like it's a bit dramatic, it's not! Any of the approximately 2,500 softball players who participated can attest to it, and I'm sure add a few more adjectives.

The week-long tournament, held in Atlanta this year, is in its 22nd year and features the "best of the best" teams from 33 different Gay softball leagues across the U.S. and Canada. Attending were 106 teams, 71 Open (mens) and 35 Women's divisions, all competing for the opportunity to be crowned champions.

Sunday and Monday were registration days for the players as they flooded the Sheraton Colony Square Hotel in midtown Atlanta giving everyone a chance to greet old friends and meet new ones. Teams were divided in pools (groups) by random draw to play on Tuesday and Wednesday. Each team played three games within its pool, then was seeded (ranked) according to its won/loss record, runs scored by the team and runs scored by the opposition. Thursday through Saturday began the double elimination part of the tournament. Two losses in this format and your team was out of the tournament.

The first game for the Jaguars was against Nashville Express

which saw both teams alternately jump to a lead only to have the other teamcome back and tie or go ahead by a run. Nashville scored seven runs in the last inning to go ahead 13 to 5 as the Jaguars staged a rally themselves scoring six runs only to fall short by 13 to 11.

The Haze played later that afternoon against the DC Metz, hanging tough with its opponents until the fifth inning when the Metz scored five runs and won by a 12 to 6 score.

Two games were on tap for both teams on Wednesday. The Jaguars played Chicago Scots and were drubbed 19 to 7 as their defense fell apart allowing 10 unearned runs to score. The second game was a different story as the team pounded the Birmingham A-Train by a score of 14 to 0 as their bats and defense finally came together for a much needed win.

The Haze's next game was against Norfolk Wipeout where the team members played their style of softball by making timely hits and taking the extra base with their speed and aggressive running. The Haze came away with a hard fought 8 to 4 victory as the team picked up support from many spectators. Scheduled next was the Nashville Sounds as the Haze eked out a 6 to 5 win against a very tough

Thursday was a new start for all teams as the double elimination part of the tournament started. The Jaguars faced Pittsburgh Outlaws, and were mugged 19 to 7 even though the Outlaws had only four more hits then the Jags. The Haze faced the Portland Storm and held

a 4-0 lead late into the game only to see the Storm score five runs on hits that seemed like they had "eyes," sneaking between the infielders and spelling defeat by a 5 to 4 score

Friday morning came and so did the rain as games were delayed five hours to allow time for the maintenance crews to make the fields playable. The Jaguars were pitted against Houston Pacific Street, and played like they were possessed by thumping them 22 to 4. Meanwhile, the Haze was playing Birmingham Quest Cubs and fell by a close 7 to 6 score in spite of turning five double plays during the game, an almost unheard of accomplishment. The Haze wasn't able to get the much needed runs with runners in scoring position. Next up for the Jaguars was the N.Y. Titans, the number one seed. The Jaguars played great defense and scrapped for runs as they knocked the Titans out by an 8 to 6 score. Minneapolis Twin-Cities Storm was next for the Jags with the game changing leads back and forth as the Storm held a slight 14-13 lead into the last inning and then exploded for seven runs as the Jaguars were not able to stage a rally of their own and fell by a 21 to 13 final score.

Both Memphis teams were out of the tournament, but it wasn't a time for feeling down. Even though no one likes to lose, it was more of a time to look back on the week's acomplishments. All teams there were winners no matter what the final outcome.

Our first venture in the Gay Softball World Series was a successful one, not necessarily based

on wins or losses but the overall spirit and reason why they are held - unity, fun, athletic competition and meeting new people who hold the same interest in sports. Both teams from Memphis cheered each other on in victory or defeat showing that we are proud of our city and softball league, and making a statement about us to others attend-

The feature games on Saturday were the finals in each division, with approximately 2,000 fans lined up around the entire field, including the outfield areas, to relax and watch as the games were played. Division winners were: C Division - Boston South Enders, B Division- Dallas Sting, and A Division-L A Stray Cats

Closing ceremonies were held Saturday night with a lavish buffet and casino set-up with each person given \$4,000 in "play money" to use on the gaming tables.

With that we say a sincere "thank you" to Atlanta and the many volunteers who helped make our visit there most enjoyable and memorable. Next year's series will

be in Kansas City, and we look for the same kind of excitement as we did in Atlanta. Toronto, Canada, was awarded the host city honors for the year 2000.

Competition? No. Colleague? Yes.





Who was Bayard Rustin?

Alveda King, niece of Dr. Martin Luther King, Jr., has expended a lot of energy publicly condemning Gay people and denouncing the Gay rights movement. What she seems to have forgotten is that the man who taught her famous uncle about nonviolent protest and was a major architect of the Black civil rights movement of the 1950s and 1960s was an openly Gay man named Bayard Rustin.

Rustin was born in 1912 in eastern Pennsylvania and raised by his Black Quaker grandparents. Toward the end of his life, he noted that his activism was rooted more a Southern white Lesbian and auinto the national spotlight.

thor of the controversial novel about miscegenation, Strange Fruit, hooked Rustin up with the 27-year-old Martin Luther King, Jr., who was trying to organize a bus boycott in Montgomery, Ala. King had academic knowledge of Gandhi's philosophy, but Rustin taught him how to actually employ the techniques of nonviolence. As King's adviser, Rustin and several others conceived the Southern Christian Leadership Conference (SCLC), the grassroots civil rights organization that propelled King

in Quaker pacifism than in his being Black. After attending two colleges and graduating from neither, Rustin moved to New York City in the mid-1930s and enjoyed a brief first career as a singer and actor, playing opposite Paul Robeson in the Broadway musical, John

But activism, not acting, was to become Rustin's life work. In 1936, he joined the Young Communist League, but became disenchanted with the party when it abandoned its commitment to the desegregation of the armed forces at the start of World War II. Rustin quickly moved on to work with the Fellowship of Reconciliation (FOR), an international Christian pacifist organization. During his early years with FOR, Rustin became a disciple of Gandhian nonviolence. In 1944, he put Gandhi's principles into action when he defied his draft summons and had to spend 28 months in a federal prison. After his release, Rustin played an important role on the Committee Against Jim Crow in Military Service and Training, which was instrumental in the desegregation of the armed forces in

Rustin became one of FOR's top figures and was rumored to be heir apparent to its leader. But his homosexuality and frequent casual sex hurt his career. In 1953, while on an FOR speaking tour, he was arrested in Pasadena on a morals charge when he was caught in a parked car having sex with two men. Rustin maintained that the men entrapped him, but he pled guilty anyway and spent 60 days in jail. Though Rustin had never been closeted, being arrested made him a liability to FOR, and he was asked to resign.

Rustin continued to work in the peace movement, taking a staff position with the War Resistors' League. But in 1956, Lillian Smith,

To King's credit, he hired Rustin knowing about his sexual orientation and criminal record. King himself "was under such extraordinary pressure about his own sex life," Rustin later explained. "J. Edgar Hoover was spreading stories, and there were very real efforts to entrap him" and thereby discredit the civil rights movement.

Some Black activists close to King were not comfortable with Rustin, whose promiscuity, they believed, might compromise the entire movement. At one point and for unknown reasons, Congressman Adam Clayton Powell, Jr. threatened to go public with the false accusation that King and Rustin were lovers. In 1960, in the interest of preserving the movement, Rustin quietly resigned as King's assistant.

In 1962, however, Rustin was back in the thick of things, at the request of veteran Black organizer A. Philip Randolph. Randolph's 1941 threat to bring 100,000 Black protesters to Washington had convinced Roosevelt to block discrimination in defense contracting, and he was once again planning a march to bring about government action. Recognizing Rustin's extraordinary organizing skills, Randolph asked him to draw up the blueprint for a massive civil rights march on Washington, to be held on the 100th anniversary of the Emancipation Proclamation. Though Rustin was the march's architect, Black leaders were hesitant to name him as director, since his ties to Communism, his conscientious objection and his morals charge arrest made him vulnerable to attack from civil rights opponents. (Strom Thurmond did eventually attack Rustin on all of these points.) Randolph became the official march director instead, but he named Rustin as his assistant and turned the responsibilities of organizing over to him. The March on

Washington, which took place on Aug. 28, 1963, and culminated in King's "I Have a Dream" speech, was a pinnacle of the movement for Black civil rights.

Though the march was probably Rustin's finest hour, he spent his entire lifetime as an activist, being arrested over 20 times for acts of civil disobedience. In 1964, he organized a public school boycott in New York City, in which 400,000 students, teachers and school employees stayed home to protest the slow pace of integration. Well into his 70s, Rustin was still active in various causes, including the fight against AIDS. "He had work to do until the very end," one of his associates said after Rustin died in August 1987 of heart failure. "His utter devotion to causes was marked by the use of his last ounce of talent, the driving urge to talk,

to plan, to organize."



Autogynephile? What in Heaven's Name is That?

'Autogynephile"? What in ing a woman's body. It is, heaven's name is that? Another Greek-sounding medical diagnosis designed to oppress a sexual

minority?

Well, sort of. The term was coined in 1989 by sexologist Ray Blanchard, of the Clarke Institute of Psychiatry in Toronto. It describes a subgroup of male-to-female transsexuals who, he believes, have been thoroughly misunderstood. And some of these very transsexuals are stand-

ing up to say they agree with him.

The "classic" transsexual is a person who, from early childhood, has the sense of belonging to the other sex from that which his or her anatomy indicates. In childhood, such a boy or girl may show many behavioral traits of the other sex and may express a wish to become the other sex. When sexually mature, he or she is sexually attracted to people of his or her own sex, but does not identify as Gay or lesbian. Rather, he or she identifies as a heterosexual person of the other sex. Often, a classic transsexual seeks sex-reassignment surgery to bring the body into harmony with the mind, and to achieve sexual relationships with heterosexual part-

This kind of transsexuality has a lot in common with homosexuality. In my view, it probably represents an extreme case of the same kind of sex-atypical brain development that, in a less marked form, produces Gay people. But increasing numbers of people, mostly men, who request gender-reassignment surgery don't fit this picture. Many of these men do not have a history of marked gender-nonconformity in childhood, and say that they are sexually attracted to women. In other words, men in this group are heterosexual, but become homosexual after sur-

Blanchard believes that what motivates such men is a sexual attraction to the idea of themselves as women, and he translates this concept into Greek as "autogynephilia." He thinks that autogynephilia is essentially an extreme form of heterosexual cross-dressing: that is, instead of being sexually aroused simply by the thought of wearing a woman's clothes, an autogynephile is aroused by the thought of wearBlanchard thinks, a kind of fetishism - a projection of the libido onto an atypical object or idea.

One person who thinks Blanchard is at least partly right is physician and sexologist Anne Lawrence. Herself a male-to-female transsexual, Lawrence participates in an annual retreat for "new women" (postoperative male-to-female transsexuals). In a 1997 presentation at the International Congress on Sex and Gender, she described the results of a survey of thirteen women at the retreat. Ten of the women identified as lesbian or bisexual, and the same number said that the idea of themselves as women was sexually arousing to them. Over half of the women said that the idea of themselves as women had been their primary erotic fantasy prior to their sex change, in line with Blanchard's hypothesis. Many of the women were specifically attracted to other male-tofemale transsexuals, and had been in sexual relationships with them. "Is it," asked Lawrence at the congress, "because they are our own fantasies made flesh?

Why has autogynephilia remained hidden till recently? Probably because male-to-female transsexuals have feared that they won't be accepted as "real" women, or even as "real" transsexuals, if they acknowledge having such fantasies. Indeed, as Lawrence pointed out, surgeons might well not want to perform surgery to help someone act out their fetishistic fantasies. Yet the crucial question is not what brings a person to a surgeon, but what the long-term outcome of surgery is for a person's sexual and mental health. The answer to this question is not yet in, but identifying autogynephiles as a distinct group of people is a necessary prelude to finding it.

There's been plenty of debate, over the years, about the "naming" of sexual minorities by doctors and other professionals. Has the invention of clinical-sounding terms like "homosexual," "transvestite," and "transsexual" helped or harmed the people the terms were intended to describe? In my view, the net effect has been beneficial: the terminology and the medical discourse helped identify groups who had been profoundly harmed by their non-recognition

Still, to reap the benefits of such identification has required the active participation of the "named" groups themselves. They, after all, are in the best position to assert that they are not sick and have a right to social respect. Typically, as part of this process of reaction, the named groups have insisted on nonmedical designators such as 'Gay," "cross-dresser," and "trans person." The day someone insists on a friendlier-sounding term than "autogynephile" will be the day another sexual minority claims a place at the table.

Chad Allen Grows Up




