Course Description

The purpose of this course is to provide a general knowledge of the social, political, and economical developments in the United States from the post-Reconstruction era to recent times. In doing so, we will look closely at major events, ideas, institutions, and people over approximately 120 years. Hopefully, investigating such aspects of nineteenth and twentieth century America will provide the student with a historical context for more specific components of the American experience(s).

Grading

Grades will be determined from the following course requirements:

- 1. 45% (15% each) Three 2-4 page "reaction" papers. Throughout the semester, students will write essays in response to questions that arise from the readings, lectures, and discussions.
- 2. 20% Exam I. This examination will consist of a few short answers (4-8 sentences) as well as at least one more lengthy essay. In answering these questions, students will be expected to incorporate the readings, lectures, and class discussions.
- 3. 20% Final Exam. This examination will consist of short answers (6-8 sentences) that will cover material from the entire semester.
- 5. 15% Attendance/Participation. Although lectures will take up much of class time, student discussions of issues raised throughout the semester will also be an important component. Thus, students are expected to attend class and be prepared to discuss the major themes from the readings.

*Late Policy - There will be no extensions given on any written assignments without a letter grade per day penalty (this includes papers handed in on the same day but after the

designated time). The only exceptions will be those that the College deems as "acceptable" in the Student Handbook. Students should also note that having other exams and papers due on the same day will not be considered a valid excuse.
