**ANNUAL REPORT OF THE TREASURER
AS OF DECEMBER 31, 1931.**

To the Board of Directors of Southwestern:

Gentlemen:

Herewith is submitted the Audit Report of the books and accounts of Southwestern for the fiscal year ending August 31, 1931 as prepared by C. J. Farris & Co., Certified Public Accountants. The report sets out in detail the financial condition of the College, its assets and liabilities and the results of the operation for the year ending August 31, 1931 as compared with the previous year. The Balance Sheet, pages 1 and 2 of the Audit and Balance Sheet Analysis, and page 2 of the audit letter, show "net worth unincumbered" (or assets in excess of liabilities) of \$1,978,730.29, a decrease of \$25,545.63 as compared with the previous year. This decrease in net worth is due to bank loan of \$15,000.00 and the use of certain Reserve funds and Plant funds in order to meet current operating expenses during the latter part of the college year ending August 31, 1931. The bank loan was paid from Current funds in October 1931 - and there are no bank loans outstanding at this time.

Referring further to the Balance Sheet Analysis page 2 - under caption "Endowment Fund Account", The investments plus cash show \$438,009.62, an increase of \$2,350.37 as compared with the previous year. The item "Other Assets" \$5,501.00 is unchanged from last year as is also the \$6,000.00 invested Annuity held in the endowment fund and not carried as an asset. The average amount of the productive endowment for the year ending August 31, 1931 may be placed at approximately \$434,000.00 and it earned \$23,751.23 or 5.47%.

A comparative statement of total operating expenses and total operating income as shown on pages 17, 18 and 19 of the audit is as follows -

As further reflecting income and disbursement, reference is made to Statement, "Income and Expense, Dormitories, Dining Hall and Book Store", page 6 of the Audit. These activities show income over cost of \$11,613.27 and this amount is listed as income on page 17 of the Audit, and is an increase of \$3,509.85 over the previous year.

The following statement reflecting expense and income may be of interest.

The details of net increase in operating expense as compared with the previous year amounting to \$9,153.92, exclusive of bond interest may be seen on pages 18 and 19 of the Audit.

The decrease in average amount received from each student - as compared with the previous year is more than accounted for in the increase in free tuition allowance. See page 2 of the Audit letter.

As above shown the operating deficit for the college year ending August 31, 1931 was \$44,205.90. Approximately \$29,000.00 of this was provided for through the application of available current fund and other available funds temporarily transferred from Plant account and from Reserve funds. The balance of accrued operating deficit unprovided for as of August 31, 1931 was approximately \$15,000.00 against which a bank loan of that amount was outstanding.

As affecting the cash position of the College it should be stated notes taken from students for tuition, etc. are considered as revenue in the income set-up, but the cash is not available until these notes are paid. Student Note Account shows as follows -

Unpaid subscriptions, exclusive of the older campaigns and the \$118,000.00 of plant fund subscriptions, pledged additional security on the \$75,000.00 bond issue were valued as of December 31, 1931 as follows -

The College is in great need of operating funds and will require at least \$55,000.00 not now in sight to complete the present college year ending August 31, 1932 and immediate steps to secure this amount are now imperative. The additional sum of at least \$90,000.00 will also be necessary to enable the College to balance its budget for the 1932-33 year. If the Carnegie Corporation award of \$35,000.00 is again received this year the \$90,000.00 may be reduced by that amount. The present acute financial requirement further emphasizes the need of \$1,000,000.00 of additional endowment and it is certain that the problem of annually raising funds from the public will continue until at least that additional amount is provided.

The operating expenses of the College for the year was \$908.95 less than the approved budget.
