## Jackson, MS — That Battle Rages On

Jackson MS — In Jackson, MS the battle which began as the result of Gays beginning a local chapter of the Metropolitan Community Church, rages on as Rev. Mike Wells calls on city officials to "decrease or control the activity of the homosexual element" Eddie Sandifer of the Mississippi Gay Alliance points out the parallel between Wells' "clean up campaign" and Hitler's purges (also in the name of Christ); and Ass't Police Chief L.C. Smith puts things in perspective by pointing out that "He (Wells) must have been out really looking for that (homosexual activity). He probably went up to Smith Park and hid in the bushes."

In a press conference, Rev. Mike Wells, president of the Mississippi Moral Majority, complained of "men embracing one another...caressing one another...cavorting with one another. (They) openly display their perversion." According to Wells, "Downtown Jackson becomes a hot bed for this kind of activity. (It is) an embarrassment to the citizenry of our state." Wells claims that anyone who happens to be in downtown Jackson at night is likely "to be hustled" by homosexuals and called on the mayor "to encourage additional arrests."

Assistant Police Chief Smith said, "We used to get people complaining all the time. But we haven't had any complaints in a long time...If there is much activity, people start complaining." Smith pointed out that complaints had actually decreased and at any rate, the city has no ordinance prohibiting kissing, embracing or holding hands by two people of the same sex.

In response to Wells charges, the Mississippi Gay Alliance held a press conference at which, office manager Eddie Sandifer read a prepared statement and answered questions. Quoting passages from *IS THE HOMOSEXUAL MY NEIGHBOR?* by Letha Scanzoni and Virginia Ramey Mellenkott, Sandifer pointed out that "Hitler had persons who were suspected of homosexuality either shot without trial or exterminated in concentration camp gas chambers." Sandifer accused Wells of using the emotional issue of Gay activity as a means of raising funds "There was a time when race was used as an emotional issue for the same purposes and also using quotes from the Bible to support it."

Sandifer emphasized his group was not opposed to enforcement of laws against sexual acts or the display of sex organs in public as long as it was enforced on heterosexuals as well as Gays. At the same rate, kissing, embracing and holding hands in public is not illegal for heterosexuals and should not be for Gays. "Gay people have just as much right to show affection toward their partners as heterosexuals do."

"Gay people know who their people are. There may be some exceptions but they're not going to bother anyone on the street," Sandifer said. Since Gays are everywhere at all times, if we were indeed a threat, the threat would be present everywhere 24-hours a day. He said, "...Mike Wells has said we were out to take over the country...to what end? Our parents, brothers and sisters, business associates and best friends, and neighbors are heterosexuals and we do not find them offensive nor do we wish them harm nor to change that which is normal for them"

Both Sandifer and Wells spoke of their past political activity and plans for the future.

Wells is continuing his media campaign against homosexuality, abortion, pornography and prostitution. An anti-pornography statute has passed the Mississippi Legislature, been signed by Governor William Winter and will take effect July 1. It contains a "vigilante" provision which allows citizens to file pornography complaints against businesses after posting a \$500 bond. Wells feels, "It is a good law that will withstand court testing. We will encourage citizens to support and uphold the law." He is looking to law enforcement officials to "move quickly to close down once and for all the smut shops that are growing in our state."

In other action, Wells' group will push for anti-obscenity legislation aimed at cable TV and he claims that a legislator has agreed to introduce an anti-sodomy bill in the next legislative session. Although the organization will not be making political endorsements this year, candidates' stand on "pro-life, pro-morality,

pro-family, pro-American" issues will be researched and published.

"We are not a phenomenon," Wells said. "We are a movement to re-establish the climate of morality that this nation enjoyed in previous years."

Sandifer said the Gay Alliance has a political caucus which has been endorsing candidates for six years based on their positions on many issues, not just Gay issues, and will continue to do so. The group will also stage a march the last Saturday in June in celebration of Gay Pride Week. Sandifer said, "As taxpaying citizens and as registered voters we shall do all that we can to help our city and state progress. We also want the best--but for all citizens...not just Gays but for all who live here."

"I think their chief concern is satisfying lust today," Wells said, "they don't care one iota about tomorrow."

Sandifer said that Gays in Jackson and throughout Mississippi, far from being intimidated by Wells and the Moral Majority are more unified as a result of these recent attacks.

### Lack of Volunteers Prompts Move to Shorter Switchboard Hours

The staff of the Gay Switchboard voted at their April staff meeting to change the helpline's hours of operation for the first time in its seven year history. The new hours are 7:30 PM to 11:30 PM seven nights a week. The phones had previously been staffed from 7 PM to 1 AM.

Switchboard Coordinator, Ric Sullivan, told Gaze the change was made "to maximize staffing during the hours in which most calls are received."

"We hope that the shortened hours

will encourage more people to volunteer for the Switchboard and discourage our late night prank calls," Sullivan said. "Several volunteers had to drop off the Switchboard because they couldn't stay up until 1 AM because of their work schedule."

At present, the Switchboard has ten volunteers, some of whom work five or six nights a month, according to Sullivan.

## MCC Memphis

A district Metropolitan Community Church official says that if Memphians don't throw support into the local MCC, the seven-year-old church could lose much of its independence or be closed.

Rev. Gilbert Lincoln, coordinator for the 13 churches in MCC's South Atlantic District, sent letters to members of MCC Memphis last month calling for increased attendance, giving and support. Otherwise, he said, the district Board of Home Missions, which governs the church, is expected to either close the church, or revoke its "mission" status.

As a "mission", the church is operated by an interim board of directors and an interim pastor. But the district coordinator and the Board of Home Missions exercise more control over MCC Memphis than other missions than larger churches, which have been granted charters.

Lincoln is challenging Memphians to support the local MCC. He noted that active participation in MCC Memphis has declined since last November. And

he said if community support increased soon, he would have a much better argument to take to the Board of Home Missions.

The board was to meet May 27-29 at a district conference in Columbia, SC.

The guidelines governing the 180 churches in the fellowship are expected to be changed at a conference in July in Toronto. If the proposed changes are passed, any group of 12 persons who agree to sorship, pledge and support the church with their time and talent for one year should receive an MCC charter.

Rev. Jim Simon, interim pastor of the mission since April, 1892, said the church is several hundred dollars in debt. But he said letters have been sent to inactive members in an attempt to increase participation. He added that a small delegation of MCC Memphis supported would be attending the district conference, and that a major pledge campaign is expected to get underway soon.

MCC Memphis is located at 2224 Central Avenue.

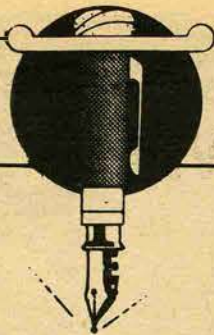

Now the job's almost done but we can't let our tormenters stand alone. They need a group, too.

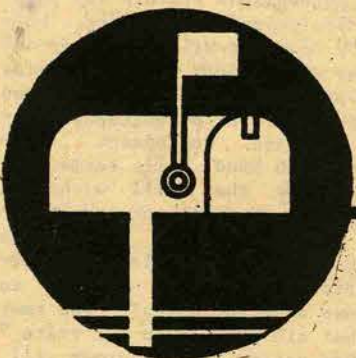
So how about this--the preachers, educators and disciplinarians? Sounds real nice, doesn't it?

But few know that in spite of its growth and progress since that time, the district board that governs the church has strongly considered closing the church once and for all.

The fate of the 7½-year-old church should be decided by the end of July. Both the church members and the district officers are doing everything possible to guarantee MCC's survival. But success will ultimately depend on increased attendance, membership, donation and support in the very near future.

The Gay Christians of greater Memphis CAN make a difference, and so can the entire community. Let's see if we do.

# AIDS: Test Your Knowledge

The following is reprinted from The Weekly News and modified slightly for the readers of Gaze.

In the interest of continuing our educational campaign to inform the Gay community about AIDS, the Health Task Force of the Gay and Lesbian Community Center of Colorado has developed this "AIDS Quiz #1." Answers can be found at the end of the quiz.

## 1. What is AIDS?

- an antacid
- The "Gay plague"
- a poorly understood disorder in which part of the body's immune system is damaged in varying degrees of severity.
- the wrath of God called down on queers by J. Falwell of Lynchburg, VA.

2. Some victims of AIDS are more vulnerable (because of a damaged immune system!) than others to a large and growing number of serious, often fatal diseases. The two most frequently reported of these cases are:

- hemorrhoids and zits
- Kaposi's Sarcoma (KS—a cancer) and Pnuemocystis carinii Pneumonia (PCP)
- an uncontrollable desire to be Empress of Memphis and similar disorders characterized by an uncontrollable desire to be editor of Gaze — both leading to permanent insanity.

## 3. Who is at risk for catching AIDS?

- Dykes on Bikes
- The Pope
- Mayor Hackett, the City Council and John Scatamacchia.
- Gay or bisexual men sexually active with multiple different partners, IV drug users who share needles; some Haitians; individuals receiving large quantities of blood or blood products by transfusion (hemophiliacs)

4. Persistent fevers or night sweats; weight loss not related to diet or exercise; unexplained profound fatigue which may be accompanied by light headedness or headaches; and recently appearing or slowly enlarging purplish or discolored nodules plaques, lumps, or other new growths on top of or beneath the skin or the mucous membranes (mouth, anus, under eyelids or nasal passages) are all:

- the result of voting Republican on a habitual basis
- some of the general symptoms often associated with AIDS — they can be symptoms for many other disorders, however
- the result of attending too many brunches where quiche was served.

5. Lymphadenopathy-- enlarged, hardened, or otherwise prominent lymph nodes (found in neck, armpits, groin) more than three months; a heavy persistent dry cough--not from the flu or smoking; a thick persistent, whitish coating on the tongue or in the throat which may be accompanied by a sore throat; easy bruisability or unexplained bleeding from any orifice, or new growth are all:

- some more of the general symptoms often associated with AIDS -- but can be symptoms for many other disorders
- the result of getting your picture on the front page of Gaze.
- the result of moving to the Skyline or Bellevue Towers.

6. If you exhibit any of the symptoms listed in questions 4 and 5 you should:

- move out of the Skyline or Bellevue Towers
- Register as a Republican and find Jesus
- give Phyllis Schafly a call and see what she would do
- don't be alarmed--but do consult your health care provider about it . If you don't have a health care provider familiar with AIDS and the other unique health issues of Gay men and Lesbians, call the Gay Switchboard at 726-GAYY.

7. If your health care provider does know you are Gay or Lesbian, you should:

- thank your lucky stars
- keep your mouth shut and hope for the best
- tell him or her right now and if they can't handle it, get a new one
- invite him or her over for brunch, serve quiche if you are a Gay man or Tofu if you are a Lesbian and hope s/he gets the message

8. At the present time, there are several routine, inexpensive laboratory tests that may either strengthen or help to rule out a diagnosis of immune deficiency. These include:

- the inhalation of large amounts of poppers with the immediate appearance perusing back issues of *Drummer* for at least two hours-- if blisters appear anywhere you're in trouble
- a white blood cell and lymphocyte count (skin testing with common recall antigens, " which continue to have uncertain diagnostic value--- both of which are often low in victims of immune deficiency

9. Although no conclusive evidence exists, so far as we know, to lay direct blame on any drug, activity, place of residence or other factors as the cause or causes for AIDS, virtually all leading observers currently believe that the risk of AIDS can be reduced (not eliminated) if you:

- reduce the number of different sexual partners and cease the use of shared needles for injection of drugs
- get a friend with a whip, go to the nearest Catholic Church during Holy Week and do the stations of the cross on your knees while being flogged
- cancel your travel plans to New York and head for Missoula, Montana, instead
- absolutely refuse to use stale poppers or rancid Crisco

## 10. AIDS IS:

- not funny
- killing us softly
- something that an educated responsible, cohesive and nurturing Gay and Lesbian community can conquer
- all of the above

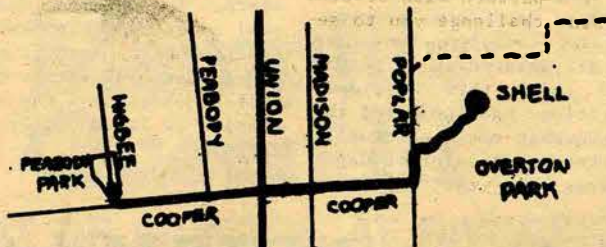

## Record Number Co-Sponsor Federal Gay Civil Rights Bill- More Expected

Washington, DC--Co-sponsorship of the House of Representatives' Gay and Lesbian civil rights bill, H.R. 427, has now reached a record level of 63, according to Gay Rights National Lobby (GRNL)--the primary lobbying group for the legislation. The chief sponsors of the bill are Rep. Ted Weiss (D-NY) and Rep. Henry Waxman (D-CA).

The record co-sponsorship came as no surprise, according to Steve Edean, the Executive Director of GRNL who also serves as Treasurer. GRNL, who also serves as Treasurer of the Human Rights Campaign Fund. "The re-election of every co-sponsor (who ran) from the last session, the election pledges coming from GRNL's Constituent Lobby of Candidates program, and the help the Campaign Fund gave in key races all pointed to is reaching a record level this session." Earlier projections had indicated the House co-sponsorship could eventually hit 80-85 members, but informed Capitol Hill sources note that the death

of Rep. Phil Burton, an influential Gay civil rights supporter who had pledged to help gain co-sponsors, could make it difficult to reach those numbers this year.

Although passage of the national civil rights bill--which would prohibit discrimination against Lesbians and Gay men in employment, housing, etc.--will take several sessions to pass, Edean asserted there are concrete, positive advantages to the continually expanding co-sponsorship. He noted that GRNL works particularly closely with co-sponsors on a variety of other Congressional issues such as AIDS funding, immigration reform and defeat of anti-Gay amendments. In addition, large Congressional co-sponsorship encourages prominent public leaders and organizations, such as former Vice-President Walter Mondale and the American Federation of State County and Municipal Employees (AFSCME) to speak out in favor of Gay Rights.

## Black Gays, NGTF Meet

Washington, D.C.- According to the *Washington Blade*, Ginny Apuzzo, Executive Director of the National Gay Task Force, called a meeting with members of the D.C. Coalition of Black Gays in response to their letter in the *Blade* denouncing the firing of Mel Boozer. According to the Black Gay leaders, Boozer was a highly visible Black Gay and his forced resignation appears to indicate that the major white-dominated Gay organizations are insensitive to the needs and concerns of the Black Gay Community. They also objected to Apuzzo's appointment of Jeff Levi to replace Boozer without allowing other Black Gays to apply for the post.

Apuzzo said that she had openly stated if she were chosen to replace Valeska, her intention was to hire her own staff. According to Apuzzo, "The previous administration has a dismal record in terms of programatically working with the Gay Rights National Lobby. It was my deeply felt belief that if nothing else, it was absolutely crucial that NGTF work well with GRNL." Apuzzo also claimed that Boozer could not get along with other Gay leaders but when pressed

for specific names, she replied, "My major concern was with GRNL. If (Boozer worked well programatically with GRNL, (he) would not have been terminated."

In a statement issued by the Black leaders, they indicated that their specific questions about Boozer's forced resignation had not been satisfactorily answered but Apuzzo had to certain objectives designed to discourage discrimination against Black Gays by other Gays. These include: encouraging Gay businesses and organizations to stop discriminatory practices, refusing to accept funding from groups or businesses that discriminate and encouraging businesses and groups to stop displaying symbols of oppression (eg. Confederate flags). It was further decided that additional discussions were necessary.

### Jane Rule Honored

New York(*The Washington Blade*)-- The Fund for Human Dignity, the tax-exempt arm of the National Gay Task Force honored Canadian Lesbian author Jane Rule at its annual awards dinner held May 16 in New York. Rule is the

author of a diverse body of work, including criticism (*Lesbian Images*) and short stories (*Theme For Diverse Instruments* and *Outlander*), but is perhaps best known for such novels as *Desert of the Heart*, *The Young in One Another's Arms*, and *Contract With The World*. Also honored were Sgt. Perry Watkins and Holly Near.

### NGTF Head Threatened

NGTF HEAD THREATENED.

Washington- (*The Washington Blade*)-- A 40 year-old Washington man, who earlier in April threatened National Gay Task Force official Jeff Levi with a handgun to show "how easy it is to murder a homosexual," was released from custody two hours after he was arrested when an assistant U.S. attorney refused to prosecute the case.

An official with the U.S. Attorney's office has since said the decision to decline to prosecute the case was based on "incomplete information" and that prosecutors now plan to issue a judicial summons for future prosecution of Paul Franklin Buck.

Gay activists, however, said they were outraged when they learned that Buck returned to the D.C. Gay community Center--the place where he first encountered Levi--the following day, in an attempt to locate Levi a second time.

Levi, meanwhile, was unharmed but shaken following what he said were a series of developments that raise further questions about whether the U.S. Attorney's office is doing all it could to prosecute cases in which Gays are victims.

### Freud's Daughter "His Only Son"

(*Out Front*) - Anna Freud, Sigmund Freud's daughter, was known to him as "my only son," according to the most recent *Emma*, West Germany's feminist monthly. Anna Freud died at 86, after a life spent as a psychoanalyst and founder of the children's therapy clinic in London.

She was co-publisher of her father's works and author of the first standard psychoanalytic work on treating children. In 1938 she fled Nazi persecution and settled in London with the woman who remained her constant companion and who was treated as a member of the family by Anna's father.

"The public remained unaware of what the Freud family didn't mind," *Emma* claims. "The fact that the daughter of the famous analyst was a Lesbian." *Emma's* article was prompted by an implication in one of *Der Spiegel's* columns that Anna Freud "sacrificed marriage because she loved her father so much and that, therefore, she involved herself totally in his work."

### 'Olympics' Injunction Permanent

San Francisco(*Gay Community News*)-- The U.S. Ninth Court of Appeals made permanent an injunction against the Gay Games use of the word 'Olympics,' according to the *Bay Area Reporter*.

U.S. District Judge Robert Peckham on April 12 turned down the appeal of attorney Mary Dunlap to lift the ban. Peckham upheld the U.S. Olympic committee's claim that the use of the word confused the public about the nature of the games.

Dunlap has said, however, that the case will be pursued in a trial scheduled to begin this summer.

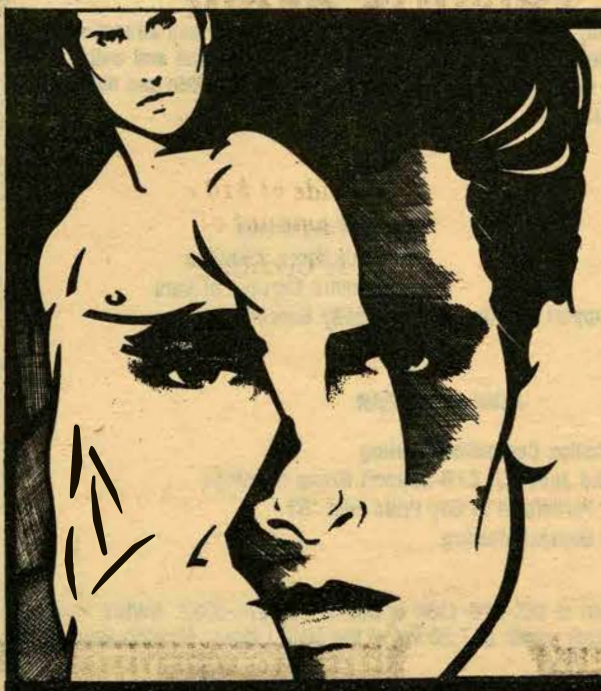

# Mother's of Nashville Opens

Already 1983 has brought a host of changes to the gathering places of the Nashville Gay community. In the wake of the enlargement and charming redecoration of The World's End restaurant; Juanita's stylish (and wise) move uptown on St. Patrick's Day; The Jungle's successful relocation to East Nashville---and the fiery (and mysterious) demise of The Mind Shaft---a new Gay bar unobtrusively opened its doors on Tuesday, April 12... and quickly proceeded (through word-of-mouth) to make its presence known.

Located at 2535 Franklin Road in Nashville, Mother's offers a striking-somewhat surrealistic "street scene" decor within its relatively small confines. An intriguing, perhaps forbidden urban alley-way is suggested by Mother's long and narrow dimensions, dim lighting and contrasting walls of either exposed brick or shimmering chrome. Plus, a changeable light projection of a metropolitan skyline or the starry heavens glitters on a brick wall...and an actual motorcycle, permanently parked against the brick wall, provides a novel place to sit. The bar (drink counter) is comfortable and L-shaped. Pinball and video games are found in the back corner. There is no dance floor. Setting an aural mood are continuous, professional sounding music tapes, featuring a mixture of dance music, new wave, and rock music (including such seldom heard gems as The Alan Parsons Project's "(You) Can't

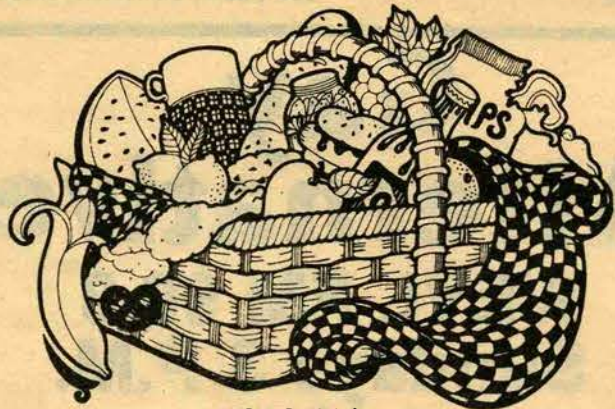
Take It With You," from the 1978 "Pyramid" album.

Housed in a former laundromat, Mother's is owned and operated by Mark Ryan, a 28-year-old Nashville businessman who previously has produced Gay-oriented illustrations and T-shirts, including material for TWIT magazine. The moustachioed Ryan labored for nine months to launch the Franklin Road nightspot. In addition to the obligatory paperwork and actual design and construction of the interior, Ryan's exhaustive preparations included a fact-finding tour of successful Gay bars in New Orleans, Houston, Austin and Los Angeles. Interestingly, a widespread comment among Mother's Nashville patrons is that the bar is "like a New York or California bar."

Music City's Gay community seemingly has embraced this newest club---and owner Mark Ryan couldn't be happier. He describes Mother's patrons as "the best." He observes that his weeks-old bar has "developed a real nice crowd. Everybody seems to talk here, more than in any other bar." In his opinion, Mother's is a place to meet people. Improvement plans for Mother's in the immediate future include the acquisition of the store next to the club and the addition of more seating and two pool tables. The full, official name of the bar is Mother's Construction Company-- and Mark Ryan reveals that his 55-year-old mom is a partner in the business! Mother's, at 2535 Franklin Road in Nashville, is open Monday through Friday from 5:00 PM to 3:00 AM, and on Saturday and Sunday from three to three.

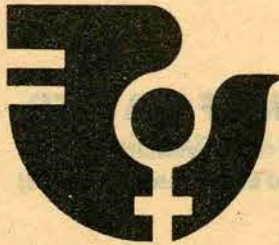

# Books

## ACLU Hails Release of Lobbying for Freedom

At a time when individual rights are under heavy attack in state legislatures across the country, the ACLU welcomes the publication of *Lobbying for Freedom in the 1980's*, a guide to action that will help civil libertarians fight back.

*Lobbying for Freedom*, edited by Kenneth P. Norwick and published by Perigee Books describes how legislatures function, explains how individuals can influence the legislative process, and examines five important issues of individual freedom confronting Americans today -- reproductive freedom, women's rights, Gay rights, drug law reform and censorship.

"This book is especially needed today," says Norwick, former legislative director of the New York Civil Liberties Union. "The dominant political climate throughout the United States today is clearly less sympathetic to the cause of individual freedom than it has been in many years. The battle to preserve these freedoms is taking place more and more in the various state legislatures, not just in Washington."

"Very few people understand how state legislatures work," adds Executive Director Ira Glasser. "Fewer still understand how ordinary citizens can influence their legislation."

Part I, written by Norwick, takes an in-depth look at the make-up and machinery of state legislatures, examining the forces that influence a legislator's vote and outlining the role and tactics of professional and citizen lobbyists.

In Part II, each of the five issues is examined by an expert who provides an overview of the legislative precedents for the issues, an assesment of its current legal status and the ramifications of bills now under scrutiny, and guidance on lobbying techniques to enact or defeat pending legislation.

### King's Blood Four/Moonscatter

One of the first difficulties with using Gay and Lesbian characters, or sex scenes, is that without great care, the effect is shocking.

It is rare to find a book that includes Gay and Lesbian characters simply, integrally and unobtrusively. The great care and skill necessary is amply shown in these two books.

*Moonscatter*, by Jo Clayton, is a sequel to *Moongather*, not quite fantasy, but superior fiction. A battle between a sorcerer supreme and the forces of life, with our heroine, healer, warrior, not quite a sorcerer, caught between.

*King's Blood Four*, by Sheri S. Tepper, is from a author new to me, perhaps her first. A unique look at extraordinary powers in the land of the True Game, and what comes next. Both well written and intellectually stimulating. Practically demands a sequel or elaboration. -JJ

## Reunion - Diaman's Latest

*Reunion*, the new book by San Francisco novelist N.A. Diaman, published by Persona Press at \$8.95, will be available June 1983 in bookstores and postpaid direct from the publisher.

*Reunion* is a love story involving three men in the Castro in the late 70's. The shifting moods and feelings which affect the course of their individual lives, are presented in sparse, precise, almost elegant prose. No other novel so well captures the spirit of contemporary Gay San Francisco. It is both realistic and hopeful, offering a unique glimpse of a special place and time.

N.A. Diaman is a native San Franciscan and an eight-year resident of the Castro District. His previous books are *Ed Dean is Queer*, *The Fourth Wall* and *Second Crossing*, all published by Persona Press.

In 1978 Diaman published *Ed Dean is Queer*, "which is part satire, part Utopian fantasy beginning with the Florida Gay rights struggle and ending with a part of California forming

an independent nation. This was followed by *The Fourth Wall* in 1980 which explores what it might be like being different in a conformist society dominated by television. In a sense the two books are closely related because they deal with two sides of the same issue which is the relationship between government and individual freedom," Diaman said.

*Reunion* deals with the changing nature of Gay male relationships. Though it is set in the Castro in the late 70's, it is essentially about the present. The joys and satisfactions as well as the problems and dilemmas of love.

"I think I'm both a realist and an optimist," Diaman said. "What I write about is the world as I see it. I care about the people I'm writing about. Despite all the difficulties ahead of us, I still believe in the possibility of a loving community."
